REPORT FROM THE GOALS AND OBJECTIVES COMMITTEE

A discussion of the report by Professor White will be carried in a special edition of the IUPUI Magazine which will be broadcast by WIAN (90.1 FM) on Tuesday, July 3 at 2:30 p.m.; Wednesday, July 4, at 4:30 p.m.; Sunday, July 8, at 1:30 p.m., and Monday, July 9, at 3:30 p.m.

This special edition of The Green Sheet follows with excerpts from the report and its recommendations.

The preliminary report on IUPUI goals and objectives has been completed by the GO Committee and is now being distributed throughout the University community.

Although the report presents a comprehensive basis for the development of IUPUI -- 121 specific recommendations are proposed by the GO Committee -- the report in toto does not require formal adoption.

Many of the recommendations can be adopted by the individual actions of department chairmen; others fall within the responsibility of deans and the chancellor; some would require action by the President of the University and the Board of Trustees; a few are within the jurisdiction of the Commission for Higher Education.

The preliminary GO Committee report is presented as a basis for further discussion and action by the governing bodies of IUPUI and Indiana University. Chancellor Hine has indicated that the GO Committee should continue the development of its recommendations.

The committee has been meeting for more than two years under Professor James P. White, law, as chairman. Other members are Dr. Bernerd Bogar, economics; Dean Alvin S. Bynum, University Division; Dr. Monte Juillerat, agricultural economics; Dean Lola Lohse, Normal College; Dr. Arthur L. Norins, medicine, and, as ex-officio members, Vice-Chancellors John C. Buhner and Jack M. Ryder.

## The preliminary GO Report includes these major recommendations:

- -- That IUPUI retain academic and administrative affiliations with Indiana's two Big Ten universities;
- -- That autonomy for the planning, development, and administration of academic programs be vested in the IUPUI faculty and administration;
- -- That IUPUI schools, divisions, and programs be based primarily within the University Quarter campus;
- -- That IUPUI students continue to be awarded either Indiana University or Purdue University degrees, with the diploma notation that the degrees are awarded at IUPUI;
- -- That IUPUI academic programs be developed within the urban context to serve the needs of Indiana's major urban region and to take fullest advantage of the opportunities presented by the IUPUI location;
- -- That substantial academic credit for professional and occupational experience be given to students enrolled in many of the IUPUI schools and divisions;
- -- That an open admissions program be inaugurated as IUPUI develops resources for preparatory and remedial courses, for counseling, and for expansion of the established and successful Guided Studies Program;
- -- That IUPUI continue to work through the Consortium for Urban Education (CUE) to develop co-operative programs with other Central Indiana colleges and universities to improve the transfer of students among these institutions, enhance sharing of resources and programs, and to avoid the costs of duplicating specialized courses and programs;
- -- That IUPUI develop graduate and professional programs consistent with existing strengths and consistent with the requirements of the Central Indiana region.

## Among the specific recommendations are these, which are listed by their number in the report:

- 1. The committee recommends that IUPUI continue to offer a wide variety of certificate programs, two-year programs, baccalaureate programs, graduate programs and professional programs in response to demonstrable occupational and research needs.
- 4. The committee recommends that a positive program of public relations to improve the image of the University be developed through the appropriate allocation of fiscal and human resources.
- 5. The committee recommends that a more aggressive program of recruitment and retention of minority students be established.
- 7. The committee recommends that IUPUI adopt and announce an undergraduate admission policy which will allow persons to enroll upon presentation of a high school diploma, its equivalent, or by reaching the age of 21 years.

- 13. The committee recommends that IUPUI endorse the principle of credit transferability in similar degree programs among the campuses of Indiana University and Purdue University.
- 14. The committee recommends that curricular requirements for degrees be established in programatic terms which may be met by students who move throughout the Purdue and Indiana university systems since traditional residency requirements have imposed unnecessary restraints.
- 19. The committee recommends that for the immediate future the University give priority to strengthening several existing programs rather than to the creation of new major programs.
- 22. The committee recommends that a committee of faculty and students be formed . . . and charged with developing a proposal to meet needs for personal (as distinguished from academic) counseling . . .
- 24. The committee recommends that the Graduate Studies Program at IUPUI have a dean and a co-ordinating council made up of faculty chosen by each academic area responsible for advanced studies.
- 25. The committee recommends that each graduate program at the master's level leading to Purdue or Indiana university degrees in Indianapolis be under the direction of an IUPUI faculty member for that program.
- 26. The committee recommends the continuance of existing doctoral programs . . . (and) the future developments of doctoral programs (which) conform to the established missions of IUPUI and meet a demonstrable need.
- 27. The committee recommends that individual professional graduate programs . . . be administered by the school concerned.
- 30. The committee recommends that university grants, such as summer fellowships, be designated for Indianapolis in a block sum to be allocated by an IUPUI committee.
- 34. The committee recommends that continuing education should be expanded and . . . have financial support from the general fund budget.
- 37. The committee recommends that every academic department should devise methods (for) students' evaluation of each course . . to improve the quality of course offerings.
- 66. The committee recommends that the Chancellor's Advisory Board be broadened to include representatives of the major professions and that appropriate reorganization take place in the 1973-74 school year.
- 68. The committee recommends that representatives of the faculty, staff and student body sit as non-voting members of the Chancellor's Advisory Board.
- 75. The committee recommends that the administration of IUPUI . . . establish a central library administration for all school libraries . . . other than those for Medicine, Nursing, Dentistry, and Law.
- 78. The committee recommends that . . . a special allocation of \$3,500,000 (be) spread across the next eight fiscal years over and above the regular operating budgets (for libraries) for book and book processing expenditures.



- 88. The committee recommends that a state judiciary building be constructed . . . near the law school.
- 89. The committee recommends that the University adhere to its policy of not permitting the construction of any free-standing commercial buildings on campus.
- 90. The committee recommends (for) the effective utilization of private development for the benefit of the university, the University shall prepare . . . specifications (for) specific types and locations of facilities . . . in accord with the long-range plan, the conditions under which proposals may be submitted and the time frame for specific proposals.
- 98. The committee recommends a 10-year priority schedule for facility development . . . based on program priorities and necessary supporting services.
- 100. The committee recommends that private enterprise be encouraged to provide contiguous housing for University faculty, staff, students and local residents.
- 106. The committee recommends that a student and employee health care service be established and that it not be the direct responsibility of the medical school.
- 110. The committee recommends that the Faculty Council and central administration . . . identify a permanent mechanism for faculty participation in a review of the budget making process.
- 112. The committee recommends the total conversion . . . to the method of fiscal planning known as program budgeting.
- 114. The committee recommends that an Indianapolis office of the I.U. Foundation be established and made operational no later than July 1, 1973.
- 121. The committee recommends the creation of an . . . advisory council with representation from campuses of the Indiana University System to assist the Director of University Relations in formulating legislative policy.
