WYOMING FUTURE FARMERS OF AMERICA

Constitution and By Laws 1931 JUL -27- M 8:48

CONSTITUTION.

Article 1. Name and Purposes of the Organization ATTIONAL EDUCATION

- Section A. The name of this organization shall be the Wyoming Association of "Future Farmers of America." Members of local chapters are hereinafter referred to as the "Future Farmers of America."
- Section B. The purposes for which this organization is formed are as follows:
 - To promote vocational education in agriculture in the public schools of the State of Wyoming.
 - 2. To create more interest in the intelligent choice of farming occupations.
 - 3. To create and nurture a love of country life.
 - 4. To encourage recreational and educational activities for students in vocational agriculture.
 - 5. To promote thrift.
 - 6. To encourage cooperative effort among students of vocational agriculture.
 - 7. To strengthen the confidence of the form boy in himself and his work.
 - 8. To promote scholarship among students of **recational** agriculture.
 - 9. To develop rural leadership.

Article II. Organization.

- Section A. The Wyoming Association of "Future Farmers of America" is a state organization of affiliated local chapters in schools having organized instruction in vocational agriculture under the provisions of the Smith-Hughes Act.
- Section B. Local "Future Farmer" chapters shall not be organized in schools where systematic instruction in vocational agriculture is not given under the provisions of the Smith-Hughes Act.

Section C. Members of local chapters shall meet, organize, and adopt the State constitution as their own, elect officers, set up a program of work, and then apply to the State Secretary for membership in the State organization. After this application has been approved by the State Secretary the members of the local chapter may been be known as "Future Farmers of America."

Article III. Membership.

- Section A. Membership in this organization shall be active, associate and honorary.
- Section B. Active membership. Any student of focational agriculture, who is regularly enrolled in a part-time, day-unit, or all-day class, is entitled to active membership in "Future Farmer" chapters upon receiving a majority vote of the members present at any chapter meeting. A member may retain his active membership for three years after completing his systematic instruction in vocational agriculture.
- Section C. Associate membership. Any former student of vocational agriculture may be elected to associate membership upon receiving a majority vote of the members present at any chapter meeting. Any former active member of a "Future Farmer" chapter may be elected to associate membership upon receiving a majority vote of the members present at any chapter meeting.
- Section D. Honorary membership. Instructors, school principlas, superintendents, business men, and others who are helping to promote vocational agriculture may be elected to honorary membership by the majority vote of the members or sent at any meeting.

Article IV. Membership Grades and Privileges.

Section A. There shall be four grades of membership based upon achievement. These grades are (1) Green hand, (2) Future Farmer, (3) State farmer, and (4) American farmer. (These terms to be used until approved or modified by the First National Congress.)

Section B. "Green Hand". Qualifications for Election:

- 1. Fourteen years of age.
- 2. Be regularly enrolled on a class in a part time, day unit, or all day agriculture class.
- 3. Possess facilities for and have a satisfactory program of supervised practice.

4. Receive a majority vote of the members present at a regular meeting of the local chapter of "Future Farmers of America."

Section C. "Future Farmer." Qualifications for Election:

- Satisfactory completion of at least one year in vocational agriculture, including a program of supervised practice.
- 2. Earn and deposit in a bank, or otherwise productively invest at least \$25.00.
 - Note. Any modification of (2) above must be approved by the State advisor.
- 3. Be regularly enrolled in vocational agriculture with an amplified supervised practice program.
- 4. Recite from memory the "Future Farmers" creed.
- 5. Be able to lead a group discussion for ten minutes.
- 6. Receive a majority vote of the members present at a regular local chapter meeting of "Future Farmers of America."

Section D. "State Farmer Degree." Qualifications for Election:

The qualifications for election are left to the various State organizations. The following qualifications are simply suggestive:

- 1. At least two years of systematic instruction in vocational agriculture with an outstanding supervised practice program in operation.
- 2. Pass some occupational test supplied by the State Staff.
- 3. Earn and deposit in a bank, or productively invest at least \$200.00. This may include the \$25.00 saved while advancing to the grade of "Future Farmer."
- 4. Be familiar with parliamentary procedure by having held office in the local chapter, or by having passed a satisfactory test on parliamentray procedure.
- 5. Be able to lead a group discussion for forty minutes.
- 6. Make the school judging team, debating team, or some other team representing the school.
- 7. Show marked attainment in scholarship in all school subjects (average 85 or above.)

- 8. Possess qualities of leadership as shown by having held responsible positions in connection with student and chapter activities.
- Each State shall be entitled to elect 10 qualified 9. individuals but where the State membership exceeds 500, not more than 2 per cent of the total State membership may be elected, fractions counted to the nearest whole number. Only copies of written records of achievement verified by the local advisor shall be submitted to the State Advisor by the local executive committee at least one month The advisor will prior to the State Convention. then review the records and submit his findings to the State Executive Committee. This Committee will nominate at the regular State Convention the candidates who have been found most worthy to receive the honor. Synopses of these records shall be read by a member of the executive committee when the students are nominated. The delegates shall then proceed to elect to the "Third Degree" the number of candidates to which the State is entitled.

Section E. American Farmer. Qualifications for election:

- 1. Hold the degree of "State Farmer."
- 2. Be capaged in a farming occupation or have definite plans for becoming a farmer.
- 3. Possess demonstrated ability to farm by having conducted an outstanding program of supervised practice throughout the period of vocational training.
- 4. Earn and deposit in a bank or otherwise productively invest at least \$500.00.
 - Note. In cases where the applicant had assisted in the support of dependents the amount so expended, in the judgment of the National Board of Trustees, may be considered as an investment.
- 5. Possess demonstrated ability to work with others by having participated in some agricultural cooperative enterprise or movement.
- 6. Be recommended by the National Board of Trustees and receive a majority vote of the delegates present at a National Congress of "Future Farmers of America."
- Section F. Associate and honorary members shall not vote nor shall they hold any office except that of advisor in the State and local organizations and that of executive Secretary-Treasurer and Advisor in the National Organization. Exceptions to this provision are permitted during the first two years of a chapter's existence.

- Section G. Only members who have been elected to the grade of "American Farmer" are eligible to hold national offices after 1929. One year after the (State) organization has been chartered all (State) organization has been chartered all (State) officers shall have attained the "State Farmer" degree. Officers in the local chapters must not rank lower than the grade of "Future Farmer."
- Section H. Associate and honorary members are eligible to election to any degree provided they have done outstanding work in promoting vocational agriculture and the organization of "Future Farmers of America."

Article V. Officers.

- Section A. 1. The officers of the (State) association of Future Farmers of America " shall consist of a president, vice president, secretary, treasurer, adviser and reporter. These officers shall be elected annually by a majority vote of the delegates present at a regular State Convention of "Future Farmers." The officers shall perform the usual duties of the respective officers. Each local chapter shall be entitled to two delegates in the State Convention, who shall represent the local chapter in balloting for officers and members who are nominated to be advanced to the grade of "State Farmer."
 - 2. Officers of the local chapter shall be identical with those for the State organization but shall be elected semi-annually at a r gular meeting of the local chapter.
- Section B. The executive dommittee of the State organization of "Future Farmers of America" shall consist of the State officers exofficio and three active members elected by the delegates in State Convention. This sommittee shall perform the usual duties of an excutive committee, review and approve receipts and disbursements, act as a nominating committee, and be responsible for the welfare of the organization.

Article VI. Meetings.

Section A. A meeting of the State Convention of "Future Farmers of America" will be held annually and at least 30 days prior to the meeting of the National Congress of "Future Farmers of America" at such time and place as may be determined upon by the Executive Committee of the Local Chapter.

Article VII. Dues.

Section A. Membership dues in a State organization shall be fixed by

the State Executive Committee subject to approval by a majority vote of the delegates present at the State Convention of "Future Farmers of America."

Section B. The dues of any local chapter shall be fixed by the majority vote of the membership of that chapter.

Article VIII. Ammendments.

- Section A. Amendments to the State Constitution shall be submitted in writing by the delegates from any chapter at any annual State Convention of "Future Farmers". Amendments may be adopted by a two-thirds vote of the delegates present.
- Section B. In order to secure flexibility by-laws may be adopted to fit the needs of the State organization or local chapter, providing they are not in conflict with the State constitution, which is also the constitution for each chapter.

Article IX. Insignia.

- Section A. The Insignia of the "Future Farmers of America" shall be made up of four symbols, namely (1) cross section of an ear of corn, representing common agricultural interests, since corn is native to America and grown in every State; (2) the owl, representing wisdom; (3) the plow, representing tillage of the soil, the basis of modern agriculture, and (4) the rising sun, representing progress.
- Section B. All active, associate, and honorary members shall be entitled to wear the insignia. All "Green Hands" are entitled to wear a bronze insignia, \$.15. All "Future Farmers" are entitled to wear a gold insignia, \$1.00. All members elected to the degree of "State Farmer" are entitled wo wear the gold insignia of a rectangular key base. All members elected to the degree of "American Farmer" are entitled to wear the gold insignia directly mounted on a key.

BY-LAWS

Articles 1. The Buties of State Officers.

- Section A. The President. Does the duty of the president to preside over all meetings of the State Convention of Future Farmers of America and over all meetings of the State executive committee. The president shall call one meeting of the State Convention each year at the time of the State Livestock Judging contest at Laramie. The president shall appoint all committees and may serve as an ex-officio member of these committees.
- Section B. Vice President. The vice president shall assume all the

duties of the president in the event that office becomes vacant by absence, resignation, or otherwise.

- Section C. The Secretary. The Secretary shall perform the duties common to such office, such as keeping record of the meetings of the State Convention and State executive committee, one copy of which is to be filed with the advisor, the other in the secretary's file, and such other duties as he is instructed to perform by the president or State Executive Committee.
- Section D. The Treasurer. The treasurer shall handle all moneys for the State Convention. He shall keep permanent records of all financial transactions and make an annual report on same to the State Convention. He shall pay all bills ordered by the state executive committee on checks countersigned by president.
- Section E. The Advisor. He is a member of State executive committee and an ex-officio member of all committees. It is his duty to advise the executive committee and appointed committees on matters of plicy, meetings, programs and finances. He shall issue to local chapters, their charters, when applied for in a regular channel, seeing that the same are signed by president, secretary, and himself. He shall review all applications for "State Farmer" degree and prepare brief or their qualifications and present same to state executive committee for confirming degree of "State Farmer" on accepted candidates.
- Section F. The Reporter. The duties of the reporter shall be to handle all beneficial publicity and advertising for the state organization. He shall also have records of membership and progress of association for advertising purposes and reporto executive committee work done during year.
- Section G. Method of Electing State Officers.

A nominating committee consisting of four representatives from four sections of state shall be appointed annually by president. The election of officers shall be by ballot and by majority vote of delegates present, each chapter being entitled to two votes. President shall not be elected from same region in two consecutive years.

Article 11. Methods of Issuing Charters to Local Chapters.

The secretary of local chapter "Future Farmers of America" shall submit with their application for charter the following information:

- 1. A copy of proposed constitution and by-laws.
- 2. Copy of chapter program of work.

- 3. List all members of chapter.
- 4. Name, grade and address of each officer of chapter.

Application for charter shall be signed by president, secretary and advisor and ______fee to cover cost of engraving.

Suspension of charter is at discretion of State Executive Committee.

- Article III. Procedure for Choosing Candidates for "StateFarmer" Degree.
 - 1. Chapter organizations may submit one candidate for each 50 members or fraction there of in chapter organization.
 - 2. Not more than 2 per cent of members shall be dected annually.
 - 3. The advisor shall formulate score cards for selecting candidate for "State Farmer" degree and send to chapter advisors 30 days previous to State Convention.
 - 4. Application for "State Farmer" degree shall be forwarded to advisor 15 days prior to State Convention meeting.
- Article IV. Reports to State Advisor. Each chapter shall submit the following information to advisor.
 - Yearly statement of names of chapter officers, delegates, Future Farmers and Green Hands.
 - 2. Report of amendments and changes in constitution and by-laws.
 - 3. Report to State Secretary showing name and number of boys in each chapter and other desired information.

Article V. <u>Dues.</u>

Dues in local chapter shall be 10ϕ per member, per year, in State organization 5ϕ per member per year, and in National organization 10ϕ per member per year, making a total of 25ϕ .

Article VI. Committees.

- 1. Nominating committee.
- 2. Auditing committee.

3. Program work.

Nominating committee shall select and place in nomination candidates for various state offices.

Auditing committee shall examine and report on treasurer report.

Program of work committee shall set up the annual objectives of organization and suggest ways and means of attaining them.

Committee members shall serve for one year.

Advisor is ex-officio member of all committees.

 One year after the (State) organization has been chartered all (State) officers shall have attained the "State Farmer" degree. Officers in the local chapters must not rank lower than the grade of "Future Farmer."

Section H. Associate and honorary members are eligible to election to any degree provided they have done outstanding work in promoting vocational agriculture and the organization of "Future Farmers of America".

Article V. Officers.

- Section A. 1. The officers of the (State) Association of "Future Farmers of America" shall consist of a president, vice president, secretary, treasurer, adviser and reporter. These officers shall be elected annually by a majority vote of the delegates present at a regular State Convention of "Future Farmers". The officers shall perform the usual duties of the respective officers. Each local chapter shall be entitled to two delegates in the State Convention, who shall represent the local chapter in balloting for officers and members who are nominated to be advanced to the grade of "State Farmer."
 - 2. Officers of the local chapter shall be identical with those for the State organization but shall be elected semi-annually at a regular meeting of the local chapter.
- Section B. The executive committee of the State organization of "Future Farmers of America" shall consist of the State officers exofficio and three active members elected by the delegates in State Convention. This committee shall perform the usual duties of an executive committee, review and approve receipts and disbursements, act as a nominating committee, and be responsible for the welfare of the organization.

Article VI. Meetings.

Section A. A meeting of the State Convention of "Future Farmers of America" will be held annually and at least 30 days prior to the meeting of the National Congress of "Future Farmers of America", at such time and place as may be determined upon by the Executive Committee of the Local Chapter.

Article VII. Dues.

- Section A. Membership dues in a State organization shall be fixed by the State Executive Committee subject to approval by a majority vote of the delegates present at the State Convention of "Future Farmers of America".
- Section B. The dues of any local chapter shall be fixed by a majority vote of the membership of that chapter.

Article VIII. Amendments.

Section A. Amendments to the State Constitution shall be submitted in writing by the delegates from any chapter at any annual State Convention of "Future Farmers". Amendments may be adopted by a two-thirds vote of the delegates present.

Section B. In order to secure flexibility by-laws may be adopted to fit the needs of the State organization or local chapter, providing they are not in conflict with the State constitution, which is also the constitution for each chapter.

Article IX. Insignia.

- Section A. The insignia of the "Future Farmers of America" shall be made up of four symbols, namely (1) cross section of an ear of corn, representing common agricultural interests, since corn is native to America and grown in every State; (2) the owl, representing wisdom; (3) the plow, representing tillage of the soil, the basis of modern agriculture, and (4) the rising sun, representing progress.
- Section B. All active, associate, and honorary members shall be entitled to wear the insignia. All "Green hands" are entitled to wear a bronze insignia, \$.15. All "Future farmers" are entitled to wear a gold insignia, \$1.00. All members elected to the degree of "State farmer" are entitled to wear the gold insignia on a rectangular key base. All members elected to the degree of "American farmer" are entitled to wear the gold insignia directly mounted on a key.

BY-LAWS

Article I. The Duties of State Officers.

- Section A. The President. It shall be the duty of the president to preside over all meetings of the State Convention of Future Farmers of America and over all meetings of the State executive committee. The president shall call one meeting of the State Convention each year at the time of the State Livestock Judging Contest at Laramie. The president shall appoint all committees and may serve as an ex-officio member of these committees.
- Section B. Vice President. The vice president shall assume all the duties of the president in the event that office becomes vacant by absence, resignation, or otherwise.
- Section C. The Secretary. The secretary shall perform the duties common to such office, such as keeping record of the meetings of the State Convention and state executive committee, one copy of which is to be filed with the adviser, the other in the secretary's file, and such other auties as he is instructed to perform by the president or State Executive Committee.
- Section D. The Treasurer. The treasurer shall handle all moneys for the State Convention. He shall keep permanent records of all financial transactions and make an annual report on same to the State Convention. He shall pay all bills ordered by state executive committee on checks countersigned by president.

- Section E. The Adviser. He is a member of state executive committee and an ex-officio member of all committees. It is his duty to advise the executive committee and appointed committees on matters of policy, meetings, programs, and finances. He shall issue to local chapters, their charters, when applied for in a regular channel, seeing that same are signed by president, secretary, and himself. He shall review all applications for "State farmer" degree and prepare brief of their qualifications and present same to state executive committee for confirming degree of "State farmer" on accepted candidates.
- Section F. The Reporter. The duties of the reporter shall be to handle all beneficial publicity and advertising for the state organization. He shall also have records of membership and progress of association for advertising purposes and report to executive committee work done during year.
- Section G. Method of Electing State Officers.

A nominating committee consisting of four representatives from four sections of state shall be appointed annually by president. The election of officers shall be by ballot and by majority vote of delegates present, each chapter being entitled to two votes. President shall not be elected from same region in two consecutive years.

Article II. Methods of Issuing Charters to Local Chapters.

The secretary of local chapter "Future Farmers of America" shall submit with their application for charter the following information:

- 1. A copy of proposed constitution and by-laws.
- 2. Copy of chapter program of work.
- 3. List of all members of chapter.
- 4. Name, grade and address of each officer of chapter.

Application for charter shall be signed by president, secretary and adviser and ______ fee to cover cost of engraving.

Suspension of charter is at discretion of State Executive Committee.

- Article III. Procedure for Choosing Candidates for "State Farmer" Degree.
 - Chapter organizations may submit one candidate for each 50 members or fraction thereof in chapter organization.
 - 2. Not more than 2 per cent of members shall be elected annually.
 - 3. The adviser shall formulate score cards for selecting candidate for "State Farmer" degree and send to chapter advisers 30 days previous to State Convention.
 - 4. Application for "State Farmer" degree shall be forwarded to adviser 15 days prior to State Convention meeting.
- Article IV. Reports to State Adviser. Each chapter shall submit following information to adviser.
 - 1. Yearly statement of names of chapter officers, delegates, Future Farmers and Green Hands.
 - 2. Report of amendments and changes in constitution and by-laws.
 - 3. Report to State Secretary showing name and number of boys in each chapter and other desired information.

Article V. Dues.

Dues in local chapter shall be 10¢ per member, per year, in State organization 5¢ per member per year, and in National organization 10¢ per member per year, making total taxation 25¢.

Article VI. Committees.

- 1. Nominating committee.
- 2. Auditing committee.
- 3. Program of work.

Nominating committee shall select and place in nomination candidates for various state offices.

Auditing committee shall examine and report on treasurer's report.

Program of work committee shall set up the annual objectives of organization and suggest ways and means of attaining them.

Committee members shall serve for one year.

Adviser is ex-officio member of all committees.

CREED OF A FUTURE FARMER

I believe in the future of farming, with a faith born not of words but of deeds -- achievements won by the present and past generations of farmers; in the promise of better days through better ways, even as the better things we now enjoy have come up to us from the struggles of former years.

I believe that rural America can and will hold true to the best traditions in our national life and that I can exert an influence in my home and community which will stand solid for my part in that inspiring task.
