MESSAGE FROM THE DEAN

Dear Alumni and Friends,

I wish that all of you could have the opportunity to serve as the dean of our law school, so that you could share my perspective on IU Law-Indianapolis. After spending six months in this role, I can't tell you how proud I am of our students, our faculty and our alumni.

Graduate Law Programs Grow and Prosper

Four years ago the law school launched its Master of Laws (LL.M.) program with ten students from seven countries. In fall term 2005-06, the school has 70 LL.M. students from 17 countries, enrolled in five tracks: American Law for Foreign Lawyers; International & Comparative Law; Health Law, Policy & Bioethics; International Human Rights Law; and Intellectual Property Law. The faculty advisors for these specialized tracks are Professors Jeff Grove, Frank Emmert, Larrie Wilkins, George Edwards and Kenny Crews, respectively.

This year the school inaugurated its Doctor of Juridical Science (S.J.D.) program; only about 15% of American law schools offer this terminal degree in law. Our four S.J.D. candidates hail from Italy, Canada, South Korea and Saudi Arabia and hold LL.M. degrees from the University of Utah, Osgoode Hall of York University, Washington and Lee University and Southern Methodist University. Professors Dan Cole, Kenny Crews, Nicholas Georgakopoulos and Jim Nehf serve as their dissertation advisors.

According to Professor Jeff Grove, the school's first Associate Dean for Graduate Studies, "in only four years our graduate programs have enjoyed remarkable growth in size, scope, diversity and quality. Our foreign students bring the world to IU Law-Indy, and as graduates they become ambassadors for our school in countries around the globe. We may be as well-known in China as we are in Peoria, Illinois. Our domestic LL.M. students also develop specialties that prepare them for the next stages of their professional lives."

A recent LL.M. graduate, Mr. Gao Zhen, who returned

to China and has just taken the National Bar Exam, describes his experience in the program this way, "My year as an international student at IU Law-Indianapolis changed my understanding about the U.S. I saw for myself that America's success comes from the honesty, openness and goodness of the American people. . . . I will keep going as you taught me, as an honest, responsible man."

Cathy Beck, a specialist in English as a Second Language (ESL) has designed a Legal English component for foreign LL.M. students, which is perhaps unique among American LL.M. programs. For non-native English speakers, Beck conducts a mandatory two to three week intensive Legal English course in August, prior to the beginning of law classes. In the summer program, students are introduced to the language skills needed for legal study in the United States. In addition to the intensive course, individual and group instruction is available to students throughout the academic year. Beck also works closely with the school's legal writing faculty who teach the course, *Legal Analysis, Research and Communication for LL.M. Students*. The goal is to give LL.M. students the greatest chance for success and distinction in their academic program.

The LL.M. program is staffed by the director, Claire Grove '99 (who also works with the S.J.D. program), the assistant director, Miki Hamstra and Legal English coordinator, Cathy Beck. The Program Center, with offices, classroom space and a student lounge is located in Canal Square at Vermont Street Plaza, directly across West Street from Inlow Hall.

Program on Law and State Government's Annual Symposium Focuses on Ethics

On September 29, 2005, the Program on Law and State Government (PLSG) hosted its fifth annual PLSG Fellowship Symposium. Entitled, "Integrity in Public Service: Living Up to the Public Trust?" the symposium was the brainchild of 2005 PLSG Fellows Michael Montagano and Shariq Siddiqui. Montagano presented his paper, "State Legislative Ethics: The Right, The Wrong and Indiana." Siddiqui's paper addressed "State Government Design and Incentives for Local Codes of Ethics." Several experts in the field of ethics and state government, in Indiana in particular, were on hand to discuss these issues along with the fellows.

This year's event assembled prestigious speakers from around the country, including nationally acclaimed investigative journalist Roberta Baskin, formerly of 20/20 and currently the executive director of The Center for Public Integrity in Washington, D.C. Baskin spoke on the topic, "Watching the Watchdogs." Other speakers included Steve Schultz, General Counsel for Indiana Governor Mitch Daniels, and Patricia Salkin, Associate Dean and Professor of Law, as well as director of the Government Law Center at Albany Law School.

Panel discussions included Ed Feigenbaum, owner of INGroup publishing firm and former staff director of the Council on Governmental Ethics Laws; Peggy Kerns, director of the Center for Ethics in Government at the National Conference of State Legislatures; Indiana State Senator J. Murray Clark, '82, former chairperson of the Senate Ethics Committee; Professor Ed Charbonneau of Indiana University Northwest; Carla Miller, representative of the Council on Governmental Ethics Law and an ethics officer of the City of Jacksonville, Florida; David Maidenbergh, former director of the Indiana State Ethics Commission; and Dean Salkin.

Clinical Associate Professor of Law, Cynthia Baker, director of the Program on Law and State Government, gave the opening and closing remarks for this event which attracted a wide variety of attorneys from around the state. Five hours of ethics CLE credit were available in connection with the symposium. The event was planned in cooperation with the editorial board of the *Indiana Law Review* in anticipation of their upcoming symposium issue focusing on ethics and law.

James P. White Lecture on Legal Education

The fifth annual James P. White Lecture on Legal Education took place on Tuesday, November 8 and featured The Right Honourable Lord Woolf of Barnes. Lord Woolf retired in September after serving for five years as the Lord Chief Justice of England and Wales. He spoke on the topic "The English Judiciary and the Rule of Law."

Next year's White Lecturer will be Hon. Ruth Bader Ginsburg of the U.S. Supreme Court, who will speak on March 8, 2007.

Lord Woolf was educated at Glasgow Academy, Fettes College Edinburgh, and graduated from the University College London. He was admitted to the Bar (Inner Temple) in 1954. In 1974 he was appointed first Treasury Counsel, a post he held for five years, until his appointment to the Queen's Bench Division of the High Court of Justice in 1979. He was appointed as Lord Justice of Appeal in 1986 and a Lord of Appeal in Ordinary in 1992. In 1996 he held the position Master of the Rolls and in 2000 was appointed Lord Chief Justice of England and Wales.

He has a long-standing interest in alternative dispute resolution and mediation. His report, "Access to Justice," was generally acknowledged to have been a catalyst for the development of ADR in England. Lord Woolf is the author of *Protecting the Public: The New Challenge*, based upon lectures he delivered at the Institute for Advanced Legal Studies in London (the Hamlyn lectures), and is co-editor of a major textbook, *Judicial Review of Administrative Action*.

He is Pro-Chancellor of London University and holds honorary LL.D. degrees from twelve universities, including London, Oxford and Cambridge. In September of this year, Lord Woolf was appointed as the United Kingdom representative to the "Group of Wise Persons," charged with drawing up a comprehensive strategy to secure the long-term effectiveness of the European Convention on Human Rights.

The White Lecture was established in 2000 to honor Professor Emeritus James P. White, who served for 25 years as the American Bar Association's Consultant on Legal Education. Members of the ABA Section of Legal Education and Admissions to the Bar and other friends contributed to the establishment of the annual lecture series in his honor. Past White Lecturers include Hon. Sandra Day O'Connor of the United States Supreme Court, Professor Graham J. Zellick of the University of London; Dennis W. Archer, 2004 President of the ABA, and John Edward Sexton, former president of New York University.

SECOND ANNUAL LEIBMAN FORUM ADDRESSES "ART AS AN ASSET CLASS"

Can an art portfolio enhance an investment portfolio? That topic was addressed by Professor Michael A. Moses, who, along with his colleague, Professor Jianping Mei, has created an independent fine art index to track the prices of works sold at auction. The Mei/Moses Fine Art Indices™ track the tenor of the art market from 1875 to today. Their research findings have been published in the *American Economic Review*, *Journal of Finance* and the *Journal of Investment Consulting*, as well as leading print and broadcast financial media.

In his lecture, Professor Moses used several examples to illustrate the value of art as an investment strategy. A faculty member at NYU's Stern School of Business for 30 years, Professor Moses' ongoing research involves pricing the priceless: predicting success and failure in the New York auction market for impressionist and modern paintings as well as the role that momentum investing and price leadership may have on the art auction market. An introduction to Professor Moses' lecture, and an overview of local art initiatives, was provided by Mindy Taylor Ross, Director of Public Art for the Arts Council of Indianapolis.

The Jordan H. and Joan R. Leibman Forum was established at IUPUI in 2004 in honor of retired IU Kelley School of Business Professor and law school alumnus, Jordan Leibman, '79. The forum examines issues surrounding the legal and business environment of the arts, and is a joint project of the IU Kelley School of Business Indianapolis, the IU School of Law-Indianapolis and the IU Herron School of Art and Design.

Summer Program in Croatia a "Jewel"

The ABA's site evaluation team gave glowing reviews to the law school's newest study abroad program, the Central and Eastern European Law Summer Program, based in Dubrovnik, Croatia. The report, submitted on behalf of the ABA site evaluation team by Lizbeth A. Moody, Dean Emeritus and Distinguished University Professor from Stetson University College of Law, stated the program is "an excellent example of what can be accomplished in a foreign summer program... [It] combines a rigorous academic regimen with a cultural exchange between Croatia and the United States... which is sure to provide benefits to the interests of both countries." According to the report the program's highlights include: "dedicated directors," "superb faculty," "evident enthusiasm of the students for the program," and "the support of two great universities" (i.e. Indiana University and the University of Zagreb). It concludes by characterizing the program as a "jewel easily recommended to future enrollees."

The program's director is Professor Frank Emmert, Executive Director of the Center for International and Comparative Law and John S. Grimes Professor of Law. Emmert is the founder and managing editor of the *European Journal of Law Reform* (since 1997). He served as Dean of Concordia International University Estonia School of Law and Executive Director of the Academy of European Law at the European University Institute.

Professor Jennifer Drobac, Associate Professor of Law and Dean's Fellow, was a visiting director of the program in 2005.

Patience and Persistence Pay Off

When Thea Kelly, '98, was in high school, she dreamed of being a fashion model in New York City. When she was an undergraduate student at Michigan State University, she dreamed of being a lawyer. What is remarkable about Thea is that she has made both of those dreams come true.

On July 27, 2005, when Thea heard her name announced as the grand prize winner of *More* magazine's 40+ Model Search competition, she was truly surprised.

"I think being an attorney helped me. Presenting our case is what we as lawyers do best. This time 'I' was my case. I was nervous until it was time to talk. Obviously, I must have presented my case well."

"I kept waiting for this 'Thea' person to walk out on stage when my name was called—I didn't realize it was me!" she says. "I'm honored to be part of a magazine that is challenging stereotypes about women and aging."

A senior attorney for DowAgroSciences, LLC, Thea was encouraged to enter the annual *More* magazine 40+ Model Search contest by her children and a guy friend. Selected as the grand prize winner from among a record-setting 19,142 entrants, Thea received a \$15,000 modeling contract with Wilhelmina Models in New York City. She also was featured in the November issue of *More* magazine. The annual model search was created six years ago to find models—and role models—who best illustrate the many possibilities available for women during the second half of their lives.

Thea Kelly grew up in Kalamazoo, Michigan and was the first person in her family to attend college. While in her teens, she aspired to be a high fashion model in New York—and even did some local modeling—but a protective father advised her not to move to New York City alone. So instead she attended Michigan State University. At first, she studied business law, hoping to go to law school, but financial considerations forced her to put that dream on hold, so she switched her major to finance and landed a position in accounting upon graduation.

Thea worked in accounting for 10 years before taking the plunge to go to law school. And what a plunge it was.

She cashed in her 401 (k), sold her house, and moved with her two children to Indianapolis.

“My desire to go to law school never disappeared. It was just put off as I married and had children. I have always been highly motivated and believed that getting an advanced education would afford me the opportunities I wanted to make a difference.”

Thea says that her legal training actually helped during the model search competition. “Part of the judging process included a panel interview. Both the president of Wilhelmina and the editor of *More* were on the panel. I think being an attorney helped me. Presenting our case is what we as lawyers do best. This time ‘I’ was my case. I was

nervous until it was time to talk. Obviously, I must have presented my case well.”

Thea will return to New York in January to review the options for her first modeling assignment. She says that the experience of participating in the competition was a good one.

“It has been an amazing experience...The competition has been, for me, affirming and validating. Many women have contacted me from around the country to tell me that my story has inspired them. Many have said that they have been inspired to go back to school, to take better care of themselves, to follow their dreams...I am glad that I took the challenge and went after mine.”

TRATHEN SERVES AS TECHNICAL ADVISOR FOR CBS DRAMA

Barbara Trathen, '77, chief deputy prosecutor in Hamilton County, Indiana, serves as a technical advisor for a new CBS drama series, “Close to Home,” which features a story that is set in Indianapolis. The show's creator, Jim Leonard, is originally from Fort Wayne and a graduate of Hanover College. He was already planning to use Indianapolis as the locale for the series when he met Trathen two years ago. The main character in “Close to Home,” is a female prosecuting attorney, whose story is loosely based on Trathen's longtime career as a Marion County deputy prosecutor. According to a recent article in the *Indianapolis Star*, the writers of “Close to Home,” frequently call Trathen with questions about Indiana law. The main character in the series, Annabeth Chase, played by Jennifer Finnigan, is both an attorney and a new mother. The series addresses the life balance issues that she faces combining work and family.

IN MEMORIAM



JON DAVID KRAHULIK, CLASS OF 1969

Jon David Krahulik, 60, a former Indiana Supreme Court Justice, died September 6, 2005, after a prolonged battle with cancer. He earned an A.B degree in History from Indiana University in 1965 and graduated *cum laude* from the law school in 1969.

He began his legal career at Baker and Daniels and then practiced at Bingham Summers Welsh & Spilman from 1971 to 1990, serving as the firm's managing partner for a number of years. He served as counsel to Governor Evan Bayh's transition team in 1988 and Bayh's Government Review Task force in 1989-1990.

Appointed the 101st Justice of the Indiana Supreme Court in 1990, Krahulik authored more than 140 majority opinions before he left the bench in 1993 to serve as President and COO of Chemed Corporation. Shortly thereafter, he returned to private practice with his two sons, David Krahulik '93 and Sam Krahulik '01 as a partner in the firm Yosha, Krahulik and Levy. In 2002, he was part of a legal team that won \$67

million for an injured truck driver, one of the largest injury awards in state history.

A member of the law school's Board of Visitors, Krahulik also served as an adjunct professor, teaching Indiana Constitutional Law. He was recently honored by the law school with a Distinguished Alumni Service Award and by the Indianapolis Inns of Court with a lifetime professionalism award. Governor Bayh awarded a Sagamore of the Wabash to Krahulik.

In addition to his many legal accomplishments, Krahulik was also an athlete and lover of the outdoors. He trained for and completed an Ironman Triathlon in Hawaii. He also was a member of the Jordan YMCA Board of Managers.

He is a strong financial contributor at leadership levels. The Burns family legacy at the law school continues with his son, Jonathan, who is currently a third-year student.

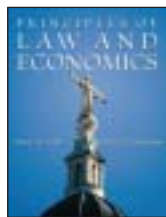
INTRAMURAL MOOT COURT COMPETITION NAMED AFTER HON. ROBERT H. STATON '55

Four of Judge Robert H. Staton's former clerks, John Ippenbach, '73, Tom Hall, '74, Linda Hammel, '75, and Kevin Knight, '90 have undertaken a fund raising effort resulting in naming the school's fall semester intramural moot court competition after Judge Staton, their former boss and mentor. With support from several former clerks, Judges from the Court of Appeals, and friends of Judge Staton, an endowed account has been established that will continue to support the intramural competition in perpetuity.

Judge Staton was a member of Indiana Court of Appeals from 1971 until his retirement in 2000. He has received the Distinguished Alumni Service Award from the law school's Alumni Association, as well as the Maynard K. Hine Medal from IUPUI. He was named a Sagamore of the Wabash by Gov. Otis Bowen. Staton is a former Chief Trial Prosecutor and Administrative Judge, as well as the first editor of *Res Gestae*, the first Chair of the Mandatory Continuing Legal Education Commission, Chair of the Indiana State Bar Association Consortium on Competency, and Chair of the Judicial Council on Legal Education. Judge Staton has chaired over 200 seminars and written over 2,000 majority opinions, as well as numerous articles. He is a World War II veteran (1943-46).

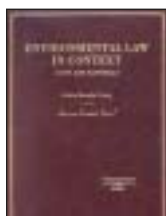

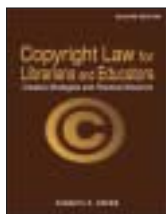

From September 17-26 Chancellor Bepko and his wife Jean Bepko hosted an IU Alumni Travelers group on a tour of village life in the Cotswolds in the UK.

On November 15 he was honored as the 2005 “Man of Achievement” at the Anti-Defamation League annual dinner. In addition to the tribute made at the dinner, Governor Mitch Daniels was the special guest speaker.

Dan Cole has published a new casebook, *NATURAL RESOURCES LAW* (co-authored with Jan Laitos, Sandi Zellmer, and Mary Woods) (West 2005). His article “Political Institutions, Judicial Review, and Private Property: A Comparative Institutional Analysis” has been accepted for publication by the *SUPREME COURT ECONOMIC REVIEW*. A book chapter on “Institutional and Technological Constraints on Environmental Instrument Choice: A Case Study of the U.S. Clean Air Act” (co-authored with Peter Z. Grossman) was published in 2005 in, Michael Hatch, ed., *ENVIRONMENTAL POLICYMAKING* (State Univ. of New York Press). Finally, he published a book review in 2005 on Richard R. Stroup’s *ECONOMICS: WHAT EVERYONE SHOULD KNOW ABOUT ECONOMICS AND THE ENVIRONMENT*, in 4 *THE YEARBOOK OF EUROPEAN ENVIRONMENTAL LAW* (Oxford University Press).

During 2005 Professor Cole made presentations at the following conferences, universities and law schools: Law and Society Annual Meeting in Las Vegas; the Southeastern Association of Law Schools Annual Meeting in Hilton Head, SC; Cambridge University; Michigan State University; and the ESADE Business School in Barcelona, Spain.

In July, **Jeffrey Cooper** presented a paper, “Superstrong *Stare Decisis* Rules in the Federal Courts of Appeals,” at the Southeastern Association of Law Schools annual meeting in Hilton Head, South Carolina. Also in July, he was appointed by the Indiana Supreme Court to a five-year term on the Indiana Supreme Court Committee on Rules of Practice and Procedure. He is one of nine members of the committee and the only academic (the other members are an appellate judge, a trial judge, and lawyers in government or private practice).

He replaced IU School of Law-Bloomington Dean Lauren Robel, who had completed her second five-year term (the maximum allowed).

Ruth Lilly Law Library Head of Reference, **Dragomir Cosanici** and Catalog Librarian, **Chris Long**, published "Recent Citation Practices of the Indiana Supreme Court and the Indiana Court of Appeals," in 24 *LEGAL REFERENCE SERVICES QUARTERLY* 103-119. The date of the paper publication was June 23, 2005. Funded by a grant from two special interest sections of the American Association of Law Libraries, their study provides an empirical, practical measure of the citation practices of the two highest courts in the state of Indiana for the years 1994-2003. It focuses on the types of legal materials most frequently cited as authority, examining the importance of both primary and secondary sources. It also discusses the importance of housing and maintaining appellate briefs from the two highest courts in the state of Indiana. This is the only citation study of this kind encompassing Indiana courts.

Dragomir Cosanici's book review of *JUSTICE IN A TIME OF WAR: THE TRUE STORY BEHIND THE INTERNATIONAL CRIMINAL TRIBUNAL FOR THE FORMER YUGOSLAVIA* by Pierre Hazan has been published in 33 *INTERNATIONAL JOURNAL OF LEGAL INFORMATION* 133 (Spring 2005).

Paul Cox has published the 2005 Supplement to *Employment Discrimination* (3d ed. Matthew Bender/Lexis).

Robin Kundis Craig has published a textbook, *ENVIRONMENTAL LAW IN CONTEXT* (West 2005). The accompanying 433-page teacher's manual, *TEACHER'S MANUAL TO ACCOMPANY ENVIRONMENTAL LAW IN CONTEXT* (West 2005), appeared in August 2005, while a comprehensive set of animated PowerPoint presentations for professors was published through TWEN in September 2005. The textbook has already had five adoptions. Professor Craig's article, "Protecting International Marine Biodiversity:

International Treaties and National Systems of Marine Protected Areas," appears at 20:2 *JOURNAL OF LAND USE AND ENVIRONMENTAL LAW* 333-369 (Spring 2005). Another installation of her quarterly column for the ABA's Administrative Law Section, "Supreme Court News," appeared in 30:4 *ADMINISTRATIVE & REGULATORY LAW NEWS* 18-20 (Summer 2005).

In September 2005, she was formally appointed to the 13-member Committee on the Mississippi River and the Clean Water Act of the Water Science and Technology Board of the National Research Council, the National Academies. The appointment will last until August 31, 2007, and the first meeting of the Committee (of five) took place October 18-19 in Minneapolis, Minnesota. Professor Craig was also re-appointed as Chair of the Marine Resources Committee of the Section on Environment, Energy, and Resources, ABA, and as Contributing Editor, of the "Supreme Court News," for the Administrative Law Section of the ABA. Both ABA re-appointments are in effect through July 2006.

On August 8, 2005, Professor Craig appeared before the House of Delegates at the ABA Annual Meeting in Chicago to defend three ocean policy resolutions that she had helped to draft for the ABA's Working Group on Ocean Policy. The resolutions passed on a voice vote, allowing the ABA to lobby Congress on ocean policy issues. On September 23, 2005, she was one of two panelists speaking on recent developments in the constitutional aspects of environmental law at the ABA Section on Environment, Energy, and Resource's Annual Fall Meeting in Nashville, Tennessee. She and her co-panelist, Jonathan Adler, presented a similar panel at the Capitol University School of Law in Ohio on November 14, 2005.

Kenneth Crews has authored a new and completely revised edition of his book, *COPYRIGHT LAW FOR LIBRARIANS AND EDUCATORS: CREATIVE STRATEGIES AND PRACTICAL SOLUTIONS* (ALA Editions 2005). One of his earlier articles, "Harmonization and the Goals of Copyright: Property Rights or Cultural Progress," 6 *IND. J. GLOBAL LEGAL STUD.* 117 (1998), has been selected this year for reprinting in *GLOBALISATION AND INTELLECTUAL PROPERTY* (forthcoming from Ashgate).

During the fall semester, **Jennifer Drobac** presented a paper, "Developing Capacity: Adolescent 'Consent' at the Workplace, at Law, and in the Sciences of the Mind," at three conferences. In June, she presented at the Law and Society Association Conference in Law Vegas, Nevada. In July, she presented at the International Society of Family Law Conference in Salt Lake City, Utah and in August she presented at the International Coalition Against Sexual Harassment Conference in Philadelphia. The law review article upon which the presentation is based will appear in the U.C. DAVIS JOURNAL OF JUVENILE LAW AND POLICY later this month.

Professor Drobac serves as a manuscript referee for Cornell University Press and also received the IU Trustees' Teaching Award and a Dean's Fellowship Award in 2005.



Frank Emmert, the Director of the Center for International and Comparative Law, supervised two of the school's summer study abroad programs in 2005. During the first half of the summer, he took 28 students to Strasbourg, France and taught them about EU law and the European Convention on Human Rights. European faculty colleagues taught additional courses on the legal systems of France, Germany and the United Kingdom. The students travelled to Geneva, Luxembourg, Paris, Brussels, and London, and visited institutions such as Parliament, the Commission of the European Union, the WTO, the UN, and the European Court of Human Rights.

Later in the summer, Professor Emmert and 32 American students went to Dubrovnik, Croatia to meet with local faculty colleagues and students. This new summer program included courses on legal, administrative, and court reform in Central and Eastern European

PROFESSOR EDWARDS PRESENTS PAPER AT UNITED NATIONS IN NEW YORK

On June 10th Professor George Edwards was invited to give a paper at the United Nations Headquarters in New York. His paper was titled "Assessing International Criminal Courts and Tribunals (ICCTs) and Non-Judicial Alternatives Towards Peace and Reconciliation in the Context of UN Secretary-General Kofi Annan's March 2005 Millennium Report – 'In Larger Freedom: Towards Development, Security and Human Rights For All.'" The event was part of the 2005 Summer Institute on Global Issues Facing the United Nations, a high-level conference with the theme of "Strengthening Respect for the Rule of Law." Conference attendees included diplomats, UN officials, government officials, and others from around the globe. The paper was presented as part of a panel entitled "The Role of International Criminal Courts and Tribunals." Prof. Edwards is pictured

countries (CEECs), accession of CEECs to the European Union, doing business in Central and Eastern Europe, real estate acquisition and ownership in CEECs, and human rights issues from CEECs before the European Court in Strasbourg. All faculty and students were accommodated in a hotel on the beach just outside of Dubrovnik, one of the oldest towns on the Adriatic. The group was visited by the President of IU, Dr. Adam Herbert, and by an ABA inspector, Professor Lizabeth Moody. In her report to the ABA, Professor Moody called the program a “jewel” among summer study abroad programs.

Professor Emmert also taught in a summer study abroad program organized by Stetson University College of Law in Tallinn (Estonia). On the domestic front, Professor Emmert finished several publication projects over the summer. Together with Professor Toni Fine, the director of graduate and international programs at the Benjamin N. Cardozo School of Law, he wrote a 55-page paper, “Introduction to the American Legal System” for a German-English, English-German legal dictionary forthcoming from Langenscheidt, the largest German publisher of reference works. He also acted as overall scientific advisor for this project.

As part of a research contract with the Centre for Economic Policy Research in London, which was financed by the EU, Professor Emmert co-authored a 78-page report analyzing “Statements Made in Favour of and Against the Adoption of Competition Law in Developing and Transition Economies.”

Professor Emmert finished the second edition of his collection, *EU Law - Documents*, which is currently in print. An updated edition of the *EU Law - Cases* should be ready in spring 2006 and both the English and the updated German version of the textbook on EU Law have been making good progress as well.

Finally, Professor Emmert found a new commercial publisher for the *EUROPEAN JOURNAL OF LAW REFORM*. Eleven International Publishing in the Netherlands will assume all rights and obligations related to the production and distribution of the EJLR, while Professor Emmert will continue as editor-in-chief. Therefore, at least for the foreseeable future, the journal will continue to call our law school “home.”

Nicholas L. Georgakopoulos is delighted to report that his recently circulated book *PRINCIPLES AND METHODS OF LAW AND ECONOMICS: BASIC TOOLS FOR NORMATIVE REASONING* from

The first was, "Reinstatement, Restitution, and Redemption: The Three R's of Preventing Home Loss to Foreclosure," and the second was "Licensing Statutes and the Holder in Due Course Doctrine: Problems and Possibilities for Broker and Assignee Liability for Predatory Lending." Professor Wilson serves as an Executive Officer, AALS Real Estate Transactions Section.

Latin American Law Summer Program's Second Year a Success

The Latin American Law Summer Program took place during the months of May and June in Argentina, Brazil and Uruguay. The program is part of an Educational Partnership with the Universidad Nacional de La Plata in La Plata, Argentina, funded by the Fulbright program.

Latin American Law Program Executive Director and Hall Render Professor Eleanor D. Kinney and Adjunct Professor Alejandro M. Garro, a faculty member at Columbia University School of Law, led the six-week program in which law students from our law school and four other U.S. law schools studied Latin American Legal Systems and the Law of the Economic Communities of the Americas. Program participants visited many Latin American legal institutions, including the Supreme Court of Argentina, trial courts in Buenos Aires and La Plata, the office of the federal public defender in La Plata, and the Bar Association of La Plata. Professor María Pabón López, Co-Director of the Latin American Law Program, joined the group for part of the program in La Plata.

One of the highlights of the summer (which is actually winter in South America) was a Fulbright-funded three-day international conference in which scholars from Latin America and the United States, including Professors Kinney and Lopez, discussed

economic integration and aspects of teaching civil and common law in the Americas. Also, the group visited the United States Embassy in Buenos Aires, the headquarters of MERCOSUR in Montevideo, Uruguay, as well as the University of Montevideo and the Fundación Getulio Vargas and the Latin American Parliament in Sao Paulo, Brazil. THE HONORABLE JOHN L. PRICE, '68

The Honorable John L. Price, '68, a Marion County judge for 24 years, died Saturday, October 29, 2005, after a valiant fight against cancer. Judge Price had a keen interest in education and the law. As a public school teacher, he taught in his hometown of Michigan City, in Greenfield, Indiana, and in Clark's Point, Alaska, a tiny and isolated Yup'ik Eskimo village on the Bering Sea. Judge Price obtained a B.S. degree and an M.A. degree in sociology from Ball State University. In 1968, he received the J.D. from the law school. He also was a graduate of the Indiana Judicial College. From 1968 until 1981, he practiced law in Indianapolis. He served as a Master Commissioner for six years and in 1981 was appointed to the bench on the Marion County Superior Court, a position he held for 24 years. After retiring, he continued to work in the Marion County Court system as a Senior Judge.

Judge Price taught courses at both IUPUI and the University of Indianapolis. He also served on the faculty of the Indiana Judicial Center, and the National Judicial College. After his retirement, he taught at Sheldon Jackson College in Sitka, Alaska, for two years. Awards for his teaching included the Indiana Bar Association's John Morton Finney Excellence in Education Award and the

Indiana Judges Association Award for Excellence in Public Information and Education. Judge Price participated in numerous civic organizations, including the Kiwanis (past president) and the Indianapolis Kiwanis Foundation (past president); the Indianapolis Lawyers Commission; the Indiana Legal Services Organization (board of directors); Second Presbyterian Church (deacon); Child Advocates of Indiana (board of directors); Sitka, Alaska Native Brotherhood Camp #1; and Indiana University School of Law Alumni Association (board of directors).

Judge Price was active in the Boy Scouts of America throughout his life. He established a Boy Scout troop in a remote Alaskan village, received the Silver Beaver, an award from the National Boy Scouts Association for service to youth, the District Award of Merit, and the Daniel Beard Award from the Pennsylvania Masonic Grand Lodge for service to Boy Scouts. A member of the Thirty-third Degree, Judge Price's Masonic memberships included Mystic Tie Lodge #398; Scottish Rite; and the Murat Shrine.

He is survived by his wife of 44 years, Julia Adelaide Hudson Price, a sister, a daughter and son-in-law, and three grandsons.
