The award recognizes a medical student for outstanding service and leadership in the care of older adults.

Created in 2006, the award honors the founding father of geriatrics at Indiana University, **Dr. Jeff Darnell**, for his 31 years of service and dedication to his patients and to IU Geriatrics.

## JAMA Authors Note Great Potential for GRACE Model of Care in Aging Theme Issue

Health-care reform is calling out for ways to improve health and lower costs. We have found a strategy to do that for a very vulnerable growing population in a way that shows cost savings over time and has the added benefit of providing services that these seniors desperately need but can't get elsewhere.

Authors Chad Boult, MD, MPH, MBA, and Darryl Wieland, PhD, MPH, highlighted the <u>GRACE model of care</u> in "Comprehensive Primary Care for Older Patients with Multiple Chronic Conditions: Nobody Rushes You Through" which appears in the Care of the Aging Patient section of *JAMA*. The November 3, 2010 issue focuses on aging.

Based on expert consensus about the available evidence, the paper identifies 4 proactive, continuous processes that can substantially improve the primary care of communitydwelling older patients who have multiple chronic conditions. Three models of chronic care include these processes--GRACE, PACE, and Guided Care.

The models appear to improve some aspects of the effectiveness and the efficiency of complex primary care and have the greatest potential to improve quality of care and quality of life for older patients with complex health care needs, while reducing or at least not increasing the costs of their health care.

The authors describe how the models work, steps for implementation, and how they differ in structure and operation.

"We were able to deliver care which was very popular with patients and their doctors, improved health outcomes, and saved money because it helped keep seniors from having to use the emergency department or be admitted to the hospital," adds Dr. Counsell, who directs dissemination of the GRACE Program. 


