Sixty dentists were registered for the meeting.

Howard University, among others, covered such

topics as orthodontics, prosthodontics, endodontics,

practice management, maxillofacial prosthetics, and

periodontics. The quality of dentistry done there

is remarkably good. Full spectrum dentistry is

done for those who can afford it.

Port of Spain, the capital of Trinidad, is a lovely city on the Northwest side of the isle. It has approximately 100,000 inhabitants living in a mountainous setting. Like Saudi Arabia, Trinidad has oil, only not as much. The natives are basically self-supporting and not looking to tourism for a livelihood. Homes are built into the mountainside, many of them at high cost by American standards. The native language is English since the island was once a British Commonwealth. It is now an independent country. The island is about the size of Indiana and its southwestern-most point is seven miles from Venezuela. The natives are of West Indian, African, European, and Caribbean extraction. They are very beautiful people to meet and admire. DR. It was certainly a delightful affair. There were "fetes" (parties) and "jump ups" (dancing to calypso music) everywhere from Saturday through Tuesday night. Our host tried to see to it that we attended as many as possible. It seems that we made all of them, twice for some.

We were fortunate in obtaining good slides of the Carnival parade of bands and other participants with their brightly colored costumes. Anyone interested in hearing tapes of a steel band or seeing slides of Carnival is welcome to do so.

Dr. Garner also delivered a paper on "Depressive Root Movement in the Macaque Speciosa Monkey" at the Annual Meeting of the International Association for Dental Research in Copenhagen, Denmark, in late March. Also present at the Copenhagen meeting was Ed Backes, Fourth Year dental student, who attended as a student representative.

At the request of the Newsletter, Ed supplied the following impressions of life in Denmark, based on his eight-day stay in that country:

Weather Cold, very windy; it rained 3 days, snowed 2 days, and was sunny 3 days. Someone said the snow was the first they have had in 3 winters.

Transportation Every Dane owns a bike - the No. 1 means of transportation...l in 5 Danes owns an automobile.
