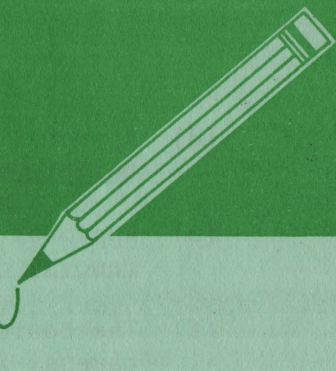

TRUSTEES' ACTIONS EFFECT IUPUI

Chancellor Maynard K. Hine reports that at the June meeting of the Indiana University Board of Trustees much very important business was transacted. The following items were approved for IUPUI:

General Matters

- (a) The Board of Trustees approved changing the name of the Graduate School of Social Service of the Indianapolis Campus to the School of Social Service. This request is made for the purpose of recognizing that the school has been teaching undergraduate courses for social service and is now expanding this activity.
- (b) The Board also approved two undergraduate degree programs for the School of Social Service, subject to the approval of the Commission for Higher Education. The two new degrees are Associate of Science in Human Services (two-year program) and a Bachelor of Social Work.
- (c) The Board of Trustees approved the establishment of the "Oral Health Research Institute" in Indianapolis under the general direction of Dr. George Stoekey, Dr. James McDonald, Dr. Simon Katz, Dr. Bradley Beiswanger and Dr. David Hennon.

This institute is patterned after the Preventive Dentistry Research Institute which Dr. Joseph C. Muhler organized many years ago. Since Dr. Muhler has moved to the Fort Wayne Campus, it was decided that he should continue Preventive Dentistry Research Institute there, so a new one was established here.

These institutes are non-degree granting units which emphasize research in dentistry. Institute staff members who do some teaching will have joint appointments with the Medical School or Dental School.

Construction & Contract Matters

- (a) The Board of Trustees approved some changes in the "M" Building at 902 North Meridian Street, to make it more secure. The renovation will cost \$7,000 and will include installation of five folding gates in the building, and improvement of door controls and alarms on 14 doors.
- (b) Approval was given for the remodeling of the Dental School Lecture Room 114 to accommodate 140 students, at a cost of \$5,600.
- (c) Renovation of the 2nd floor of Long Hospital to expand outpatient facilities was approved, at an estimated cost of \$255,296. The Board also approved upgrading the electrical wiring of Long Hospital at a cost of \$10,824. Funds are available from the Physicians Augmentation Grant.

- (d) Approval was given for building repairs to Krannert and Administration Buildings at 38th Street at a cost of \$19,380.
- (e) Approval was given to the low bidder, Zebrowski & Associates, for the removal of 14 houses on the IUPUI Campus.
- (f) The Board also approved many miscellaneous renovation projects for the campus, including remodeling of Cavanaugh Hall rooms 222 and 347 to create offices; sidewalk replacements on the campus, etc.
- (g) It was reported that approval has been received for proceeding with the Campus Services Building at a cost of \$708,000. This building will be placed adjacent to the Preventive Dentistry Research Institute Building and will house some administrative offices, Safety, Sponsored Programs, and other campus services.

BUSINESS OPERATIONS DECENTRALIZED

Indiana University Vice-President and Treasurer W. George Pinnell has announced a plan for substantial decentralization of business functions throughout the state-wide Indiana University administrative system which became effective July 1. Responsibilities for the operation of a number of functions have been transferred from the Office of I. U. Vice President and Treasurer to the chancellors of the Indianapolis and Bloomington campuses and to the Chancellor for Regional Campus Administration and their business managers.

IUPUI Chancellor Maynard K. Hine commented that the reorganization marks another major step forward in achieving local, functional authority.

"As we assume added operational responsibilities, we will have more opportunities to adapt our business services to the special needs of the Indianapolis divisions," he said. "This development parallels the increasing degree to which the University has moved to decentralize its academic programs. More and more, we will be expected to 'paddle our own canoe.' We will be held accountable for the effectiveness of our navigation, but managing how we move ahead will be locally determined to an increasing extent." Arthur D. Lautzenheiser, business manager of IUPUI, agreed that the steps being taken will increase efficiency.

The new operational policies for business matters were adopted after extensive studies and discussions under the leadership of I.U. President John W. Ryan. Members of the Board of Trustees participated in the discussions.

Among the functions transferred to IUPUI are more responsibility for physical plant operations, purchasing and stores, Union Building, student housing, personnel administration, the Controller's Office, the bookstores, and parking lot operations.

As the President Ryan's principal staff officer for business affairs, Pinnell will be responsible for proper administration of fiscal and business affairs throughout the University, as established by the trustees and by governmental agencies.

There will be central policies and guidelines to foster legal, effective, and relatively uniform practices and services throughout the University. In addition, the chancellors are to submit periodic reports to the Office of the President concerning the status and progress of business activities on their campuses.

Among the University-wide business operations retained in the Office of the President are central fiscal services and development, investments, capital planning and financing, general real estate operations (not details), insurance, internal auditing, and general policy formulation.

DENTAL DESTINIES

4 Nearly half the new dentists graduated from the School of Dentistry will begin their careers in Federal service, according to a report prepared by the school's assistant dean, Dr. Robert L. Bogan.

The Army has taken 24 of the Class of '72s 100 graduates. Thirteen have gone to the Navy, six to the Air Force, and three to the United States Public Health Service.

Nineteen of the Class of '72 graduates are continuing their educations and beginning post-graduate training programs in dental specialties.

Twenty of the graduates are planning on opening practices in Indiana. Only five are planning out-of-state practices and 10 members of the class are still undecided.

Dr. Bogan said past experience indicates that many of the 46 graduates who have entered Federal service will return to Indiana to open private practices when their tours of duty are completed.
