1. INVOCATION

The invocation was given by Brad Lewis, National Vice President.

2. BRIEFING ON BOARD PROCEDURES

Dr. Case explained the Board's function and purpose and stated that discussion was open to all. He explained the voting procedures and invited full participation of the National Officers, the adult members of the Board as well as the Consultants. Dr. Case then proceeded to introduce and seat the new Board members. (Rosco Vaughn, State Supervisor, New Mexico and Hugh McClimon, State Supervisor, South Carolina.)

3. OVERVIEW OF NATIONAL OFFICER ACTIVITIES

Donnell Brown led a review by National Officers of their activities since the January 1990 Board of Directors Meeting.

MOTION: It was moved by Les Thompson, seconded by Don Michael and carried to accept the report of the National Officers and to commend them for their outstanding work and leadership.

4. REPORT - NVATA CONSULTANTS TO THE BOARD

Mr. Doug Spike, President NVATA, updated the Board on their activities.

5. REPORT - AATEA CONSULTANTS TO THE BOARD

Dr. Barbara Malpiedi Kirby gave the report on the AATEA.

6. REVIEW AND ADJUSTMENTS OF AGENDA

One adjustment to the Board agenda was requested and made.

7. APPROVAL OF PREVIOUS MINUTES AND GOVERNING COMMITTEE MINUTES

Mr. Harris reviewed the Minutes of the January 1990 Board minutes; Governing Committee Minutes of January 25, 1990, February 27, 1990, April 25, 1990 and June 7, 1990 and a Special Meeting of the Board conducted by conference call on April 13, 1990.

MOTION: It was moved by Dan Schroer (Dr. Heiman)¹ , seconded by Scott Crouch (Dr. Coffey) and carried to approve the Governing Committee minutes of January 25, February 27, April 25 and June 7, 1990 and the Special Conference Call Meeting of the Board on April 13, 1990 and the January 1990 Board Minutes. (See Appendix A)

8. REPORT OF NATIONAL TREASURER

Mr. Wilson Carnes, National FFA Administrative Director, distributed and led a review of the National FFA Organization's consolidated statement for the 10-month period of September 1, 1989 through June 30, 1990. Mr. Carnes also introduced the budget for the Board's review. A copy of the most current membership roster was distributed.

MOTION: It was moved by William Henricksen (Mr. Munter), seconded by Brad Lewis (Mr. Thompson) and carried to accept the Treasurer's Report.

9. RECOMMENDATIONS OF 1990 CANDIDATES FOR REGIONAL STAR FARMERS, STAR AGRIBUSINESSMEN AND AMERICAN FFA DEGREE

WESTERN REGION

MOTION: It was moved by Brad Lewis (Dr. Heiman), seconded by Bill Henricksen (Mr. Thompson) and carried that Waylin Eldrid from Bellingham, Washington be selected as the Western Region Star Farmer and Brian P. Bingham from Glendale, Arizona be selected as the Western Region Star Agribusinessman for 1990. It was further moved by Brad Lewis (Mr. Heiman), seconded by Bill Henricksen (Mr. Thompson) and carried that 318 American FFA Degree candidates from the Western Region receive the degree with five candidates pending verification.

MOTION: It was moved by Dan Schroer (Dr. Heiman), seconded by Scott Crouch (Dr. Coffey) and carried to accept the committee report of the Western Region as presented by Mr. McClimon, Chair, Southern Region.

SOUTHERN REGION:

MOTION: It was moved by Dan Schroer (Mr. Muller), seconded by Brad Lewis (Dr. Coffey) and carried that Allen Lewis from Gates, Tennessee be selected as the Southern Region Star Farmer and Adrian I. Land from Branford, Florida be selected as the Southern Region Star Agribusinessman for 1990. It was further moved by Brad Lewis (Mr. Thompson), seconded by Dan Schroer (Mr. Muller) and carried that 132 American FFA Degree candidates from the Southern Region receive the degree with three candidates pending verification.

MOTION: It was moved by Dan Schroer (Dr. Heiman), seconded by Bill Henricksen (Mr. McClimon) and carried to accept the committee report of the Southern Region as presented by Mr. Michael, Chair, Eastern Region.

MOTION: It was moved by Bill Henricksen (Dr. Vaughn), seconded by Dan Schroer (Mr. Michael) and carried that Todd Lotter from Monroe, Indiana be selected as the Central Region Star Farmer and Chad O. Luthro from Moorland, Iowa be selected as the Central Region Star Agribusinessman for 1990. It was further moved by Scott Crouch (Mr. McClimon), seconded by Brad Lewis (Mr. Thompson) and carried that 427 American FFA Degree candidates from the Central Region receive the degree with two candidates pending verification.

MOTION: It was moved by Casey Isom (Dr. Coffey), seconded by Scott Crouch (Dr. Vaughn) and carried to accept the committee report of the Central Region as presented by Mr. Parker, member of Western Region Committee.

EASTERN REGION:

MOTION: It was moved by Casey Isom (Mr. Thompson), seconded by Dan Schroer (Mr. Muller) and carried that Morgan B. Ott, III from Fauquier, Virginia be selected as the Eastern Region Star Farmer and Jody E. Germann from Bowling Green, Ohio be selected as the Eastern Region Star Agribusinessman for 1990. It was further moved by Scott Crouch (Mr. McClimon), seconded by Bill Henricksen (Mr. Muller) and carried that 179 American FFA Degree candidates from the Eastern Region receive the degree with four candidates pending verification.

MOTION: It was moved by Casey Isom (Dr. Vaughn), seconded by Bill Henricksen (Dr. Coffey) and carried to accept the committee report of the Eastern Region as presented by Dr. Heiman, Chair, Central Region.

10. HONORARY AMERICAN FFA DEGREE (TEACHERS)

MOTION: It was moved by Dan Schroer (Mr. Munter), seconded by Brad Lewis (Mr. Thompson) and carried to accept 62 teachers of Agricultural Education (list attached) for the Honorary American FFA Degree for 1990. Michael Behner of Alaska is pending clarification of point totals prior to final approval. (See Appendix B)

11. 1990 HONORARY AMERICAN FFA DEGREE (OTHERS)

MOTION: It was moved by Casey Isom (Mr. Thompson), seconded by Bill Henricksen (Mr. McClimon) and carried to bestow upon 92 candidates (List attached) the Honorary American FFA Degree at the 1990 National FFA Convention. (See appendix C)

12. HONORARY AMERICAN FFA DEGREE (AUTOMATIC BY WAY OF POSITION)

MOTION: It was moved by Bill Henricksen (Mr. McClimon), seconded by Casey Isom (Mr. Muller) and carried that the retiring National FFA Board of Directors, Trustees and Consultants, parents of all national officers and star candidates, the retiring presidents of NVATA and FFA Alumni, and the chairman of the Foundation Sponsors Board receive the Honorary American FFA Degree at the 63rd National FFA Convention.

13. 1990 VIP CITATION

MOTION: It was moved by Dan Schroer (Dr. Heiman), seconded by Brad Lewis (Dr. Coffey) and carried that Dr. Max L. Amberson (MT); Mr. Gus R. Douglass (WV); Mr. Richard L. Hummel (OH); Mr. Ray Lett (VA); Dr. Floyd G. McCormick (AZ); Mr. Joe Raunika (OK) and Mr. Eldon E. Witt (IL), receive the VIP Citation at the 63rd National FFA Convention.

14. 1990 DISTINGUISHED SERVICE CITATION

MOTION: It was moved by Dan Schroer (Dr. Heiman), seconded by Brad Lewis (Dr. Coffey) and carried that Federal Crop Insurance, USDA (Washington, DC); Ford Motor Company (Dearborn, MI); and Rhone-Poulenc Ag Company, (Research Park, NC); receive the Distinguished Service Citation at the 63rd National FFA Convention.

MOTION: It was moved by Bill Henricksen (Mr. Michael), seconded by Brad Lewis (Mr. Muller) to accept the recommendations of the committee as stated by Mr. Doug Spike.

15. STANDING COMMITTEE REPORT - RESEARCH

Dr. Barbara Malpiedi Kirby, Chairman, presented the committee report. Discussion followed

MOTION: It was moved by Dan Schroer (Mr. Thompson), seconded by Bill Henricksen (Dr. Coffey) and carried that the FFA organization request Foundation funding of at least \$12,000 to develop an on-going system for determining and interpreting the needs of the FFA's market. The National FFA Organization Tactical Plan identifies a need for the systematic collection and processing of information (Goal 4). The Research committee recommends that a research and evaluation specialist be hired at the rate of \$200.00 per day for 60 days (or \$12,000 for 3 months)

MOTION: It was moved by Dan Schroer (Mr. Muller), seconded by Scott Crouch (Mr. Michael) and carried to accept the research committee report as stated by Dr. Kirby.

16. STANDING COMMITTEE REPORT - CONTESTS AND AWARDS

Mr. Les Thompson presented the committee report. Discussion followed.

MOTION: It was moved by Dan Schroer (Mr. McClimon), seconded by Bill Henricksen (Mr. Michael) and carried to support the Council's Financial Records Package (A plan to upgrade the Secondary Agriculture Education Instructional Program relative to Financial Records for Agriculture Education Students).

MOTION: It was moved by Casey Isom (Mr. Muller), seconded by Dan Schroer (Mr. Michael) and carried to support recommendation #3 of the Council, that the Council approve a writing team of key SAE leaders to develop written and visual materials that reflect contemporary philosophy and practices of SAE. Specific responsibilities should include the development of a comprehensive resource list of SAE materials and that a complete revision be performed on the National SOE Handbook. It is also recommended that this writing team develop new SAE materials in light of the competencies involved in agrimarketing, agriscience, international agriculture and enterprise/entrepreneurship development. It is further recommended that the writing team address the proposal, " A Plan to Upgrade the Secondary Agricultural Education Students."

MOTION: It was moved by Brad Lewis (Dr. Vaughn), seconded by Dan Schroer (Mr. Muller) and carried that the American FFA Degree and Agricultural Proficiency programs update be included as a part of the Financial Records Package recommended by the Supervised Agricultural Experience Taskforce of the Council, if the project is not funded, up to \$15,000 of the State Service Set-aside be made available in 1991 to begin a systematic review of the Agricultural Proficiency and American FFA Degree program.

MOTION: It was moved by Dan Schroer (Mr. Michael), seconded by Scott Crouch (Mr. McClimon) and carried that in addition to the four Regional Winners, who are automatically National Finalists, we designate six-at-large BOAC National Finalists Chapters with Four National Awards to be announced, unranked at the National BOAC Conference and the 1-2-3-4 place National Awards, announced at the convention.

MOTION: It was moved by Brad Lewis (Dr. Heiman), seconded by Dan Schroer (Dr. Coffey) and carried that we determine the eligibility for establishing a National Parliamentary Law contest as part of GOAL 3 in the National FFA Organization's Tactical Plan.

MOTION: It was moved by Dan Schroer (Dr. Coffey), seconded by Scott Crouch (Dr. Heiman) and carried (as amended) to appoint a taskforce consisting of representatives of Contests and Awards Standing Committee members, Contest Superintendents and Contest Advisory Council members to meet for the purpose of preparing a proposal to the January Board meeting regarding the feasibility of considering multiple team participation per state for national judging contests. Request funding from the FFA Foundation in the amount of approximately \$5,000.00.

The meeting was recessed for lunch.

Wednesday Afternoon, July 18, 1990

The meeting was reconvened at 1:30 p.m. with all members of the Board present.

16. CONTINUATION OF STANDING COMMITTEE REPORT - CONTESTS & AWARDS

MOTION: It was moved by Scott Crouch (Dr. Coffey), seconded by Dan Schroer (Dr. Heiman) and carried that the members of a state team may be from either the same or different schools as determined by the State Supervisor of Agricultural Education. It is recommended that all team members come from the same school.

MOTION: It was moved by Casey Isom (Dr. Vaughn), seconded by Brad Lewis (Dr. Coffey) and carried to accept the report of the Contest and Awards Committee as presented by Mr. Thompson.

17. FFA FOUNDATION BUDGET

Mr. Bob Seefeldt, Program Specialist - Contests & Awards, distributed copies of the 1990 National FFA Foundation Budget summary sheets to the Board members stating that between now and January there will be changes made and an updated budget will be provided to Board members at the January Board Meeting.

MOTION: It was moved by Brad Lewis (Mr. Thompson), seconded by Bill Henricksen (Mr. Michael) and carried to accept the report of the National FFA Foundation Budget as presented.

18. STANDING COMMITTEE REPORT - ORGANIZATIONAL DEVELOPMENT

Dr. Terry Heiman presented the Board with the report on Organizational Development.

MOTION: It was moved by Scott Crouch (Mr. McClimon) , seconded by Bill Henricksen (Dr. Vaughn) and carried that the National FFA Board of Directors request that the National FFA Foundation seek funding of either budget option #1 (\$123,772.72) or option #2 (\$75,488.37) to implement a national FFA membership card program.

MOTION: It was moved by Dan Schroer (Dr. Coffey), seconded by Scott Crouch (Mr. Munter) and carried to endorse the goals presented in the National Task Force Report and encourage FFA staff to proceed with developing future board proposals to accomplish the action steps.

MOTION: It was moved by Scott Crouch (Dr. Coffey), seconded by Bill Henricksen (Mr. Thompson) and carried that the National FFA Board of Directors request that the National FFA Foundation seek funding in the amount of \$230,022.72 to implement GOAL 1 of the task force report, "Develop partnerships with all major educational and agricultural organizations."

19. REPORT AND RECOMMENDATIONS FROM THE NATIONAL FFA FOUNDATION OFFICE

Mr. Bernie Staller, Executive Director of the National FFA Foundation gave the following report from the National Foundation: There are three new additions to National FFA Foundation Staff, Mr. Glenn Simms who is replacing Melanie Burgess who has moved to Europe, Mr. Jack Keller, formerly with the National FFA Center International Department, who is replacing Mr. Jeff Brazo and Mr. Dean Gagnon formerly state supervisor in Wisconsin who serves as Regional Director responsible for contacts with Foundation and Government Agencies. Mr. Staller then presented a financial comparison from July 13, 1989 until July 12, 1990. Mr. Staller spoke about the 1990 Development & Endowment program referencing several bequests.

These names shall be submitted to the Leadership Committee which will then select 1 person from the list of 5 to serve as the advisor to the National FFA Nominating Committee with the approval of the full Board of the Directors meeting in January.

Recommendations were made to have a group of three parliamentarians to the National FFA Convention each year and that the group act as the official parliamentary voice at the National Convention. MOTION: It was moved by Dan Schroer, seconded by Bill Henricksen to create subscription audio/magazine for FFA state and chapter officers in accordance with the attached proposal and budget, and to request funding in the amount of \$248,080 from the National FFA Foundation for two years of development and promotion. The motion was table until the next business day.

MOTION: It was moved by Dan Schroer to table this motion until the January Board Meeting. Motion failed for lack of a second.

The meeting was adjourned at 4:30 p.m.

The meeting was reconvened at 9:00 a.m. with all members of the Board present.

MOTION: It was moved by Scott Crouch (Mr. Munter), seconded by Dan Schroer (Dr. Vaughn) that the Board of Directors submit the following amendment (as amended) to article VI, Sec D, Item 2 to the National Convention delegates in November 1990. Add paragraph: "In those state where students are enrolled in a secondary level area vocational/technical center, the state governing body may determine the length of active membership required for those members to receive the state FFA Degree." Motion failed.

MOTION: It was moved by Bill Henricksen (Mr. Thompson), seconded by Brad Lewis (Dr. Heiman) and carried that the Board of Directors submit the attached "Fixed 400" amendment to Article XIII, Section B, to the National Convention delegates in November, 1990. To read: "At the national convention an official delegate assembly limited to 400 delegates will convene. This delegate body will consist of two official delegates from each state association to be designated as chair and vice chair of the state delegation, plus additional official delegates based on the individual state association's percentage of national FFA membership." The delegates shall be selected by the state FFA association. A quorum shall exist when both the following conditions are met at the time business is conducted: a majority of the official delegates registered at the national convention are present and at least twenty-six (26) state associations are represented by official delegates. Business items shall only be considered when approved by a delegate committee, or by a two-thirds vote of the delegate body. (See Appendix E)

MOTION: It was moved by Dan Schroer, seconded by Scott Crouch and carried to reconsider and amend motion #3 as follows: Add paragraph: "In those states where students are enrolled in a secondary level area vocational/technical centers, the state governing body may determine the length of active membership required for those members to receive the state FFA degree. MOTION: It was moved by Brad Lewis (Dr. Coffey), seconded by Bill Henricksen (Dr. Heiman) and carried that the Board request the National Advisor to write the Pennsylvania Association and advise them that the proposed amendment is in conflict with PL740, Sec. 7 (d), and therefore cannot be submitted to the National Convention Delegates.

MOTION: It was moved by Brad Lewis (Dr. Coffey), seconded by Casey Isom (Dr. Heiman) and carried to accept the report of the Constitution and Bylaws/Policy and to commend them for the fine work done.

26. REPORT AND RECOMMENDATIONS OF THE NATIONAL ALUMNI COUNCIL

Mr. Woody Cox, Executive Director, National FFA Alumni Association, introduced Alumni Council members. Mr. Josiah Phelps, National President, gave greetings and a report on the activities of the Alumni Association. Mr. Cox stated that there were no items to be presented for official business.

MOTION: It was moved by Bill Henricksen (Dr. Vaughn), seconded by Dan Schroer (Mr. Muller) to accept the report of the National Alumni Council as presented by Mr. Robert Cox and Mr. Josiah Phelps.

Mr. Harris introduced the visitors from Kansas City, Mr. Mike Brenan, Chairman of the Board, Greater Kansas City Hotel/Motel Association, Denise DeJulio, Convention Sales Manager, Convention & Visitors Bureau of Kansas City, Jim Hutchinson, President, Convention & Visitors Bureau of Kansas City, Paul Beecher, Director of Special Facilities, Kansas City Convention Center, and Bill Harsh, Member of the Executive Committee and Board of Directors of the American Royal. Mr. Jim Leathers was unable to be present.

The meeting was recessed for lunch until 1:00 p.m.

Thursday afternoon, July 19, 1990

The meeting was reconvened by the National President at 1:15 p.m. with all members of the Board present.

A special presentation was made to the Board by the delegation from Kansas City. Mr. Jim Hutchinson gave greetings and remarks. Mr. Hutchinson then turned the presentation over to Denise DeJulio, who had several suggestions for changes that could be made in the housing forms for the National Convention. The podium was then turned over to Mr. Mike Brenan from the Greater Kansas City Hotel/Motel Association. Mr. Brenan spoke in reference to the escalating hotel/motel rooming prices and the efforts to do whatever is necessary to keep the prices of rooms in Kansas City down. Mr. Bill Harsh, a member of the executive committee and Board of Directors of the American Royal then spoke on the American Royal Program. MOTION: It was moved by Brad Lewis (Dr. Vaughn), seconded by Dan Schroer (Dr. Coffey) and carried that the Board recommend to the delegates to the National FFA Convention that dues for 1990-91 be maintained at \$3.50.

MOTION: It was moved by Dan Schroer (Dr. Coffey), seconded by Bill Henricksen (Dr. Heiman) and carried to accept the report of the Finance Committee as presented by Mr. Michael.

MOTION: It was moved by Dan Schroer, seconded by Casey Isom and carried to move the motion pertaining to parliamentarians for the National Convention onto the table.

MOTION: It was moved by Scott Crouch, seconded by Bill Henricksen and carried to withdraw the original motion from the table to be restated and resubmitted.

MOTION: It was moved by Scott Crouch (Mr. Michael), seconded by Brad Lewis (Dr. Heiman) and carried that each year the Board of National FFA Officers select one official parliamentarian along with two consultants for the business sessions of the National FFA Convention. These individuals are subject to the approval of the National FFA Executive Secretary.

29. REPORT AND RECOMMENDATIONS OF THE CONSULTANTS





NATIONAL FFA ORGANIZATION
PROPOSED CONSTITUTIONAL AMENDMENT

SUBJECT: National FFA Convention Delegates

MOTION: To amend Article XII Section B of the National FFA Constitution to read:
"At the national convention an official delegate assembly limited to 400 delegates will convene. This delegate body will consist of two official delegates from each state association to be designated as chair and vice chair of the state delegation, plus additional official delegates based on the individual state association's percentage of national FFA membership." The delegates shall be selected by the state FFA association. A quorum shall exist when both the following conditions are met at the time business is conducted; a majority of the official delegates registered at the national convention are present and at least twenty-six (26) state associations are represented by official delegates. Business items shall only be considered when approved by a delegate committee, or by a two-thirds vote of the delegate body.
