In one of his first public statements as President of Indiana University, Dr. John W. Ryan described IUPUI and the I.U. regional campuses as ". . . the growing edge of the University. And we must do all possible to continue their support.

"At Indianapolis, we have just made a significant stride forward. IUPUI is already a major university, and it will benefit from the full force of the University System to maintain the momentum of growth and development. ICFAR -bringing the engineering, health and social sciences resources of Purdue and Indiana Universities to focus on the community needs and interests of Indianapolis as well as the state -- is one remarkable illustration of the value of this collaboration, and one which will be closely watched throughout the educational world.

"We must maintain and enhance the excellence for which our university is already noted. Most of the history of Indiana University has been focused at Bloomington. . . This resource to the State must be maintained in its excellence, yet modified continually to meet the needs of the times.

"High on our agenda will be a hard look at the extensive reorganization of the University undertaken two years ago. Much progress has been made, but our present position must be evaluated in view of changing needs of the state and institution."

## LEGISLATIVE REPORTS VIII

SENATE -- New Bills

SB 382 (Gutman, Parks) -- Permits a state gross income tax deducation of up to \$500 for charitable contributions to elementary and secondary educational institutions and institutions of higher education that are located in Indiana. Assigned to Education Committee.

SB 387 (Helmke) -- Regulates the sale, use, and disposal of hypodermic needles and syringes and creates fines and penalties for violations of the regulations. Assigned to Organization of Courts Committee.

SB 402 (Kleinkort) -- Amends an act on public purchases to reduce to \$2,500 the amount of purchase which can be made by any state officer, board, commissioner, department, commission, or purchasing agent without letting the purchase out for bids. Assigned to Public Policy Committee.

SB 445 (Bainbridge) -- Amends an act providing for establishment of a regional hospital-affiliated internship program by eliminating the statewide medical education plan and permitting any county to establish a general medicine internship and residency program in whatever hospital or medical school it deems appropriate; creates and establishes powers of seven-member medical education board to administer the program; appropriates \$5.2 million. Assigned to County and Township Business Committee.

SB 455 (Benjamin, Orr) -- Provides grants for educational television stations; appropriates \$692,760 for 1971-73 biennium. Assigned to Finance Committee.

HOUSE -- New Bills

HB 1444 (Cloud, A. Hayes) -- Makes students enrolled in Indiana Vocational Technical College eligible to receive state scholarships. Assigned to Education Committee.

HB 1473 (Burrous, Lesniak) -- Allows \$8 daily for food and \$16 daily for lodging for state employees travelling within Indiana, and \$8 for food and \$25 lodging for travel outside Indiana. Assigned to Ways and Means Committee.

HB 1488 (O'Connor) --Requires I.U. School of Medicine graduates to practice within Indiana six months for every semester of in-state tuition support; authorizes revocation of license for failure to comply. Assigned to Public Policy Committee.

HB 1552 (McIntyre) -- States that person who moves into a county for temporary employment, education, or other purposes shall not have acquired residence enabling him to vote in that county. Assigned to Elections Committee.

HB 1593 (Harden, Mullendore) -- Authorizes trustees of Indiana University to construct facility for purpose of treating children with speech and hearing disorders; appropriates \$650,000. Assigned to Ways and Means Committee.

A transportation system that would link IUPUI campuses, using shuttle buses, is under active consideration. At the direction of Chancellor Maynard K. Hine, a feasibility study is under way. "This is a complex and important problem," Chancellor Hine said. "We are concerned with meeting potential needs, particularly among students, for movement between the various locations where classes will be scheduled."

A committee, including representatives of the IUPUI offices of Student Services and Business Manager, has been evaluating several options, taking into account such factors as operational considerations, costs, and potential usage. A survey of more than 400 students at the Downtown and 38th Street Campuses indicated interest in having such a system available. These preliminary studies have resulted in a proposal that the service be established for a two-month trial period.
