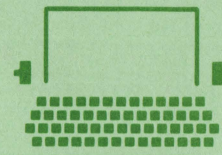

## JUSTICE IN BRITAIN AND U.S.

A four-hour "Dialogue on British and American Criminal Justice," covering issues such as the role of the police, plea bargaining, jury selection, public defender system and sentencing, will be held this week at the I.U. School of Law-Indianapolis. The program will start at 1:30 p.m. Wednesday in the Moot Court Room at the law school.

Five presentations on the British criminal justice system will be made by visitors from England and Scotland, including a judge on the English High Court, a former solicitor-general from Scotland, and a law professor from the University of Birmingham. After each presentation, a faculty member from the I.U. School of Law, Indianapolis or Bloomington, will make a response, followed by a question-and-answer session. Judge Robert H. Staton of the Indiana Court of Appeals will moderate the seminar.

Presentations will include an introduction to the criminal process in England, the adversary process from arrest to trial, special issues in the adversary process (criminal discovery, plea bargaining, jury selection, preparation of indictment, speedy trial considerations), the legal profession (system of barristers and solicitors, public defender system, selection and training of judges, professional discipline) and sentencing and corrections.

Visiting presenters include Lord McCluskey of Churchill, former solicitor general for Scotland; Sir Stephen Brown, a member of the English High Court; Clive Pratley, Lord Chancellor's Department; Harry Hatchard, solicitor and clerk to the Walsall magistrates, and David Kidner, solicitor and clerk to the Coventry magistrates.

Also, Ian Manson, chief prosecuting solicitor for the West Midlands County; Ian Scott, Barber professor of law and director of the Institute of Judicial Administration at the University of Birmingham, and George Jonas, solicitor who practices in Birmingham.

Indiana participants will be Professor Kenneth M. Stroud, I.U. School of Law-Indianapolis; Professor F. Thomas Schornhorst, I.U. School of Law-Bloomington; Sheldon A. Breskow, executive secretary of the Indiana Disciplinary Commission, and Cleon H. Foust, executive director of the Indiana Lawyers Commission.

The program, free and open to the public, is being sponsored by the I.U. School of Law-Indianapolis, in cooperation with the Wendell L. Willkie Society of International Law and the Indianapolis Bar Association. Coordinator of the seminar is W. Andrew Kerr, professor of law (Indianapolis) and executive director of the Indiana Judicial Center.

DEPT. OF HONORS & ACCOLADES

The School of Business MBA-Career Integrated Program Teaching Excellence Award for 1978-79 went to Lawrence S. Davidson, assistant professor of business economics and public policy. Other business faculty recognized as outstanding teachers were: R. Thomas Lenz, assistant professor of business administration; Ronald F. Rost, assistant professor of business economics and public policy, and Thomas P. Hustad and P. Ronald Stephenson, associate professors of marketing.

Dr. Robert E. Shupe, assistant professor of radiation oncology, is in Tokyo for the Sixth International Congress of Radiation Research.

J.M. Kapoor, associate professor of social work, was in Philadelphia last week to present his paper at the 106th Annual Forum of the National Conference on Social Welfare. His paper, "Some Measures of Evaluation and Effectiveness in Social Work Practice," focuses on certain techniques to delineate practice effectiveness at micro and macro level analyses.

Dr. Norman H. Bell, professor of medicine and pharmacology and associate chief of staff for research and development at the Veterans Administration Medical Center, has been appointed a Medical Investigator by the V.A. The research award, made to only a few persons who have already made significant contributions in their field, provides salary and research support for six years. Dr. Bell's research interest deals with calcium and mineral metabolism. The award permits him to continue to characterize diseases related to abnormalities in the metabolism of vitamin D.

Dr. Henry Wellman, director of the Division of Nuclear Medicine, has been named the recipient of a Senior United States Scientist Award for 1979-80 by the Alexander von Humboldt Foundation of West Germany. Dr. Wellman will spend a year at Heidelberg, Germany, where he will work with Prof. Kurt Scheer, director of the German Cancer Research Center. The foundation's program established in 1953, was conceived to honor American scientists from all fields who have gained an international reputation. Normally 30 to 40 American scientists are selected each year, only one or two of them from medical fields.

W. Andrew Kerr, professor of law and executive director of the Indiana Judicial Center, was awarded the first annual "Distinguished Service Award" by the Indiana Council of Juvenile Court Judges at the council's fifth annual meeting this month. The award recognized Kerr's five years' service in helping the council develop its program of activities in juvenile justice.

Dr. Angela McBride, associate professor of nursing, has been invited to present a paper called "Sex Differences in Casual Attribution of Parenting Performance" at the 1979 American Psychological Association convention in New York City this fall.

Joe Farah of the Office of International Programs will be editor of the ICIP Bulletin during the 1979-80 academic year. The Bulletin is the official publication of the Indiana Consortium for International Programs.

Leonard Schneiderman, dean of the School of Social Work, has been appointed chairman of the Long-Range Planning Committee of the United Way of Greater Indianapolis and has been elected to the organization's 40-member board of directors.



John D. Williams, director of communications services, has been elected to the Executive Committee of the Indianapolis Postal Customers Council. He also is the new president of the Indianapolis Chapter of the In-Plant Printing Management Association.

Forrest T. Meier, professor of physics, was in Minnesota this month as part of a three-member team to evaluate the physics graduate program at the University of Minnesota, Duluth. This external review is mandated by the state, a procedure being discussed as a possible requirement in Indiana.

David A. Funk, professor of law, contributed to a symposium on "Religion and Law" just published by the Capital University Law Review. His contribution is called "Religion, Ethical Natural Consequentialism and the Science of Justice."

Faculty presenters at the Society for Applied Anthropology, held this spring in Philadelphia, were W. Kenneth Barger and Barbara Jackson from the Department of Anthropology and Shirley Karlson from the School of Nursing. They presented an interdisciplinary symposium, "Mexican-American Sex Roles and Migrant Health Services in Indiana," which included participants from the Indiana Family Health Council, Inc. and the Associated Migrant Opportunity Services, Inc.

Dr. B.D. Nageswara Rao, associate professor of physics, conducted a seminar in the Department of Pharmacology at the Mayo Medical School in Rochester, Minnesota, this spring.

Peter Sehlinger, associate professor of history and associate dean of Overseas Study, has had an article published by the University of Chile Press in the collection "Cientocinquenta anos de politica exterior chilena." This spring, Sehlinger has been in Omaha to serve as commentator at a meeting of the Missouri Valley Historical Society (session on "Latin America and the Third World") and in Pittsburgh to give a paper called "Overseas Study Opportunities in Peru and Brazil" for the Latin American Studies Association.
