LIBRARIANS NOTE

The career status of professional librarians within the Indiana University library system has been considered by the I.U. Trustees, who adopted several policies at their February meeting. These include establishment of a progression of ranks parallel to the faculty ranks, a University-wide system for recommending promotions to higher ranks, adoption of the same policies and procedures for sabbatical leaves as apply to the faculty, and application of rules governing retirment for reasons of disability in the same manner as such rules apply to teaching faculty. Items still under consideration include application of rules governing TIAA/CREF status, policies regarding the question of tenure, and extension of faculty privileges, such as voting for and serving on faculty councils and committees.

ELECTION NOTE

Bloomington, Indiana -- Ten candidates are seeking the seat on the Indiana University Board of Trustees now held by Robert H. Menke of Huntingburg.

Menke, who has served two three-year temrs on the board as an elected alumni representative, is not seeking reelection.

Ballots will be mailed to some 118,000 I.U. degree holders starting April 10, according to Cecil K. Burd, I.U. librarian. He is charged by statute with conducting the election. The ballots will be counted on May 13.

Among the candidates is <u>Dr. Joseph M. Black, Seymour physician</u>, former president of the School of Medicine Alumni Association and of the general Indiana University Alumni Association. Others are John R. Ax, Linton attorney; William L. Garrett, assistant director of student services at Ivy Tech; Suhail S. Hanna, Bloomington writer and editor; William T. Hornaday II, Bloomington attorney; Jan Hanzel Jonas, academic counsellor at I.U. at Bloomington; Sally Lied, law student at I.U. at Bloomington; Morris C. McKee Jr., I.U. graduate student at Bloomington; Alex Soverly, director of instructional media for East Chicago city schools, and Gilbert B. Young, South Bend businessman.

STUDENT PARKING FEES

More than \$20,000 in parking fees will be refuned to students by IUPUI to comply with a recent ruling by the Internal Revenue Service.

The IRS has ruled that a portion of student parking fees collected in the fall semester exceeded the guidelines of Phase I of the Economic Stabilization Program.

IUPUI Chancellor Maynard K. Hine announced that a procedure for paying the rebates has been worked out. It will amount to a maximum of \$5 for each student auto permit purchaser. The University charged up to \$10 a semester for full-time students and under the ruling, one half of the fees paid will be refunded.

Refunds will begin at the Safety Office, 924 West Vermont Street, this Monday. All students who have not applied for or claimed a rebate by May 15 will be issued letters notifying them of further refund procedures. Rebates may be claimed in cash or by check. The refund application period ends on September 15.

The IRS ruled that IUPUI should not have charged any increased fees in Phase I. But for the spring and subsequent semesters, all fees, tuition, and charges by educational institutions were specifically exempted from economic controls beginning Dec. 23, 1971.

The IRS, in its report of an investigation of the IUPUI parking situation, concluded that higher fees are justifiable.

The investigation was conducted as a result of inquiries by a group of students. "The students' inquiry was sound and justifiable, and the students are to be commended for their pursuit of equity," Chancellor Hine said. "They worked within the system and were very patient awaiting a response from the IRS."

ACUPUNCTURE ON WAT 21

"Acupuncture Anaesthesia as Performed in the People's Republic of China" will be broad-cast over WAT 21 at 12:17 p.m. and 6:47 p.m. on Thursday (May 4). It is a 20 minute color program.

Produced by the Network for Continuing Medical Education, the program is based on films of major surgery under acupuncture anaesthesia recently received from Mainland China. Dr. Samuel Rosen, who witnessed 15 such operations in China late last year, gives his observations about acupuncture anaesthesia and how it works. Dr. Rosen is Clinical Professor of Otology Emeritus, Mt. Sinai School of Medicine, and Consulting Otologist, New York Eye and Ear Infirmary.
