IUPUI Academic Policies and Procedures Committee Minutes Friday September 1, 2006

Minutes of the 5/5/06 meeting were distributed.

The meeting with EVC Sukhatme was deferred until October.

Announcements from the Chair

- Rick Ward raised a concern about the information that is archived in OnCourse, including grade books since IUPUI policy says that grades need to be maintained for 5 years
 - o 8/30 email from Dennis Cromwell
 - We have made excellent progress on archiving of grade book data. We can support the ability for a
 faculty member to request grade book data for up to five years. Although this will require additional
 development time in the Oncourse CL version, we are committed to establishing a grade book archive to
 support access beyond two years.
 - The procedure for accessing grade book data will not change. Two years worth of data will be available through the operational systems and the faculty member requests the data if it is more than two years old. We will not change the policy of a small fee to cover the effort to restore older data, but Garland and I will waive charges for grade appeals upon request from the department. I did not want to approach changing the procedure as we are in transition between systems. Once we retire Original Oncourse, we can look at a better mechanism for handling these requests and possibly eliminating all charges.
 - Our great desire would be for all campuses to adopt the same policy, but we understand that this may not happen.
- Implementation of JagJackets
 - Examples of the JagJackets (recruitment/admission information replacing Viewbooks) were viewed.
 - Academic units are encouraged to move forward with developing information that in the format of the information cards.

 connected with the health sciences.
 - The UCC will assume the responsibility for the review of new degree/certificate proposals previously completed by APPC.

- Admission Yield Information
 - We had a record number of freshman applications. Highest number of admits since 2000 when we had nearly open admissions. Yield rate continues to fall.
 - We had a record number of transfer applications. Highest number of transfer admits in IUPUI history. Yield rate rebounded from 2005 rate which was an all time low.

Items for Review, Discussion, or Action

- SMART grants and ACG program—Kathy Purvis
 - During APPC meetings last spring, preliminary information was provided about two new federal grants being given to students in the 2006-2007 academic year--the Academic Competitiveness Grant (ACG) and the National Science and Mathematic Access to Retain Talent (SMART) Grant. These grants are given to students who receive Federal Pell Grants and meet the remaining criteria for the grant(s).
 - ACG-1st year= \$750. 2nd =\$1300
 - SMART—Jr and Sr awards of \$4000
 - Physical, life or computer science, engineering, mathematics, technology, or a critical foreign language

 - When these two grants were developed by Congress, there has been very little time for the Department of Education to develop the regulations for the administration of these grants. The Financial Aid, Admissions, and Registrar staff have been working together to determine how best to make the awards for the eligible students, with confusing guidance from DOE. We are beginning to make the awards to IUPUI and IUPUC students.
 - The criteria or eligibility requirements for each of the grants are posted on the financial aid website http://www.iupui.edu/%7Efinaid/undergraduate/typesOfAid.html#Smartgrants
 - When you go to this link, scroll down to information on both the ACG and SMART.
 - We have identified the students that we believe meet the criteria for either the ACG or the SMART. Working with Mary Beth Myers and Mike Donahue, we have determined if the students receiving the SMART meet the academic criteria and whether the students receiving the ACG have met the federally approved standard of a "rigorous high school curriculum" and, for the 2nd year students, have the 3.0 gpa.
 - We are in the process of placing an "estimated" ACG or SMART grant on the students' financial aid account. This estimated award will not show up on their bursar bill until after the 1st week of the semester has ended, at which time we will confirm they still meet the enrollment requirements. We place the award in our system as a "place holder" so that if they receive other financial aid they do not receive too much aid which results in an overaward situation.
 - To date, we have awarded approximately 49 estimated SMART grants and approximately 450 first year ACG grants all to students who have a confirmed Academic Honors high school diploma. We are in the process of identifying the 1st year students who have a confirmed Core 40 high school diploma so that we can award them the estimated ACG. The final groups that we will identify are the 2nd year students who have met the "rigorous high school study" guidelines and have met the 3.0 gpa guidelines, AND all other 1st and 2nd year undergraduates who do not have an Indiana Academic Honors diploma or Core 40 diploma,

- but may meet one of the other two federal guidelines for academic rigor. Extracting the data on this last set of students is proving a bit more difficult because we may not have their high school diploma or final high school transcript (e.g., they could be transfer students) and we have to determine how many credits they have, etc.
- We have a core group of individuals in the Office of Student Financial Aid Services who are working specifically with these two new grant programs. - The academic units indicated that they have not been receiving questions from students about either of the new grants.
- Change in Spring Census Date—Mary Beth Myers
 - For the reasons explained below, IUPUI is changing the Spring census date to coincide with a revision in the last day for 100% refund. This change has been approved by the IUPUI administration and Steve Keucher in the University Budget Office.
 - <u>Background--</u> Indiana University campuses, including IUPUI, have generally used coinciding dates for the end of the 100% refund period and the census cutoff for official enrollment reporting. In the past, the IUPUI Bursar's Office has allowed eight days for the 100% refund period in the Spring semester. After the University adoption of the Martin Luther King holiday and subsequent loss of that day's transactions, the 100% refund period was set at nine days from the start of the spring semester.
 - <u>Change--</u>Effective Spring Semester 2007, the IUPUI Bursar's Office is returning to an 8-day 100% refund period. Spring refund percentages will follow the same pattern as for Fall terms:

100%	for	8 days
75%	for	6 days
50%	for	7 days
25%	for	7 davs

- IUPUI has been the only campus that allowed for an extra day of 100% refund. This decision was made so that weekend college students had the opportunity to attend at least one class and had the opportunity to make drop decisions with full refund. The refund calendar change back to eight days is based on opportunity for students to drop courses on-line via self service.
- <u>Action--</u>The official census date will be adjusted to coincide with the new Bursar 100% refund date. Although the official enrollment count at census for Spring 2007 will be based on one less day activity than was reported the previous year, the data from the last two years presented in the table below indicate that it will not have a substantive impact on the headcount reported at census.

- AIP for nondegree student business practices—Mary Beth Myers
 - Representatives from the offices and academic units involved in the admission and processing
 of UG and Grad nondegree students met over the summer to develop an integrated
 understanding of the pathway for nondegree students and to address the recurring problems
 the students have faced. The group addressed how to:
 - o get nondegree students to the correct point of entry.
 - o process the students as quickly as possible.
 - assess the students the correct fee.
 - The result was a complicated flowchart which demonstrated the multiple questions that needed to be addressed to route the student to the appropriate office.
 - At the end of the AIP, several follow up areas remained which are in the process of being addressed. When these discussions conclude, the flowchart will be shared more broadly.
- Sex Offenders Registry scan—Mary Beth Myers
 - Negotiations are occurring with the Criminal Justice Institute so that we can obtain both the names and a portion of the SSN of individuals on the Sex Offenders Register to permit us to scan IU enrollment records for comparisons. New regulations limiting disclosure of SSNs has impacted our previous procedures. The reports to the academic units will be generated as soon as we can resolve the issues.

Other items

- Reminder from David Koerner—Students do not need to go to the Grad Office in the Union Building to pick up the Drop/Add forms, before getting the faculty signature. The students can use the Drop/Add forms available from the academic unit offices.
- Gayle Williams—Traffic has not been a problem at the start of the semester.
 - Change in start times of classes may be a contributing factor.
- October 22 = Fall Campus Day with both an Undergraduate and Graduate student recruitment focus
- o On Sept 9 600 21st Century Scholars students will be on campus
- A new program, Step On to IUPUI Campus, will be offered during ISTEP testing on 9/17-19 to better handle student visitations. Last year approximately 400 high school students were visiting campus during the ISTEP dates and the new program was designed to better accommodate this number of visitors.
- Tobacco Free Implementation

- Fairly good compliance has been noted during the day; much less compliance during evening.
- Some individuals reported that their interactions with smokers have not been pleasant.
- Some international students/visitors are challenged by the policy due to cultural differences in the acceptability of smoking. This was noted particularly in the area of the ELS offices.
- We now have the problem that smokers are lining Michigan Avenue which is not a positive public view of the campus.
- Given the short time since the implementation, the general view was that things were progressing well.
- These observations and concerns will be shared with the Tobacco Implementation Committee.

Resolution on General Education Indiana University Board of Trustees August 18, 2006

Whereas undergraduate education is a core component of the mission of Indiana University, and

Whereas Indiana University is committed to providing a quality undergraduate education, and

Whereas an undergraduate degree should prepare students in a major field of study as well as provide a general education which imparts common knowledge and intellectual concepts and develop skills and attitudes that every educated person should possess, and

Whereas the general education components should be designed to facilitate transfer within and among Indiana University campuses and public institutions within the State of Indiana without requiring students to duplicate coursework to meet general education requirements, and

Whereas the Board of Trustees applauds and supports the priority commitment of the President to implement a general education curriculum at Indiana University as presented in his inaugural address and subsequent public statements, and

Whereas the faculty have been actively and productively discussing the principles and details of a general education requirement over the last two years, and

Whereas the education leaders of the State of Indiana have demonstrated a commitment to provide a process for seamless transfer among public institutions,

Therefore be it Resolved that no later than February 2007 the President and faculty submit to the Board of Trustees a plan to incorporate a specific general education component in the undergraduate degree requirements for all Indiana University campuses and programs, and

Be it further Resolved that the components of the plan address and incorporate the principles enumerated above.
