

New FFA Alumni Mentoring Program

The W.K. Kellogg Foundation, as a special project of the National FFA Foundation, has funded the development expenses of a mentoring program for the FFA Alumni Association. The proposed mentoring program will be pilot tested in four states during the 1995-96 school year and available for all FFA Alumni affiliates with the 1996-97 school year. The FFA Alumni mentoring program will ask the adult mentor to give a commitment to meet with an FFA member for a minimum of ten times during the year. A series of ten topics on personal leadership development will be suggested. The FFA Alumni mentor will have a lesson/resource unit on each of the ten topics. A video(s) will be produced for introducing the program and some of the topics. Neil Schneider, Arizona, FFA Alumni life member, has been selected to develop the leadership lesson/resource units.

Activities for Administrators, School Boards and Counselors at National FFA Convention

The FFA Partner Development Team will be hosting a breakfast for administrators, school board members, counselors and other school officials during the national FFA convention on Thursday, November 10, at 7:00 a.m. The breakfast will be complementary but reservations need to be made in September with Dr. Joyce Winterton at 703-360-3600, ext. 300. You will need to pick up your tickets at the convention. The breakfast will provide an overview of convention activities and be an opportunity to thank these "key partners" for their support of FFA.

Based on past experience, the national convention is a strong selling point for the benefits of agricultural education and FFA programs. "Seeing is believing!" Alumni members can be instrumental in encouraging administrators, school board members and counselors to attend the convention.

Operational Agreement Developed Between FFA and FFA Alumni

The National FFA Organization and the National FFA Alumni Association have developed a memorandum of understanding. The National FFA Alumni Association will cooperate in support of the agricultural education enterprise and the mission of the National FFA Organization. The National FFA Alumni was chartered in 1972 as an affiliate of the National FFA Organization. This is the first memorandum of understanding developed for approval by both boards. The National FFA Board of Directors has the final legal authority for the operations of the National FFA Alumni Association.

The agreement states that the National FFA Alumni agrees to follow the policies, constitution and bylaws of the National FFA Organization. The FFA Board of Directors specifically authorizes the National FFA Alumni Council to operate as an independent subsidiary board of the National FFA Board of Directors. The FFA Alumni Council will conduct general business, annual conventions and other FFA Alumni events. The development and implementation of the Alumni program of activities and budget will be the responsibility of the Alumni Council. The Alumni Council will also manage and invest all FFA Alumni assets and provide membership services for the FFA Alumni members.

The FFA Alumni Association will present an annual report to the National FFA Organization for ratification. The report will include the program of activities, budget, changes to the constitution and bylaws, policy changes, multiple year contracts, legal concerns and financial reports. The FFA Alumni Association will reimburse the FFA Organization for nonduplicated, indirect FFA costs according to a targeted schedule that has been developed. FFA Alumni members will be considered members of the National FFA Organization.

A copy of the memorandum of understanding between the National FFA Organization and the National FFA Alumni Association can be obtained by writing the national FFA Alumni office.

FFA Changing Contests and Awards Program

In the fall of 1995, FFA will be operating under a new contest and awards program. This new program is the result of a massive customer research project conducted by the independent firm, Synergy Research. The project included data collection from FFA customers including students, teachers, state staff, teacher educators, school administrators, guidance counselors, parents and business representatives. When this project is complete, more than 2,000 customers will have been involved.

Major changes occurring in FFA judging team contests include the infusion of team problem-solving activities, multiple level participation and multiple team participation. In proficiency awards, more areas are being added to reflect agriculture's diversity and placement options are being added to increase student opportunities. The American Degree is being divided into a short form for degree applicants and a long form for star applicants. And finally, the current three chapter award programs of BOAC, Safety and Chapter Award are being combined into one National Chapter Award Program.

FFA Faces the Challenge of Diversity

In January 1993, the National FFA Board of Directors established a Diversity/Recruitment Action Force. The purpose of the action force was to develop recommendations and proposals that would assist the board in providing a long-term strategic direction that would result in a more diverse student membership and national staff. The definition of diversity for this action force included ethnic, geographic, agricultural, demographic and socio-economic differences.

The membership of the action force included representatives of the following groups: agriculture teachers, state supervisors, teacher educators, agribusiness representatives, diversity/ multicultural specialists, education leaders outside of agricultural education and minority student organizations.

After an 18-month term of service, the action force prepared fifteen proposals that were presented at the July 1994 meeting of the National FFA Board of Directors. These proposals cover, but are not limited to, the issues of student recruitment, advisor inservice, research and data collection, mentoring initiatives, teacher recruitment and FFA policy changes. These initiatives will hopefully result in FFA being more accessible to all students.

Agricultural Biotechnology Skill Standards

Last August, the National FFA Foundation received a U.S. Department of Education grant to develop national voluntary skill standards for the occupation of agricultural biotechnology technician. The FFA project is one of 22 grants given by the U.S. Departments of Education and Labor as part of the America 2000 initiative to help ensure a better prepared workforce.

Skill standards – developed jointly by education, labor and industry – guide students in their educational progress and assist educators in developing curricula that meet industry's needs for future workers. The National FFA Foundation chose the emerging occupation of agricultural biotechnology technician because it believes that agricultural biotechnology holds tremendous promise for future employment of workers with less than a baccalaureate degree.

The Foundation's efforts to develop technical and employability skill standards for agricultural biotechnology technician are being led by an Executive Committee made up of representatives from leading universities, agricultural and agricultural biotechnology companies and from organizations including the National FFA Alumni Association. In turn, the Executive Committee appointed a Technical Committee which has met for several multi-day workshops where they developed the specific skills needed for the job.

This spring, a questionnaire containing skills was developed and sent to more than 1,200 technicians working in agricultural biotechnology in labs, greenhouses, animal facilities and on experimental farms. The results of the questionnaire are currently being tabulated and will be published in booklet form later this summer.

Public Affairs Support Provided for Aquaculture

The FFA Alumni recently provided approximately \$450 of inkind staff support for the National Council for Agricultural Educations' project to infuse aquacultural education into the agricultural education system. The proposal submitted for congressional funding will include aquaculture curricula with emphasis on agriscience, biotechnology, environmental and sustainable agriculture. More than 500 high schools have incorporated aquaculture into their agricultural education program.

The economic value involved with the seafood import deficit and the apparent concern of ocean seafood is currently having a positive outlook for aquaculture as an important agricultural area. FFA Alumni is proud that Congress has funded curriculum development for the past four years. Congress is presently making final agricultural appropriation decisions for 1995. We have been told they are very interested in funding the development of aquaculture curricula. Agricultural education has a state of the art instruction program for aquaculture because of the federal funding, the outstanding materials produced by the National Council for Agricultural Education, and the working together of all agricultural education organizations on this program.

National Council Meeting

- National FFA increased membership this year. Membership is 426,523.
- The average U.S. farmer or rancher produces enough food and fiber for 128.7 people.
- FFA Alumni has increased membership every year since it started in 1972.

FFA Long-Range Planning Facilities Committee

The National FFA Board of Directors has activated a committee with the responsibility of planning the best possible facilities for the National FFA Center. Due to Public Law 740 containing language regarding the headquarters and principal office of the FFA, the committee reviewed a legal opinion. The committee is presently clarifying the relationship between FFA and USDE. To accomplish this task, the committee recommended a memorandum of understanding be developed by a subgroup of the committee. The memorandum will be designed to strengthen the relationship between FFA and USDE. According to the committee chair, it will indicate the amount of latitude available to FFA for selecting a site for the National FFA Center. The FFA Long-Range Planning Facilities Committee plans to meet again after the November 1994 board meeting. Within the parameters of the memorandum of understanding, the committee will make recommendations to the board regarding one or more possible options for location of the National FFA Center. Options under consideration by the committee include: 1) Renovate current facilities; 2) Purchase another existing facility in Washington, D.C. area; 3) Lease another existing facility in the D.C. area; 4) Build a new facility on the Mount Vernon property; 5) Purchase a new site and build a new facility in the D.C. area; and 6) Move the FFA Center to a location outside the D.C. area.
