## Preparing a Syllabus for a New Course Proposal

School of Liberal Arts syllabi should clearly outline course goals, expectations, requirements and policies, and should apprise students of important academic resources on our campus.

Please use this syllabus checklist to assist you in developing your syllabus. Syllabi missing any of the elements listed may not be approved until they have been revised appropriately.

## **Syllabus Contents**

## A. Information about the instructor

1. Instructor's name; office number; telephone number; and office hours

# **B.** Course Information

- 1. Course number, section, title, location, credit hours
- 2. Required text(s), including author(s), title(s); and edition(s)
- 3. Course description and/or objectives, including connections to the Principles of Undergraduate Learning.
- 4. Prerequisites and/or co-requisites, or additional enrollment restrictions or authorizations (e.g., Instructor's signature)

# **C. Class Schedule Information**

- 1. For the date of each class meeting (or announced well in advance):
  - a. Specify: the subject matter/topics to be covered
  - b. Pre-class readings
- 2. Assignment due dates, e.g., homework, quizzes, papers, etc. (preferably highlighted)
- 3. Examination dates (preferably highlighted)

## **D. Grading Information**

1. Course requirements (exams, quizzes, projects, papers, presentations, class participation, etc.)

a. Proportion each requirement counts toward the final grade

2. An explanation of how the class participation will be evaluated (if class participation is part of the final grade)

3. A grading scale or other method of assigning grades

## E. Other Policies

- 1. Policies regarding late work and make-up examinations
- 2. A statement regarding academic integrity (i.e., a plagiarism statement)
- 3. Attendance policy (clear statement of attendance policy and how it is related to the course grade)
- 4. A statement regarding innovative class procedures/structures, such as cooperative learning exercises, service learning components, panel presentations, case study methods, class journals, etc.
- 5. A liability warning: Students should be warned that, ultimately, they are responsible for activity on their computer accounts
- 6. A statement regarding Adaptive Educational Services.

# Below we have provided sample statements that you may wish to incorporate into your syllabus:

<u>Plagiarism</u> is the violation of academic expectations about using and citing sources. *The Indiana University Code of Student Rights and Responsibilities* (available in CA 401) explains institutional penalties for plagiarism, or you may visit <u>http://www.jaguars.iupui.edu/handbook/2002/academicmisconduct.html</u> for more information. These IUPUI policies will be enforced.

<u>Adaptive Educational Services (AES)</u> provides accommodations for students with special challenges or disabilities that may affect their classroom performance.
