  current process.
- Recommendations for the Program Review Subcommittee to consider were solicited.

## 5. Update on "Ensuring Student Achievement of the PULs..."

- 10/30/09 was established as the deadline for units to update the PUL matrix.
- Experiences with developing five-year PUL assessment plans were related.
- Relevant campus resources and upcoming workshops were highlighted.
- Representatives of several schools provided updates on the process, including concerns and benefits.

#### 6. Review of results from last meeting

Urtel presented, via wordle, a summary of the responses about the benefits of and barriers to implementing the PUL assessment process. This was constructed by the membership during the 9/24/09 meeting.

The group briefly discussed the top two barriers (communication and faculty buy-in) and how the campus might address them.
