He learned these keys to success through his personal experiences. He now shares these powerful lessons and insights with his audiences. For eight years, he has made an impact on organizations and industries across the nation with his humorous, yet effective message. Following the awards session from 6-7:30 p.m., there will be a reception for all award winners and Alumni members along with country music entertainment by Dustin Wilkes.

Council Proposes Bylaws Changes

Delegates will vote on the following proposed changes to the National Bylaws at the business session at this year's convention. Alumni leaders reviewed proposed bylaws changes at the State Leaders Conference in Columbus, Ohio. (Changes appear in gold.)

Article IV Membership

Section I. Membership shall be open to anyone interested in supporting FFA, Agricultural Education, or volunteerism. *Membership in the FFA Alumni includes many rights, benefits, and privileges, however, no level of membership entitles any member to act for and /or on behalf of any local, state or the National FFA Alumni Association regarding any policy or position unless granted by and through these bylaws and/or is otherwise granted specifically, in writing, by the National FFA Alumni Association.*

Article VI Executive Board

Section VI. *Procedure for Selection of members of the Council*

A. Elected Members

1. Four regional representatives, to represent the membership in each region as defined in the manual, shall be elected during the National FFA Alumni Convention by the convention delegates from their respective regions. *Each regional representative must live within their respective region during their entire term of service.* All convention delegates shall elect the two member-at-large positions.



Attendees Learn to Build Support Network

“Advocates for Agricultural Education!” was the theme of the 2005 National FFA Alumni State Leaders Conference (SLC) held July 24-31 in Columbus, Ohio. By the end of the five-day event, attendees had adopted the theme as their own. The conference featured workshops, educational tours, and relaxing and fun activities.

Seventy participants representing 27 states attended this year’s conference hosted by the Ohio FFA Alumni Association. Tractor Supply Company (TSC) and Toyota sponsored the SLC as a special project of the National FFA Foundation.

Conference workshops addressed the ways in which Alumni members could communicate with their state legislators, the value of individual giving, the Alumni association’s future as a partner with the FFA organization, and volunteer management. Kristina was an active FFA member who participated in numerous FFA events, served as a chapter and state officer, and received the American FFA Degree.

Kristina is the first student to graduate with distinction with a master's in international communications from the University of Leeds, United Kingdom. She co-chaired the Farm and Fisheries Assistance Reconstruction Movement, which raised more than \$10,000 in 2005 for tsunami victims.

She serves as the public relations chair for the Hershey Figure Skating Club. In addition, she was a volunteer for the 50th Anniversary NATO Summit and a spokesperson for the Young Farmers' Association in the late 1980s.
