4. A National Seminar for Professional Leaders of Young Farmer and Adult Education Programs in Agriculture and Agribusiness will be held on March 17-20, 1974. This seminar will be held at the Hotel Continental in Kansas City, Missouri. A preliminary program will be available in December. Each State should send to this seminar one individual who is most responsible for Young Farmer and Adult Education Programs in Agriculture and Agribusiness in Teacher Education Institutions as well as on the State staff. In addition each State staff is invited to send one or two of its outstanding teachers and a young farmer. The program, however, will be focused on ways and means of further promoting and developing instructional programs in each State.
5. The Committee for the development of competencies in the major occupations on which Census data is available will meet in Atlanta, Georgia immediately preceding the AVA Convention. This meeting of the committee will be held beginning at 1:00 p.m. on Friday, November 30. It will be held at the Marriott Hotel.
