Purpose

The Office of Student Rights, Responsibilities, and Conduct (SRRC) is responsible for establishing and administering the Student Code of Conduct for the IUPUI community. We believe the disciplinary process to be an educational process. Our process allows incidents of misconduct to be an opportunity for the facilitation of education and student development.

Outreach and Consultation

In addition to managing the University's disciplinary system for student behavior, the SRRC Office provides a variety of programs to help educate students on university policies and student rights. Staff are also available to provide consultation to faculty and staff in dealing with misconduct issues, student grievances and other related concerns.

General topics have included:

- Student Code policies and processes
- Safety Rights and Responsibilities
- Addressing student misconduct in the classroom
- Tobacco Free Policy enforcement recommendations
- Campus referrals

In 2008-09:

- Through outreach efforts, SRRC engaged more than 2500 students about their rights and responsibilities as members of the IUPUI community.
- SRRC adjudicated approximately 182 cases through the disciplinary system.
- SRRC facilitated 28 workshops to faculty, staff and student staffs.
- SRRC completed 570 disciplinary clearance requests.
- SRRC collaborated with CCL to participate in the SOLD program for student organizations.
