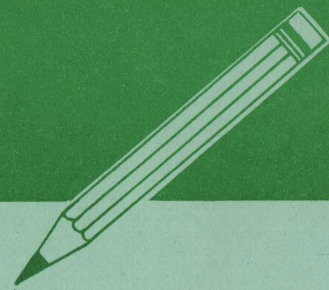

## SUMMER OF '73 FADES AS FALL SEMESTER OPENS

Classrooms and lecture halls at IUPUI will begin to fill up Wednesday, August 22, when the 1973-74 fall semester begins. Officials expect a record number of students.

Registration for all classes will be held in the lobby of Cavanaugh Hall Monday, August 20, and Tuesday, August 21. The hours for walk-in registration will be from 9 a.m. to 7 p.m. each day on a schedule based on the first four letters of the registrant's last name.

IUPUI fees must be paid at the time of registration. Students who have registered in advance will pay fees Thursday, Friday and Saturday (August 16-18). Payments are to be made in the lobby of Cavanaugh Hall according to a schedule based on last names similar to the regular registration schedule.

Students may make changes in schedules by dropping or adding classes on August 23, 24, 27, 28 and 29. Adjustments may be made at the registrar's office in Cavanaugh Hall or in Room 140 of the A Building on the 38th Street Campus. The final day for changes and late registration is August 31.

Information about the fall semester at IUPUI is available at all school and division offices and other campus locations.

## HERRON IN THE INTERIM

A search and screen committee, appointed recently by Chancellor Maynard K. Hine and chaired by Professor Bernard Bogar, chairman of the Department of Economics, is developing a list of candidates for the deanship of the Herron School of Art. The post is now vacant due to the resignation of Dean Benjamin de Brie Taylor to accept the position of director at the Institute of Design at the Illinois Institute of Technology at Chicago.

To provide continuity during this period, Chancellor Hine also has appointed an executive committee to manage the school until a dean is chosen and installed. This committee will exercise the functions normally assigned to the dean of the school.

Professor Donald Mattison, former dean at Herron, has been named chairman of the executive committee. Members are Professors Gary Edson, Phyllis Danielson and Arthur Weber. Advising the executive group are John Gebuhr, director of physical plant at IUPUI, and Dr. John C. Buhner, vice-chancellor and dean of the faculties. Secretary of the committee is Karl Ralph, administrative assistant at Herron.

#### TAXING SITUATION

The Federal Form W-4, Employees Withholding Allowance Certificate, will no longer be accepted by the Indiana Department of Revenue. In its place they have adopted Form WH-4, Employees Withholding Exemption and County Residence Certificate. This form will be used to determine the county of residence and county of principal work activity for purposes of the County Adjusted Gross Income Tax as well as the number of withholding exemptions for Indiana Adjusted Gross Income Tax.

It is extremely important that each employee promptly complete Form WH-4. All forms should be returned to account managers and sent to the Controller's Office no later than Wednesday (August 15).

Eventually appointment forms now in use will be changed to incorporate Form WH-4 information. Presently each new employee should complete Form WH-4 along with Federal Form W-4 and W-4E if applicable. Form WH-4 should accompany the advance Pay Advice copy of all appointment forms.
