## LEGISLATIVE REPORTS I

The Indiana General Assembly convened last week for a single day of organizational formalities and then recessed until January 7, when the legislators return to complete the 30-day session. Bills will be introduced and committees will meet during the interim.

Most legislative leaders are predicting adjournment around St. Valentine's Day: Most face election campaigns next year and don't want to risk the problems which may arise in a longer session; the Senate is meeting in temporary and inadequate quarters in the State Office Building and will want to end its operating frustrations as quickly as possible.

Although this is not a budget year, money bills will be introduced which may prolong the session. Governor Otis R. Bowen will ask for additional appropriations for mental health, corrections, and natural resources and for authorization to complete the Interstate Highway System in advance of scheduled Federal appropriations. Both Purdue and I.U. will also ask for additional funds.

There could be some considerable debate on legislative ethics bills. Powerful Speaker of the House Kermit O. Burrous (R-Peru) is backing a bill which would apply at least to House members. There is opposition to a broader ethics bill among the Senate leadership.

Some hot and extended debates may also erupt on such issues as pornography, school busing, and Sunday liquor sales. The Equal Rights Amendment, which passed the House and lost in the Senate during the last session, may be noisily revived. The Governor's powers to declare amnesty for prisoners involved in riots may also be debated.

Finally, because it is an election season, discipline may be harder for the Republican leadership. Some members may begin building records for re-election or for bids for higher offices. The Democratic minority in both houses, already expecting good fortune next November, may try to make issues to insure the expectations.

Events may conspire to keep the legislators in Indianapolis through the rest of the winter, perhaps until March 15 when they are required by statute to adjourn.

Eleven schools from eight states were invited to enter. The Indianapolis team defeated teams representing law schools at Loyola, Northwestern, Notre Dame and the University of Wisconsin in final arguments.

The Indianapolis Law School team will begin national final competition against the University of San Diego.

### SUMMER FACULTY FELLOWSHIPS

The Office of Research and Advanced Studies has made available a small amount of money to provide modest sums to support Summer Faculty Fellowships. The Summer Faculty Fellowship carries with it a stipend of \$1,200 for an assistant professor and \$1,400 for an associate professor. These are for individuals on 10-month contracts and in order to be eligible to apply it is necessary that no summer teaching jobs be held.

The purpose of the Summer Faculty Fellowships is to permit faculty members to devote time to pursue scholarly activities which will result in publications or the carrying out of preliminary studies to allow them to apply for larger grants-in-aid of research.

Applications may be obtained through the Office of Sponsored Programs by calling Ext. 8287. The deadline is January 1. The announcement of awards will be made no later than March 1.
