# 4. Update on Technology Support in the School of Liberal Arts-Michael Scott

Bill Stuckey celebrated his 35th year with IU this year. Please congratulate Bill.

Student Technology Fee transition status:

Last year Liberal Arts turned over the lobby workstations and BS3001 to UITS. Both areas were upgraded, BS3001 is now scheduled through Mary Anne Black's office, and SLA requests will be given priority.

This year Liberal Arts turned over the Composition By Computers labs, CA323 and CA425, and BS3003. The CBC labs were the very first SLA computer classrooms. All three rooms were upgraded with new workstations. These rooms are scheduled through Mary Anne Black's office, and SLA requests will be given priority.

The Digital Language Lab, from BS3003, is moving to CA319. This room will remain in Liberal Arts' inventory for the foreseeable future.

The former director of the Social Sciences Computer Classroom (SSCC), Dr. Wayne Husted, has left Technical Services to go to a position with UITS.

Next year the SSCC, CA436, will move to UITS control along with the old Bookstore space, CA008. Long terms plans for 008 include remodeling of the area with funding from campus, UITS and SLA, and a move of computer classrooms from the 3rd and 4th floors to the basement. Liberal Arts would repurpose the vacated space. These rooms are scheduled through Mary Anne Black's office, and SLA requests will be given priority.

Departments needing furniture should plan to visit CA008 where SLA stores used office furniture. UITS will take possession of that room July 1st, 2011, and will send the remaining furniture to Surplus.

Last year UITS funded full-time, appointed staff at 100%. This year UITS will fund staff at 75%, next year that funding will be reduced to 50%. The funds for part time consultants will be reduced at the same time.

Supplies and expenses are funded at a reduced rate each year, and the School will receive special grants to cover one-time-only upgrades to CA facilities.

July, 2012, Liberal Arts will fully fund tech support for faculty/staff computing, and any remaining SLA "owned" technology labs.

Special note to new faculty and staff members: Be very suspicious of any email that asks you to go to a site by clicking on a URL; these are phishing attempts. Go directly to a site, rather than clicking on a link in an email.

# 5. State of the School Address/Dean's remarks--William Blomquist

2009-10 was a year of challenges met and progress made

• reductions in state funding to Indiana University:

•First rescission, September 2009; SLA's share: \$79,670

•Second rescission, February 2010; SLA's share: \$125,250

•Combined reduction in state funding for the year: \$204,920

•Reduction for FY 2011: \$249,494

- First full year of three-year transition of all Student Technology Fee revenue to UITS
  - Liberal Arts Technical Services staff retained
  - Lobby workstations and printers in Cavanaugh Hall were replaced and are now maintained by UITS
  - Composition-by-computer classrooms CA 323 and CA 425 now maintained by UITS; computers and printers replaced
- Faculty and staff salary increases for 2009-10 were allowed only for promotions in rank or changes in positions.
- General-fund travel budgets were reduced by 50%.

And yet:

- Liberal Arts faculty received numerous awards for their teaching, research/creative activity, and service.
- Liberal Arts students received awards and recognitions, presented and published research, and graduated in record numbers: 521










• IU School of Liberal Arts general fund accounts total revenue by fiscal year


• IU School of Liberal Arts general fund accounts expenses by fiscal year




• IU School of Liberal Arts expenditure (%) FY 10 general fund accounts




• IU School of Liberal Arts FY 10 Compensation %'s

- We kept looking ahead
  - Through the collaboration of faculty, staff, students, alumni, and friends in the community, we completed the School's Strategic Plan for 2010-2015
  - This fall, we will develop an implementation plan of action steps, benchmarks, and measures of progress
  - We've prepared for "IMPACT: The Campaign for IUPUI," which launches its public phase on October 9th
  - Liberal Arts goals: \$4 million in philanthropic gifts, plus \$14 million in non-governmental grants
  - Targets: student support, centers and institutes, endowed faculty positions
  - Last year, we launched the series, "Liberal Arts Impact Stories"
  - This year, we're launching weekly programs highlighting research in SLA
- More challenges remain
  - We operate in an increasingly competitive higher education environment
  - We are more enrollment-and tuition-driven than ever
  - 2009 was the peak of the "echo boom"—nationally, high school graduates will decline for the next several years (although not as much in Indiana)
  - Other colleges and universities will get back in the hiring game
  - We have proved what we can do
  - We have contributed to the quality and success of the campus and the university
  - We have guided thousands of students through the completion of degrees
  - And we are the core—along with our colleagues in Science—of an IUPUI that now has more Arts and Sciences students than Medicine, Dentistry, and Nursing students combined.

6. Update on IUPUI Academic Plan--Uday Sukhatme, Executive Vice Chancellor and Dean of Faculties

Feels very welcome; arts and sciences are the core; will be a shining core; that's how a campus makes its reputation

Numbers are wonderful, and what's even more important is the growing worldwide rep

Chancellor Bantz has supported the implementation of the academic plan

Recap of progress:

 Signature Centers (started immediately after he began) 18 ppls; 10, 7; want to fund about 8-10 from now on out (3 yrs, then phases out–gives way to new ideas–chosen by faculty–what they're excited about–gives hi chance of success

What are markers of success? Number of students, # of invitns for talks;

These are now handled by VP for research

We invest \$3 million each year (large in comparison w/ other univs)

Brought in about 60-65 million each year

• Enrollment shaping initiative (to improve retention)

Conditional admits/Summer Academy - successful program. Many of these students are doing all right at IUPUI.

Predicted change of 3-4%, but takes 6 years to show up. One year retention rate is already showing up: 75% last year. Was nowhere near that in previous years. Shot up by about 12%; no other campus nationwide equals that. We are admitting more those we admit, and eventually they will graduate. Faculty should be proud of that, because teaching is important in that.

Still a ways to go. A major priority: more student campus on housing. Asks for faculty's help in making this a reality. Park Place is now rented and IUPUI students are there. Two housing units going up just across IN Ave; would have been better if on campus

Infrastructure and space constraints are one of the things holding us back. Have hired new faculty to teach the additional students, so office and lab space are at a premium. We are now forced to rent space in nearby vicinities, and often there is not space available nearby. He hopes for more space and infrastructure in the next few years.

- Revenue: Went aggressively over new degree programs that would also be attractive to out-of-state and international students. We are getting revenue from that, and SLA gets about \$1 million out of that.
- TRIP: IUPUI continues to get acclaim from its initiatives, and from RISE. All of the Schools have embraced that, and gone for it rapidly. The acronyms are catchy across the country when he gives talks.
- Development area: One area where we need to move forward. Public campaign is one way of doing that. Moving along well, in spite of the economy.
- By any measure, we have been able to enhance the research, service, and learning base.
- The future: Expects increased retention to continue: Grow by about 1000 students a year.

More out-of-state and international pgms: Grow by about 2000 a year.

Envisions campus of about 35,000 in about 7-10 years, and we're well on our way.

We told our master planners this when they came to campus. Wants an infrastructure plan, and how it will be paid for, to go with the other plans.

Question and answer:

- Q: Source of resistance to new housing? Not resistance; just slow. A matter of getting the pieces moving. Have proven they can fill the housing that's already been built.
- Q: What will happen to the old Wishard Hospital space? The easiest conversion is to convert Lockfield Gardens into dorms, but this is not moving fast enough either. Wishard has to build its parking garage, and then old buildings have to be torn down. Only then can IUPUI build whatever it's going to build there. Planners tell us what's to be built, but not how to pay for it.
- Q. Newspapers reporting rumor that new degree programs will not be line-item funded. Many of them generate their own income, esp. bachelor's degrees.
- Q. Question about 3% raise pool and enrollment shaping

The two are not connected. No comment on what governor is planning. Many more are going down much faster.

Enrollment shaping: You look at the numbers, and then track them over time. They were fairly constant, because not a lot of attention was being paid to them. After our recruitment push outside, enrollment picked up immediately. These are looked at as money we never had before. The money is divided half-half to ongoing recruitment efforts, and half to the schools for teaching the additional students. This is about \$1 million now, and we are on a good track for that. SLA should be getting about \$2-3 million in a few years.

- Q. Ambiguity of funding for additional housing and classroom, office, lab space. Sukhatme agreed.
- Q. Implications for online learning and classroom space we don't have. Has been pushing sciences departments to use a hybrid model: some physical labs could be converted to online labs, e.g., learn to do the experiments in physical labs, then followed by online simulations. Learning is key, but good if it helps with space.
