Non-Tenure-Track Representation on the Faculty Councils/Senates/Organization of IU Campuses

I. BLOOMINGTON FACULTY COUNCIL

A. CONSTITUTION OF THE BLOOMINGTON FACULTY OF INDIANA UNIVERSITY

Section 1.1: The Faculty

The faculty shall consist of the President, Provost and all professors and instructors with tenure-related appointments at the Bloomington Campus.

Section 1.2: Professional Librarians

Professional librarians at Bloomington with tenure-related appointments shall have all the privileges and rights vested in the faculty by this constitution.

Section 1.3: Professional Researchers

Holders of research ranks at Bloomington (as defined by action of the Board of Trustees on February 7, 1981) shall have the privilege of full participation in Faculty Council activities.

Section 1.4: Associate Faculty

Associate faculty shall consist of administrative officers of the Bloomington Campus who do not hold academic rank and all persons holding academic appointments at the Bloomington Campus who do not qualify as faculty under the provisions of Section 1.

Section 1.5: Emeritus Faculty

Emeritus faculty shall have the status of associate faculty.

B. BFC FAC MOTION, APPROVED APRIL 2007

Preamble

The Faculty Affairs Committee proposes the creation of a new election unit comprised of three non-tenure track faculty positions with one academic appointee from each of the following academic appointment classifications: Research Appointments, Clinical Appointments, Lecturer Appointments.

Motion

The Faculty Affairs Committee, in consultation with the Constitution and Rules Committee, moves the following changes to the Constitution of Bloomington Faculty of Indiana University:

Article V: Bloomington Faculty Council, Section 5.6: Members

A. Representation of Faculty and Librarian Units.

- 1. Faculty and Librarian Election Units; [...] Council representatives from election units must be persons qualifying under sections 1.1 **or** 1.2 of this constitution and shall be nominated and elected by such qualified persons in the represented unit.
- 2. Basis of Representation
 - Each faculty and librarian election unit shall have a minimum of one Council representative. [. . .] The College of Arts and Sciences, in addition to its representatives of its sub-election units, shall have a representative to represent the College at large.

B. At-Large Campus Representatives

There shall be ten Council representatives elected from the Bloomington campus at large of whom at least two must be untenured. Such representatives must be persons qualifying under section 1.1 and 1.2 of this constitution.

C. Non-Tenure Track Campus Representatives

Non-tenure track faculty shall constitute an election unit entitled to three representatives. One Council representative must hold a Research Appointment and qualify under section 1.3 of this Constitution. One Council representative must hold a Clinical Appointment and qualify under section 1.4 of this Constitution. One Council representative must hold a Lecturer Appointment and qualify under section 1.4 of this Constitution.

- **D.** Retired Faculty and Librarians [...]
- **F.** Administrators [...]
- **G.** Student Representatives

The voting membership of the Council shall include:

- 1. The President and a Vice President of the Student Association.
- 2. Four graduate students selected in accordance with the procedures of the Graduate Student Organization, of whom at least one shall be an officer of the Graduate Student Organization and at least two shall be associate instructors.
- **H.** The President of the Professional Council shall be a voting member of the Council.
- **I.** Non-voting Members

The Council's bylaws may provide for non-voting BFC representation of other campus constituencies.

II. INDIANA UNIVERSITY EAST -FACULTY SENATE

CONSTITUTION [last amended 3/4/2008; no change to the following since 2002]

Preamble

We the Faculty of Indiana University East, in order to promote excellence in scholastic and professional attainment, and to maximize participation, influence, and effectiveness of the faculty in the operation and development of Indiana University East, do hereby constitute ourselves as the Faculty Senate.

Article 1. The Faculty

Section 1.1 Source of Powers

Subject to the limitations imposed by the Board of Trustees of Indiana University, the laws of the State of Indiana, and the Indiana University Faculty Constitution, this constitution confirms and establishes in the Faculty the powers and duties herein specified.

Section 1.2 The Faculty

The Chancellor, the Executive Vice Chancellor for Academic Affairs, and all fulltime employees holding academic rank (including fulltime professional librarians, lecturers and clinical faculty) shall constitute the faculty at Indiana University East.

Section 1.3 Associate Members

Persons who serve as part-time teaching staff, adjunct, visiting and emeritus faculty shall have all rights and privileges in the Senate meetings except the vote.

Section 1.4 Voting Members

All faculty, as defined in Article 1, Section 1.2, shall be voting members of the Faculty Senate.

III. INDIANA UNIVERSITY SOUTH BEND-ACADEMIC SENATE

CONSTITUTION [Revised through March 2008]

Preamble

Subject to the limitation imposed by the laws of the State of Indiana and the Board of Trustees of Indiana University, and the Indiana University Faculty Constitution, this Constitution establishes the powers and the duties herein provided for and confers them upon the Academic Senate, Indiana University South Bend. The Constitution is to be construed and implemented in the spirit of affirmative action principles and of civil rights legislation.

ARTICLE I. MEMBERSHIP

Section 1. Voting Membership

Full-time staff members holding the following academic positions shall be granted the right to vote in the Academic Senate:

Professor Instructor Associate Librarian
Associate Professor Lecturer Assistant Librarian
Assistant Professor Librarian Affiliate Librarian

Associate (5/98) faculty who are scheduled to teach at least one credit course in the fall of the current academic year or who taught at least one credit course in the preceding academic year, may select representatives from their number to serve as voting members of the Academic Senate. The number of representatives shall not exceed fifteen (15).

Section 2. Emeritus Faculty

Attendance and speaking rights at Senate meetings are extended to emeritus senate members (6/96).

IV. INDIANA UNIVERSITY SOUTHEAST -FACULTY SENATE

CONSTITUTION [Last updated July 2005]

ARTICLE III: MEMBERSHIP

SECTION 1: COMPOSITION

The Faculty Senate shall consist of the following members:

- A. Administrators
- 1. Chancellor
- 2. Vice Chancellor of Academic Affairs
- 3. Vice Chancellor of Student Affairs
- 4. Vice Chancellor of Administrative Affairs
- B. Persons holding faculty rank in the following categories:
- 1. Elected representatives of degree-granting divisions and the Library
- 2. Elected part-time faculty members*

*Note: Part-time faculty includes: adjuncts, part-time lecturers, part-time professorial faculty, and IUS full-time staff who also teach part-time.

- C. Director of the University Division
- D. Administrative Heads of degree-granting divisions who do not hold faculty rank
- E. Administrative Heads of degree-granting divisions not elected as senators
- F. Director of the Library (if not elected as a senator)
- G. One professional staff representative appointed by the Professional Staff Council
- H. President of Staff Council
- I. President of the Student Government Association

SECTION 2: VOTING PRIVILEGES

Voting privileges shall be limited to persons designated in ARTICLE III, SECTION 1, PART B.

V. INDIANA UNIVERSITY NORTHWEST -FACULTY ORGANIZATION

CONSTITUTION [Last updated 1998]

Preamble

Subject to the limitations imposed by the laws of the State of Indiana and the Board of Trustees of Indiana University, and the Indiana University Faculty Constitution, this Constitution establishes the powers and the duties herein provided for, and confers them upon the Indiana University Northwest Faculty Organization. The Constitution is to be construed and implemented in the spirit of diversity that enhances this university community.

ARTICLE 1: ELIGIBILITY TO VOTE

Section 1. 1 The Faculty

Persons holding appointments as full-time faculty with instructional, clinical or research responsibilities of a regularly established academic division or the Library of Indiana University Northwest, shall be members of the Faculty. The Faculty may attend and speak in Faculty Organization meetings, to vote, to serve on a committee, and hold elected positions in the Faculty Organization.

VI. INDIANA UNIVERSITY-PURDUE UNIVERSITY FORT WAYNE

CONSTITUTION [Last updated 9 December 2002]

I. Definitions

- A. **Positions of academic rank** shall include professor, librarian, associate and assistant professor or librarian, instructor, affiliate librarian, and lecturer.
- B. **The Faculty** shall be composed of the chief administrative officer of IPFW, the Presidents of Indiana University and Purdue University, and those employees of the University who hold academic rank.
- [...]
- C. **The Voting Faculty** shall consist of those full-time members of the Faculty and those faculty who are on partial retirement, who are not enrolled in an undergraduate degree program at IPFW nor in a graduate degree program in their home department and who:
- 1. Are tenured or hold tenure-track appointments in academic units subject to those powers of the Fort Wayne Faculty detailed in Section VI, below, and perform duties at least half of which consists of teaching or other creative/scholarly work; or
- 2. Are tenured or hold tenure-track appointments with the rank of librarian or associate, assistant, or affiliate librarian; or
- 3. Hold the rank of assistant, associate, or full clinical professor.
- D. **Associate Members of the Faculty** shall consist of emeritus, continuing lecturers, and visiting members of the Faculty and persons who have academic appointments but who are not Faculty. These individuals shall have the privilege of attending Faculty assemblies and convocations, but shall not possess the right to vote.

VII. INDIANA UNIVERSITY KOKOMO
