Report from the IUPUI Resource Planning Committee

- -- Meeting yesterday, IUPUI Resource Planning Committee;
- --Prior to meeting; review of Dawn Rhodes;
- --Discussion of state appropriations;
- --Ongoing discussion of assessments (all units)

Budgetary Hearings / Cluster Conversations

- --Attempt to try something new (combination of old & new)--continue to have conversation with each dean (private) + cluster conversations;
- --Campus Planning, Budgetary Affairs, and Executive Committee will have a chance to interact with the Deans;
- --Murphy distributed questions;
- --3-4 questions (from our list) will be asked of each dean

Budget & Planning Hearings

- --Saturday, February 22, 2014 (1 morning session + 2 afternoon sessions; times not determined yet);
- --Also: Feb 4 and March 4
- --There are volunteers for all three dates;
- --February 22: each cluster conversation will last about 90 minutes (larger groups);
- --Feb 4 & March 4: these conversations will take place about 5:00 (right after Faculty Council);
- --1 cluster, each day (3-4 deans); shorter conversation;
- --Deans will all get the same questions; there will be written responses

Murphy:

- --everyone is invited to all of the cluster conversations;
- --try to attend all of them;

Banta:

- --be prepared with questions;
- --in the past, members of the faculty have not been prepared
- --Deans will have answered questions in writing already;
- --We will have time to review their answers;
- --Our verbal questions should be based on these questions/responses

- --Karen Lee? William can, if needed;
- --Banta: they would like us to prepare a report

Question/discussion as to the purpose of the cluster conversations:

- --This committee requested these conversations;
- --This is an opportunity for communication of budgetary information to faculty;
- --This is also a chance for faculty to engage with Deans;
- --What are the goals of this committee, re: cluster conversations?

Trends; 5 of 20 schools in downward cycle (this is cyclical)

Other topics:

- --Assessments;
- --Space considerations;
- --Indiana Biosciences Research Institute

Banta asked for clarification of question #2 on the BAC list for cluster conversations: "How is your unit reacting to the changing credit hour income?" Is there a perception that the metric 'income per credit hour' has changed? Or is this just a question about income going up or down with changes in enrollment? Some schools have a decline; others have increase?

Will decline in credit hour income affect program quality?

Continue review of the IUPUI Strategic Plan "A Commitment to Indiana and Beyond."

Murphy:

- --Previously, we decided to focus on student-centered aspects of the strategic plan (student learning and success).
- --Continue this conversation? Or, would you like to move on to other areas of the plan?

Enrollment management:

- --Transfer students; accreditation team noted that we weren't doing a lot for our transfer students;
- --Discussion of DFW and how this impacts length of students spend here;
- --This campus has significant success with first-year students;
- -- Can something similar be done for second year, or transfer, students?
- -- Create themed learning communities for transfer students?
- --Transfer students are not quite 1/2 of new students each year (45%);
- --Passport and Partner programs (w/ Ivy Tech);
- --Students need to complete 30 credits in their first year;
- -- Challenges for transfer students;
- --Student mentorship for transfers (peer mentors?);
- --Transfer retention rates are lower than for first-time enrollees;
- --Transfer center

Autonomous PhD programs

- --Recommendation, re: change is status of Director of the Graduate Office;
- -- Undergraduate experience suffers when graduate education emphasized;
- --PhD programs don't make money

New administration building will occupy parking lot at New York and University Boulevard
