THE ORGANIZATIONAL MEETING

A mood of optimism and enthusiasm prevailed as representatives from 33 states met to launch the National FFA Alumni Association.

May 12 was a beautiful day in Chicago as FFA Alumni Council Chairman Gus R. Douglass, West Virginia Agriculture Commissioner, called the meeting to order. "Today we stand face to face with an opportunity offered to few people," he said in his opening remarks, "What we do with it can affect agriculture positively for generations." "The FFA Alumni Association is needed for the advancement of agriculture and to help provide youth with a purpose through agriculture," Mr. Douglass continued, "FFA Alumni members can help agricultural education by applying their practical experiences to fresh, innovative programs to give agribusiness its rightful stature in our society."

The dedication, enthusiasm and aspirations of those present could be felt for the new organization. The group included blue-jacketed FFA members, FFA Advisors, vocational agriculture supervisors, farmers, businessmen, and professionals from other endeavors.

State FFA Alumni Association Charters were presented to 22 states. This brought the total of chartered states to 31 since 9 had been presented at the National FFA Convention. Life members in attendance were presented their special life membership cards and certificates.

A progress report explaining the early development was given which showed momentum building. Membership growth the first 12 days of May exceeded that of the entire 1971 year. The report stressed the need for building membership and organizing state and local affiliates.

Aimed at "Planning for the Future" the assembly broke into 6 working sessions. The areas were: Constitution, Membership Development, National Activities, State Activities, Local Activities, and Nominating Committee.

The noon luncheon included a live broadcast on 50,000 watt WGN Chicago of the Orion Samuelson Farm Show directly from the Alumni meeting. Mr. Samuelson, a former FFA member, told the group, "I would not be in the pleasant spot I am today if it had not been for FFA."

The afternoon business session contained reports and recommendations to the Council from the working sessions with an open discussion from the membership as to the direction they thought the FFA Alumni Association should take.

The election of the next FFA Alumni Council is to be held by mail ballot. The results are to be announced at the next Alumni meeting.

The next meeting is to be held on Friday afternoon, October 13, 1972, in conjunction with the National FFA Convention in Kansas City, Missouri.

In adjourning remarks, Chairman Douglass expressed a hope that everyone in attendance would make a sincere effort to be for what is good for their state and community in building the FFA Alumni; and that the flame kindled at the Organizational Meeting will grow larger with each person in attendance igniting someone else in their community to become a part and join this new organization.

NATIONAL FFA CONVENTION HIGHLIGHTS

The 45th National FFA Convention will be held in Kansas City, Missouri, October 10, 11, 12 and 13. More than 14,000 FFA members and guests are expected to attend.

The Convention begins with the Tuesday evening Vesper Services. Business meetings and the finals of the National Proficiency Contests are held on Wednesday. The evening session will feature the finals of the National Public Speaking Contest.

Dr. Earl Butz, the United States Secretary of Agriculture, will highlight the Thursday morning session. The American Farmer Degree will be conferred on 471 FFA members Thursday afternoon and the National Award winners will be named. The evening session will feature the traditional naming of the Star Farmer and Star Agribusinessman of America.

Friday morning is a business session and international guests and contest winners are recognized. The afternoon features the first Annual FFA Alumni Association Meeting and FFA Day at the American Royal Livestock and Horse Show. The traditional Firestone Show will signal the ending of the convention.

CHARTERING A LOCAL AFFILIATE

In answer to a number of inquiries, \underline{YOU} can be the one to pioneer the effort to charter an FFA Alumni affiliate in your area. The first step is for someone to act as chairman to initiate the action. Most FFA Chapters are now in the process of looking for a chairman.

Local affiliates can be chartered on a school, county, or other area basis. Three steps are required to charter: (1) to have at least 10 dues-paying members, (2) to have purposes in harmony with the FFA Alumni Association, and (3) to have a designated chairman (which could be you).

ACT NOW AND MAKE HISTORY

If you act now you can write your chapter's name in history. The names of all local affiliates chartered on or before October 13th will be recorded in the official minutes of the first Annual Meeting. RESULTS OF THE WORKING COMMITTEES

Constitution:

The Constitution Committee was chaired by Dr. James Clouse with Mr. Gordon Galbraith, the recorder. It recommended the following be added to the purposes: (1) To promote and maintain an appreciation of the American free enterprise system of free men; and (2) To promote the personal development aspect of the FFA. Other constitutional revisions were also suggested for future consideration.

Membership Development:

With Mr. Tim Burke as chairman and Mr. Edward O'Nan as recorder, many items were considered with the following two recommended: (1) That, to provide incentive for states to build membership, a state be reimbursed at the rate of \$1.00 per Alumni member when the Alumni membership meets or exceeds the active FFA membership in a given year. (2) That a Memorial Fund be established, and upon the death of a life member, their \$100.00 life member dues be placed into the fund where memorial scholarships in the name of the life member can be given.

National Activities Committee:

Mr. Ed Hadlock served as chairman, with Mr. Coleman Harris as secretary. Numerous activities were suggested for future consideration. A primary concern was to develop better public relations for vocational agriculture, FFA, and agricultural industry by disseminating information in various forms. It was also recommended that a source of supporting materials, membership pin, etc., be made available to local and state affiliates.

FFA Alumni Association

P. O. Box 15058 Alexandria, Virginia 22309 State Activities Committee:

With Mr. Kenneth McMillan as chairman, and Mr. Billy Conner as recorder, a number of suggestions were made for the operation procedures of state organizations. It was recommended that states have the key responsibility for getting local alumni groups functioning.

Local Activities Committee:

Mr. Dan Lehmann was chairman and Mr. Ed McMillan was secretary. Among the many items considered by this committee, three recommendations were made as follows: (1) That a guideline of local affiliate activities be made available: (2) That local affiliates place special emphasis on specific areas; and (3) That the present local affiliates send their activities to the national for distribution in the newsletter.

Nomination Committee:

Mr. Millard Gundlach served as chairman and Mr. Dennis Sargent as secretary of this committee. A slate of candidates were nominated for the five Council members to be elected. Two were nominated from each of the four FFA regions and four candidates for the member-at-large. Those nominated were: Pacific Region-Harry Epler, Wyoming; Dan Dooley, California: Central Region-Kenneth McMillan, Illinois; Jerome Donovan, Ohio: North Atlantic Region-Ed Hadlock, New York; Phillip Alampi, New Jersey: Southern Region-W.T.Ellis, North Carolina; Dick Weekley, Texas: Member-at-Large - Gus Douglass, West Virginia; Larry Craig, Idaho; Roger Sandman, Nebraska; and Oliver Kinzie, Oklahoma.

An election by mail ballot of all members will be held. The results will be announced at

the next meeting.
