

LAW SCHOOL DRAWS LUGAR FOR IMMIGRATION OVERVIEW

Senator Richard G. Lugar and other guest speakers will lead a free one-day seminar for lawyers and anyone else interested in the new immigration law that makes sweeping changes in nearly every area of immigration to the U.S. Joe Tucker, coordinator of the seminar, teaches immigration law at the school and will present an overview. He points out that understanding the new law is important to many people in the Indianapolis area because of the growing numbers of internationals here. "There are enough internationals in this area that in 1985 Indianapolis got an immigration service sub-office," he said. This seminar will help local attorneys learn more about the law, Tucker said, "but it should also be of interest to anyone dealing with aliens or immigrants--business, internationals and universities." Specific areas of the law will be addressed by several specialists. Paul D. Gresk, Indianapolis attorney, will talk about visas for executives and employees, and Wilma Shepherd, certification specialists with the Indiana Employment Security Division, will talk about the controversial labor certification process in the new law. Also, Ferenc Vandor, immigration law attorney from Chicago and former trial attorney for the U.S. Immigration and Naturalization Service, will discuss the deportation hearing. Finally, marital fraud and the practical aspects of the new legislation will be discussed by Timothy Clark, attorney for the Legal Services Organization of Indiana, Inc. Migrant Farm Worker project. The seminar is Feb. 10 from 1-6 p.m. in room 104 at the school. Registration is required. Call DeAnn Cook at the law office of Gresk, 632-8703.

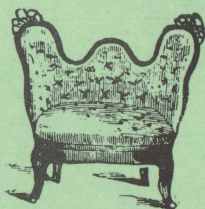

SUPREME COURT JURIST TO RESIDE

Robert F. Utter, whose career in law has taken him from clerk to chief justice of the Supreme Court of Washington State, will be the Distinguished Jurist-in-Residence at the School of Law, Feb. 9-10. Now a justice in the court, Utter has also served on the King County Superior Court which includes the Seattle area. The author of several books, Judge Utter is noted for his contribution to the recent resurgence of interest in state constitutional law, a lecture topic he will use. Faculty and students will also hear lectures on the subject of Chinese law, which has a unique legal mode of dissolving disputes. As leader of a delegation of judges and lawyers to the People's Republic of China last year, Utter has firsthand knowledge of the system.

ROTC SCHOLARSHIPS AVAILABLE TO ALL UNDERGRADS

Student assistance programs are changing in many areas, but students should be reminded that the rules have not changed for the generous Reserve Officers Training Corps Scholarships. Scholarships pay all tuition, lab fees, graduation fees, \$187.50 each semester for books and \$1,000 each year in grant monies. Students must enroll in Military Science Dept. courses, but can do so after application. The deadline for two-year applications is Feb. 16; for three-year it is Mar. 23. Call 4-2691.

PROF. JEGEN'S TAX TIPS: BURDEN OF PROOF ON YOU

The odds are small that they will, but should your dealings with the IRS on actions since 1985 go as far as Tax Court, the burden of proof of demonstrating that the IRS' action against you was not substantially justified is on you, the taxpayer. Should you come out the winner, there is no upper limitation on the amount of litigation costs which may be awarded you. However, you will be held to legal fees of no more than \$75 an hour, unless the Tax Court determines that a higher amount is warranted. If the court decides in your favor, the IRS will pay a reasonable amount for the services of expert witnesses you had. Before any of this however, you must exhaust all administrative remedies through the IRS, prior to filing petition to bring in the Tax Court. If after 10-22-86 you bring a "dilatory or frivolous proceeding into the Tax Court" by not following the IRS' administrative appeals process, then the Tax Court can impose a penalty of up to \$5,000 against you. POLICE HAVE FREE LIFESAVER TAGS FOR KIDS

The IUPUI Police Dept. is offering free tags that can help children in an emergency. Made to be sewn into clothing and shoes, the little washable tag not only has space for the name and address of your child, but there is room on it for your doctor's name and for medical information. It gives parental consent for your child to receive emergency medical treatment and it allows police to call you immediately after an emergency. All students, staff, and faculty are invited to participate in workshops during the spring semester. Come to Cavanaugh 427 for any workshop that fits your needs or interests. If you would like further information about the Writing Center or its workshops, call 274-2049.

Wednesday, February 4 1:00-2:00 p.m. "Writing Literary Analyses" This workshop for current and future L115 students presents a systematic approach to writing about a piece of literature. Students in any L115 section are welcome to attend.

Thursday, February 5 1:00-2:00 p.m. "Looping: The Two-In-One prewriting Tool" Learn a technique for drawing out your ideas on a topic and finding a focus at the same time. Examples and a live demonstration will be provided.

Wednesday, February 11 2:00-3:00 p.m. "The Black Death: Choosing a Research Topic" How do you decide on a subject to investigate? How do you narrow your topic? This journey through one such focusing demonstrates a process that works.

Monday, February 16 11:30 a.m.-12:30 p.m. "Personal Responses to Literature--Enough Said?" This workshop for current and future L105 students helps participants generate both personal and generalized responses. The values, but also the limitations of personal reactions are discussed in terms of sharing meaning about literature.

Tuesday, February 17 1:00-2:00 p.m. "Be Specific" If readers respond to your essays with little interest, perhaps you're being too general. This workshop stresses the need to be concrete. Bring a sample of your writing to analyze.

Monday, February 23 2:00-3:00 p.m. "Essay Exam Preparation" How can you dissect essay test questions? What strategies help in understanding the goal of certain kinds of questions? This workshop designed for students of all disciplines includes help in preparing for midterm exams.

Wednesday, March 4 11:00-Noon "Writing Style" Looking at a sample piece of writing, you discuss writing strategies and techniques. Imitating the structure or style of the sample allows you to try new ways of writing.

Wednesday, March 25 Noon-1:00 p.m. "Using Data to Draw Conclusions" Designed for W231 students who must synthesize data, this workshop looks at ways to draw generalizations. You are encouraged to bring your material to this workshop to begin synthesizing.

Thursday, March 26 11:30 a.m.-12:30 p.m. "CS Repair Work: Writing

Complete Sentences" If you are a student in W001, W131, or any other class and feel frustrated by comma splices, fragments, and fused sentences, you may find relief at this workshop. Bring samples of your own writing.

Thursday, April 2 11:00 a.m.-Noon "Documenting Your Paper" Are you puzzled by professors' requests for APA or MLA style? Learn in this workshop where to turn for help with endnotes and bibliographies. Students from any class are welcome.
