Researchers who receive the knockout lines through NIH are free to publish any results from research involving the lines and also to seek patent or other intellectual property protection for any of the inventions or discoveries resulting from such research. INDIANA UNIVERSITY SCHOOL OF MEDICINE (IUSOM) GRANT WRITING WORKSHOP: The annual grant writing workshop, presented by Grantwriters Inc., will be held November 17, 2008 in the IUSOM Riley Outpatient Clinic (ROC) auditorium. Registration will be available on the IUSOM continuing medical education (CME) web site in August or September, 2008. This annual workshop teaches the art of grantsmanship. The reviews of this workshop, from both new and experienced grant writers from various disciplines, have been outstanding every year.

DID YOU KNOW?

CAMPUS FACTS

Research award dollars on the IUPUI campus for this fiscal year (2007-2008) to date are up by 16.6% compared to the same period last year.

The 2008 annual review from Arizona State University's Center for Measuring University Performance ranked IUPUI among the top 50 public research universities in the country. This is remarkable given the low number of Ph.D.s that are granted by IUPUI and it attests to IUPUI's outstanding performance in the area of external funding.

In 2007 IUPUI received \$114 million in research awards from the National Institutes of Health (NIH), \$17 million from foundations, and 2.1 million from the National Science Foundation (NSF).

As of June, 2007, Indiana University's endowment totaled 1.6 billion, which placed Indiana University 14th among all public universities in the nation in the market value of its endowment and eighth in the Big Ten.

NATIONAL FACTS

From 2003 - 2006, 24 foundations awarded research grants that were larger than \$600,000. The Gates Foundation awarded 51 grants in this range and the Robert Wood Johnson Foundation and the Gordon and Betty Moore Foundation each awarded 6 grants in this range. Forty foundations awarded grants in the \$350,000 to \$600,000 range and twenty nine foundations awarded grants in the \$250,000 - \$350,000 range. Rapid increases in funding for R&D are substantially less effective in improving U.S. competitiveness than are steady long-term increases argue Richard Freeman and John Van Reenen in their paper entitled *What if Congress Doubled R&D Spending on the Physical Sciences?* The rapid growth in the NIH budget (\$14 B to 27 B) in the period 1998-2003 resulted in a substantial increase in both the number of researchers and the number of grant applications submitted to NIH. After the funding surge ended, however, the number of grants awarded decreased, but the number of applications did not. The result was a large drop in the rate of successful applications which led to staff reductions. IDENTIFYING FUNDING OPPORTUNITIES

On-line search tools are available to IUPUI investigators who are interested in identifying funding opportunities in their areas of interest. Several are listed below:

Community of Science (COS): COS is a primary on-line search tool for identifying funding opportunities. To take advantage of this tool, register at http://www.cos.com/login/join.shtml. Once you have completed the short registration process, you can personalize your search by selecting the option entitled "launch your workbench". You can access federal, local, corporate, foundation, nonprofit and other funding opportunities using key terms and save the results of up to 20 searches and have them delivered to you weekly via email.

National Institutes of Health (NIH) "NIH Guide": To take advantage of this search tool, register at http://grants.nih.gov/grants/guide/listserv.htm. It allows you to receive discipline specific funding opportunities that are delivered to you weekly via email.

National Science Foundation (NSF) "MyNSF": To take advantage of this search tool, register at http://www.nsf.gov/mynsf/. It allows you to receive discipline specific funding opportunities that are delivered to you weekly via email.

Federal Business Opportunities "FedBizOpps": FedBizOpps is the single government point-of-entry for Federal government procurement opportunities over \$25,000. To take advantage of this search tool, visit http://vsearch1.fbo.gov/servlet/SearchServlet. Opportunities found at this site include, but are not limited to, presolicitations and special notices for research and service contracts for specific projects and some national centers and surveys that would not be found in Grants.gov and may not be found in the Community of Science.

NATIONAL INSTITUTES OF HEALTH

POSSEMINATION, IMPLEMENTATION, AND OPERATIONAL RESEARCH FOR HIV PREVENTION: Goal is to enhance the science of technology transfer, dissemination, implementation, and operational research for evidence-based HIV-prevention interventions in the United States. Five broad areas of need are identified: dissemination, adoption of interventions, implementation fidelity and adaptation, effectiveness of interventions, and sustainability of interventions. Standard application deadlines apply.

USE OF POOLED STATE ADMINISTRATIVE DATA FOR MENTAL HEALTH SERVICES RESEARCH: Focus is on analysis of existing state and national administrative datasets to track the impact of state-level policy initiatives. Applicants from state agencies, in partnership with research collaborators, are invited to submit research grant applications to use existing administrative datasets to address specific policy questions relevant to the state or region. In this context, "existing" refers to data elements that are already being collected in some form by a relevant (public) agency; however, there is neither a requirement nor necessarily an expectation that the data in question are currently being used for research or policy analysis, nor that there are pre-

METHODOLOGY, MEASUREMENT, AND STATISTICS (MMS): The MMS Program is an interdisciplinary program in the Social, Behavioral, and Economic Sciences that supports the development of innovative analytical and statistical methods and models for those sciences. MMS seeks proposals that are methodologically innovative, grounded in theory, and have potential utility for multiple fields within the social and behavioral sciences. The MMS Program supports a variety of different types of awards, including: Regular Research Awards, Mid-Career Research Fellowships, Doctoral Dissertation Research Improvement Grants, and Research Experience for Undergraduates (REU) Supplements. NATIONAL FOUNDATION FOR THE ARTS AND HUMANITIES

NATIONAL ENDOWMENT FOR THE HUMANITIES (NEH) SUMMER RESEARCH STIPENDS LIMITED SUBMISSION OPPORTUNITY: Successful applicants receive an award of \$6,000 for two consecutive months of full-time research and writing. IUPUI may nominate no more than two faculty members teaching full-time. COLLABORATIVE RESEARCH GRANTS: Collaborative Research grants support original research undertaken by a team of two or more scholars, or research coordinated by an individual scholar that, because of its scope or complexity, requires additional staff or resources beyond the individual's salary. Eligible projects include research leading to the preparation of scholarly publications that break new ground or offer fresh perspectives; editions of works or documents that are of value to humanities scholars and general readers and have been either previously inaccessible or available only in inadequate editions; annotated translations into English of works that provide insight into the history, literature, philosophy, and scientific and artistic achievements of other cultures; and conferences addressing a specific set of research objectives on a topic of major significance to the humanities. OTHER FUNDING OPPORTUNITIES

ROBERT WOOD JOHNSON FOUNDATION: EVALUATING QUALITY IMPROVEMENT TRAINING PROGRAMS: Public health and health care workers have many opportunities to acquire Quality Improvement (QI) training. However, limited evidence exists about whether and how these training programs increase the ability of these individuals to successfully engage in work to improve health and health care. Information about the impact of such programs on organizational culture and patient outcomes is also scarce.
