#### SUMMER ENROLLMENT STILL UP

Enrollment for the second summer session at I.U. is up 9 per cent over the similar period last year.

<u>Preliminary figures released by Registrar M.D. Scherer show 25,491 students are currently attending summer classes on I.U.'s eight campuses</u>—in Bloomington, Indianapolis, South Bend, Gary, Fort Wayne, New Albany, Kokomo, and Richmond.

I.U. Bloomington reports the largest second session enrollment with 9,323, up 224 (2.5 per cent) over last year.

The Indianapolis campus reports 5,834 students, an increase of 749 (14.7 per cent).

<u>Largest percentage increase is reported at Richmond</u>, which has 644 second session students, up 39 per cent (181 students).

Due to variations in scheduling among the I.U. campuses, the final official tabulation of all summer enrollment for both regular and intensive sessions cannot be made until August, Scherer explained.

Dr. Robert D. Richey, I.U. director of summer sessions and dean of continuing studies, said he was very pleased to see the increase in enrollments continue: "While this may be partially attributable to the scarce job market--with those who cannot find the jobs they want deciding to attend classes--it is also a response to the flexibility of our summer schedules and encouragement by faculty members who have urged students to make good use of the summer as a time for study."

### BAXTER NAMED TO SPECIAL POST

Robert R. Baxter, Indianapolis real estate executive and an active supporter of Riley Hospital, has been named to the new position of special assistant to I.U. Vice-President Glenn W. Irwin, Jr. His duties will involve development of the Indianapolis campus, with emphasis on co-operation with private firms interested in constructing or operating facilities on the campus.

Proposals for private investment will follow conditions approved by the trustees of Indiana University. In general, these policies anticipate land use through lease, which will conform to campus plans and insure equitable benefits to the university.

"We are fortunate that Bob Baxter has accepted this post," Dr. Irwin said. "His professional experience and his commitment to our programs are an ideal combination for this challenging assignment."

Baxter has headed his own real estate firm in Indianapolis. He is a member of the board of governors of the Riley Memorial Association. For the last three years, he has been chairman of the Bradford Woods advisory board, helping design and implement a master plan for development of the I.U. recreation area near Martinsville, including Camp Riley for Handicapped Children.

Baxter is a trustee of Indiana Central University and Hanover College. He also is active in Boy Scout work, serving as president of the Crossroads of America Council in Central Indiana for the last two years.

## TRUSTEES APPROVE GENERAL HOSPITAL CONTRACT

Trustees of Indiana University have accepted a contract for management of health and professional medical services at Marion County General Hospital and the Regenstrief Health Center.

The agreement with the Marion County Health and Hospital Corporation is contingent upon contract stipulations which require adequate funding support by the corporation and payment for services to assure the hospital can be maintained as an effective service, educational, and research unit of the I.U. Medical Center. The fee to be paid to the university for providing management services is to be applied to the operation of the hospital.

By virtue of the contract--which initially applies to a two-year trial period--I.U. is to be responsible for over-all professional services and professional administration of the hospital and center. The corporation would retain full accountability for all fiscal and legal aspects of the operation, as well as administration of patient admissions and remodeling, repair and maintenance of buildings and facilities.

Noting the long/affiliation between the school and the hospital, School of Medicine Dean Steven C. Beering said the contract would formalize what has been a relatively informal fiscal and administrative relationship. "It is a management agreement typical of a significant number of such contracts between university-based medical schools and their major affiliated city-county teaching hospitals," Dean Beering stated.

The relationship between the medical school and hospital extends from the early 1900's. Recent developments which strengthened the association included a 1969 agreement giving the medical school responsibility for hospital-based education in undergraduate, graduate, and continuing education spheres, and encouraging research ventures. In 1971, I.U. and the corporation agreed to jointly manage the Regenstrief Center. In 1974, the Indiana General Assembly appropriated \$1-million for I.U. equipment, which was placed in the center.

University officials stressed that the closer co-operation which will result from the agreement should produce better health professional services for General Hospital and the entire Medical Center.
