NEW PARKING REGULATIONS GO INTO EFFECT SEPTEMBER 1

The IU-PUI Parking Committee has worked long and diligently to develop an improved program. The revised policies and procedures have been adopted after considerable study and discussion. To assure efficient and equitable operation, however, co-operation will be essential. Everyone who drives and parks on the campuses has a responsibility to help make the new program effective. We will continue to study the complex problems associated with traffic and parking on our campuses, and we will make further improvements and add more facilities as funds become available. We also expect to continue to offer free parking, in addition to space for which graduated fees will be charged.

The parking program for all of IU-PUI will begin on September 1 with these important features:

1 -- All existing parking decals will expire on September 1 and will be replaced with a new series of decals. Application blanks for decals are available at the Safety Department offices, 950 West Vermont Street and 1160 Fairfield Avenue (38th Street Campus), the Personnel Office in the Administration Building at the Medical Center and in the offices of the Deans, Directors and major departments.

2 -- Completely new records will be established and maintained for all personnel and students who choose to park in restricted areas. The new parking regulations will be strictly and consistently enforced. The cars of persistent violators will be towed.

3 -- A new series of car pool decals will be available for the cost of the parking decal plus \$1 for a magnetic clip-on tag so that the decal can be used for each of the cars in the pool.

4 -- The new decals must be displayed on the upper center of the windshield, NOT on the rear window.

The new program, like the old, is based on a color code system of parking areas throughout IU-PUI.

<u>Blue Parking Areas</u> -- These are restricted to cars with blue decals. The new program makes these decals available to all full-time and part-time faculty members and to a limited number of staff members: Heads of schools, departments, and divisions, and hospital interns and residents.

The blue decals cost \$6.25 a month (\$3 for part-time faculty members) and may be paid through payroll deductions.

<u>Green Parking Areas</u> -- These are restricted to cars with blue or green decals. Green decals may be purchased by a full-time or part-time faculty member or by any full-time staff member for \$3 a month (\$1.50 for part-time faculty members). The amount of salaries will no longer be a factor in determining eligibility for blue and green decals.

<u>Red Parking Areas</u> -- These areas are designated primarily for cars with the new red parking decals which are available only to full-time and part-time IU-PUI students. The costs of the red student decals is \$10 a semester for full-time students and \$5 a semester for part-time students (eight credit hours or less).

Parking in red decal areas is limited to cars with red, blue, or green decals.

Faculty and Staff members may not purchase red decals.

Orange Parking Areas -- These are free parking areas and their use is unrestricted. Any car, with or without a decal, may be parked in an orange lot.

Yellow Parking Areas -- These areas, most of them with meters, are reserved for visitors and out-patients. Faculty, staff, and students may not park in yellow areas and tickets will be issued for violations.

The large parking lot opposite the Indiana University Hospital on West Michigan Street will have a 25-cent coin-operated gate and will be open for unrestricted use by visitors, students, staff, and faculty. Cars in this lot will not need decals.

Temporary blue (\$1 a day), green (75 cents a day), and red (50 cents a day) permits will be available for qualified persons, such as visitors attending conferences or seminars. There will be a parking assessment included in the fee for non-credit continuing education courses.

<u>A progressive rate of parking fines will be strictly enforced</u>: \$3 for the first violation, \$5 for the second, and \$10 for the third and subsequent violations in each 12-month period.

If a student or member of the staff or faculty fails to pay a fine, his decal will be revoked. The revocation will cover any car driven by the student or faculty or staff member and will cover all university property, including the orange parking areas. If the parking privileges are revoked and the car is found on university property, it will be towed and stored at the owner's risk and expense.

Written appeals of tickets, fines, and penalties should be sent to the Safety Department. The appeals will be reviewed within 30 days by a student-staff-faculty appeals committee appointed by the Chancellor. Appeals should be written and submitted within five days after.the ticket is issued. The new regulations have been developed by an IU-PUI Parking Committee which has met under the chairmanship of Dr. Robert L. Bogan, assistant dean, School of Dentistry. Committee members represent administrative, clerical and service staff, faculty and students: Ronald F. Bryant, Department of Safety; C. Duane Gaither, School of Medicine; Dr. Robert V. Kirch, Downtown Campus; Arthur D. Lautzenheiser, Business Manager; Robert Meier, Downtown Campus; Donald E. Smith, Hospital Administration; Douglas C. Smith, 38th Street Campus; Dr. Robert Samuels, 38th Street Campus; Dr. Robert H. Shellhamer, Department of Anatomy; Mrs. Alice M. Taylor, 38th Street Campus; Dr. Violet E. Tennant, Graduate School of Social Service; Professor Jeremy S. Williams, Law School; and Roy W. Woodall, Power Plant.

The new regulations are the first step in the committee's program to develop a consistent and comprehensive parking program for IU-PUI.

The committee will make recommendations concerning changes in regulations as the parking needs change, designation of new parking areas and changes in the designations of existing areas, and make plans and recommendations for new parking facilities, including parking garages for which the General Assembly has authorized revenue bonds.

If you have comments, suggestions, or complaints concerning parking policies, send them to your representative on the IU-PUI Parking Committee. For specific questions about the existing policy, contact the Safety Department.

New maps showing all blue, green, red, orange, and yellow parking areas will be distributed to all faculty and staff members before September 1. Included with the regulations and map will be your registration form, including request for payroll deduction. Upon completion and return to the Safety Department, your decal will be sent to you through campus mail. Early application will insure early processing and worry-free parking.

## IUPUI MOTOR VEHICLE REGULATIONS EFFECTIVE SEPTEMBER 1, 1971

## The following regulations, as from time to time may be amended, govern the driving and parking of motor vehicles on IUPUI property at all times of the calendar year including examination and vacation periods:

1 -- Indiana state laws governing the movement, operation, and parking of motor vehicles shall apply on University property.

2 -- The speed limit for motor vehicles on University property shall be 20 miles per hour at all times.

3 -- Pedestrians shall have the right-of-way at designated crosswalks at all times except at signal-controlled intersections, where pedestrians and vehicles shall comply with the signal.

4 -- Motorbikes, motorcycles, and motor scooters must be operated only on streets designated for normal automobile use.

5 -- Any accident involving a motor vehicle on University property must be reported to the Safety Department at the earliest possible moment (telephone 264-7971). 6 -- Parking of motor vehicles on University property is to be confined to areas designated for that purpose. Parking is prohibited on grass plots, construction areas, or any other place which will mar the landscape of the campus, inconvenience or endanger anyone, create a hazard, or interfere with the use of University facilities by others.

7 -- Parking is prohibited at all bading and service vehicle docks and zones, entrances to buildings, and at any location where curbs are painted yellow.

8 -- The responsibility for finding a legal parking space rests with the motor vehicle owner.

9 -- The person in whose name a vehicle is registered at IUPUI is responsible for any violations involving that vehicle.

10 -- Parking areas marked "Visitor Parking" are not to be used by students, faculty, or staff.

11 -- Any vehicle in violation of parking regulations or apparently abandoned may be towed away without notice and stored at the owner's expense.

12 -- IUPUI will honor Faculty and Staff parking decals issued by the Bloomington Campus and Bloomington will honor IUPUI decals for like color-coded parking areas. (Blue for Blue Areas, Green for Green Areas.) The same will apply to the various campuses of Indiana University and Purdue University where similar parking programs are in force.

13 -- Vehicles shall not back into parking spaces.

14 -- Hours of enforcement of parking regulations shall be 8 a.m. to 9 p.m., Monday through Friday.
