
While Dr. Timothy O'Leary kept **Dr. Roland W. Dykema** occupied elsewhere, members of the Department of Prosthodontics went into action, turning the newly remodeled Graduate Prosthodontics Laboratory into an impromptu lunch buffet on April 6. The unsuspecting director of graduate prosthodontics was then summoned to the lab, where a host of colleagues, friends, students and staff were on hand for the surprise dedication of the **Roland W. Dykema Graduate Prosthodontics Laboratory**. On behalf of the **John F. Johnston Society** and the School of Dentistry, Dr. Charles Goodacre, associate professor and chairman of prosthodontics, presented Dr. Dykema with a plaque bearing his name that will be placed on the wall outside the laboratory. "There is no one who has done more to promote graduate prosthodontics than Dr. Dykema," Dr. Goodacre said during the brief ceremony.

The new laboratory seats 19 students, with the bench area separate from a wet lab and a room for ceramic and porcelain work. Each unit is equipped with an air-driven high and low-speed handpiece, as well as a belt-driven slow-speed handpiece. The laboratory has color-corrected lighting and twice the amount of storage as in the old laboratory. Remodeling also included installation of a new ventilation system and a positive air pressure system in the ceramics area to prevent contamination by metallic particles from other parts of the lab.


An extensive writer and lecturer in the field of prosthodontics, Dr. Dykema was president of the American Board of Prosthodontics in 1982-83. He has been on the IUSD faculty since 1948.

1987 IUSD Spring Teaching Conference

A flu bug forced Dr. Chris Miller, head of the IUSD Teaching Committee, to remain home in bed, and a touch of laryngitis prevented Dr. Beverly Hill, one of the program speakers, from speaking--but that didn't stop the Teaching Committee from producing yet another outstanding Spring Teaching Conference for the dental school faculty. The day-long meeting, held in March at the Indianapolis Holiday Inn-North, was the sixth of its kind. (There have been 22 annual teaching conferences in the fall, but spring interim programs, offered from 1971-1974, did not start up again until 1986.) This year **Prof. Charles J. Palenik** pinch-hit for the ailing Dr. Miller, welcoming Conference participants and introducing others on the program, including featured speaker **Dr. Karen E. Gable**, coordinator of health occupations education for the IU School of Education. She offered a stimulating presentation entitled: REFLECTIONS FROM THE TEACHING MIRROR (OR ANYONE YOU RECOGNIZE?). **Mr. Mark Stahl** represented the IU School of Medicine Medical Educational Resources Program and its director, Dr. Beverly Hill. He outlined a service offered by MERP for evaluating teaching skills and increasing instructional effectiveness.

Dean H. William Gilmore provided an overview of School activities, and the following faculty members brought Conference participants up to date on a variety of topics: Dr. Robert L. Bogan, associate dean for student affairs (speaking on admissions and recruitment); Prof. Charles J. Palenik, head of committees for infection control and table clinics (hepatitis vaccination program and table clinics); and Dr. George K. Stookey, director of the Oral Health Research Institute (animal research facilities).

Two people playing a big part in the success of this year's Conference were Ms. Drew Beck, long-time secretary-treasurer who was on hand to provide her usual expertise in coordinating numerous activities and schedules; and Dr. Leonard Koerber, who provided audiovisual assistance.

Dr. Garner Cited for Leadership and Achievement

Dr. LaForrest D. Garner, chairman and professor of orthodontics, was among those honored at the seventh annual Minority Business and Professional Achievers Recognition Awards Dinner, presented in Indianapolis by the Center for Leadership Development, Inc., in cooperation with the Indianapolis Chamber of Commerce. Dr. Garner received the award for Achievement in Professions, one of 12 categories recognized during ceremonies held on March 23 at the Indiana Convention Center. The award was presented to him by Michael Carroll, vice president of community affairs for Lilly Endowment, Inc.

People In the News

Dr. Carl J. Andres, associate professor of prosthodontics, and **Dr. Suteera Hovijitra**, associate professor of prosthodontics, were inducted as associate members into the American Academy of Crown and Bridge during the Academy's annual meeting in Chicago.

Dr. Samuel Campbell, staff oral surgeon at the Veterans Administration Medical Center and assistant professor of oral and maxillofacial surgery at the School of Dentistry, is the recipient of the 1987 "HANDS AND HEART AWARD." This award is given annually to recognize and pay high tribute to the outstanding employee at the VA Medical Center who consistently demonstrates professional expertise and provides emotional support, help and guidance to patients above and beyond the call of duty.

Dr. Anoop Sondhi, associate professor of orthodontics, was named president of the Indiana Society of Orthodontists at the annual meeting in Fort Wayne in March.

Dr. Ralph W. Phillips, associate dean for research and research professor of dental materials, was recently in Halifax, Nova Scotia, to chair a site visit committee appointed by the Medical Research Council of Canada to study a \$1½ million grant proposal from Dalhousie University. Other members of the committee, all Canadians, represented disciplines in toxicity, pathology and engineering. Dr. Phillips also presented the Annual Dean Jones Lecture at the University of Washington in Seattle on March 30th. The all-day lecture was the 16th in a series honoring the first dean of the School of Dentistry at the University of Washington. In the evening Dr. Phillips was guest of honor at a dinner given by the President of the University of Washington.

Dr. Rosario H. Potter, professor of oral facial genetics and director of dental biometry and research computing at the School of Dentistry, recently served in the special study section of the National Institutes of Health for the merit review of research grants in Washington, D.C.

Dean's Message

As downsizing of dental schools throughout the country continues, IUSD will also have fewer students, but we anticipate a stable enrollment compared to many other schools. Our smaller classes will finally make it possible for us to vacate the laboratory in the Medical Science building next fall. Room SB05 in the dental school is being divided into separate labs for first and second year classes. The wet lab will be adjusted to accommodate both groups at once, as well as third and fourth year students working on their own. A partition will separate the labs, and televisions and bench equipment will be upgraded. Members of the operative dentistry faculty relocated by the move will be given office space near the facility. The new laboratory layout should help to consolidate preclinical instruction.

As the school year winds down, clinical productivity of third and fourth year students remains above average and fourth year practical examinations are nearly completed. The registry continues to aid students and faculty in identifying and working out scheduling problems and avoiding patient cancellations. In an effort to achieve a continuity of dental treatment, clinics will not close this summer.

I am pleased to announce the appointment of **Dr. Dwight C. Swimley** as new director of the undergraduate program in the Department of Oral and Maxillofacial Surgery, effective in August. Dr. Swimley comes to IU after a distinguished teaching and research career in the U.S. Air Force. He is currently chairman and program director of the Department of Oral and Maxillofacial Surgery on the USAF Medical Center at Lackland Air Force Base, Texas. After 17 years of outstanding service as a full-time faculty member, **Dr. James H. Dirlam**, professor of oral and maxillofacial surgery, retires as head of the undergraduate program in May and will continue teaching in the department on a part-time basis.

I am also pleased to announce the following faculty promotions, effective July 1: **Dr. Larry L. Graham**, professor of oral and maxillofacial surgery; **Dr. Kenneth J. Spolnik**, associate professor of endodontics; **Dr. Timothy J. Carlson**, associate professor of operative dentistry; **Dr. Mark E. Mallatt**, associate professor of preventive dentistry; **Dr. Susan L. Zunt**, associate professor of oral pathology; and **Dr. Charles L. Nelson**, associate professor of oral and maxillofacial surgery.

Remodeling will soon be completed in the admitting area of dental diagnostic sciences, the special care clinic and the graduate prosthodontics laboratory. The new University Dental Service Plan faculty practice facility is now open, offering a full-range of dental services.

Private consultants visited the School recently to evaluate patient services and the teaching missions of the major departments. They recommended a self-study to identify and eliminate sources of problems that block efficient patient flow. An increased patient pool will be needed to meet future curriculum requirements. The top priority is to provide professional, high quality treatment for the School's patients. While these exigent times in dental education have made it impractical for some dental schools to remain open, our school will be a quality survivor, heading into the 1990s fortified with a unique strategy created by the faculty and administration. The IU School of Dentistry remains a valuable Indiana resource.

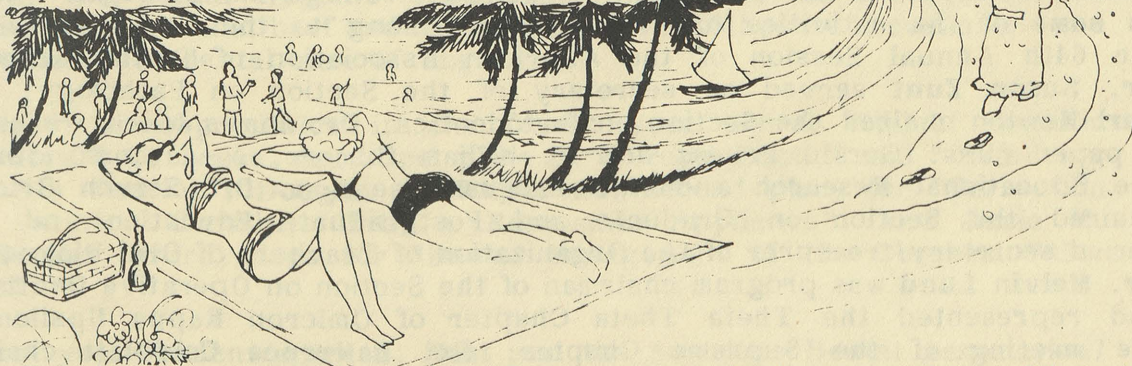
**The 18-Hour...

Bahamian Holiday**

Stark white sands...a bevy of boats...an azure sky paling only in comparison to the even more vibrant blue of the Atlantic ocean. Mix these sights with the muffled sounds of lapping waves, murmurings of beach-goers with a British lilt to their voices, and island music drifting on a warm breeze, and you have the perfect daydream to shake the chill out of February in Indiana. Another Success Story: IUSD Table Clinic Day

Visitors to the School cafeteria looking for a snack on March 23 found instead a feast--of information, that is, on a wide range of topics pertaining to dentistry and presented with enthusiasm and style by 69 IUSD students of dentistry, dental hygiene and dental assisting at the annual Table Clinic Day. This year's clinics, 32 in all, were well attended by faculty, students and staff who were given the opportunity to learn, for instance, that a hollow pontic can save 4.5 dwt in gold and \$97 in fees for a dental patient; that pit and fissure sealants are now being placed in the dental hygiene department under the supervision of Dr. Sybil Niemann; and that beef and chicken-flavored toothpaste is available--and recommended--for dental care of dogs.

Award winning clinics in the fourth year dental student division were: **Gerald C. Leake, Jr.**, first place for "Trojan Pontic" and "Distalizing Molars with Elastics"; **Douglas G. Whitehead**, second place for "Correction of an Anterior Crossbite With a Removable Appliance"; and **Jamie M. Roach-Decker**, third place for "Dental Management of the Cerebral Palsy Patient."

First year student **April L. West** won the American Dental Association/Dentsply Student Clinician Travel Award for her presentation entitled "Mirage Porcelain Inlay." She will be awarded a plaque by a representative of the Dentsply Corporation at the next IUSD Faculty Council meeting. Ms. West will present her table clinic at the Annual Session of the Indiana Dental Association on May 2 and at the ADA Annual Session in Las Vegas, Nevada, next fall.

Second year student **Steven F. Rodgers** was named runner-up in the ADA/Dentsply competition for his clinic entitled "The Ability of Various Dyes to Stain Dentin In Vitro." He receives \$25 from the Indiana Section of the American Association for Dental Research. Winners of the table clinics for dental assisting and dental hygiene will be announced during graduation ceremonies.

Dr. Warren Blair Zurich-Bound

He has spent the past seven years at Indiana University, first as a predoctoral student and then as a graduate student in periodontics. But next fall Dr. Warren Blair will be trading his Hoosier landscape for one a bit more hilly--and he'll be bidding us "auf Wiedersehen" instead of good-bye. Dr. Blair has been appointed "postdoktorand" and scientific assistant at the Dental Institute of the University of Zurich in Switzerland. He will assume the post in September after completing requirements for the MSD degree at Indiana this summer.

Dr. Blair's new job in Zurich sounds far away to most of us, but it's actually much closer to his hometown. The son of an American businessman located in Stuttgart, Germany, Dr. Blair will be only a two-hour drive from his folks and the place where he grew up. Language will pose no problem at Zurich for Dr. Blair, who has spoken both English and German since childhood.

Dr. Blair will be on the faculty in the Department of Cariology, Periodontology, and Preventive Dental Medicine. He has learned that ties to Indiana are far-reaching: The head of that department is Dr. Felix Lutz, who completed a two-year sabbatical in the IUSD Department of Dental Materials in 1983.

Not a New Face...Just a New Place

The School of Dentistry extends a "Welcome Back" to Dr. Christianne Guba, a former part-time faculty member in dental practice administration who has recently been reappointed to the faculty in a full-time position as assistant professor of operative dentistry.

Roots

The School of Dentistry lost one of its greatest supporters and friends with the death of Dr. Jack D. Carr last December 31. Dr. Carr was well known for his contributions to the School as a faculty member in the department of radiology from 1952 until his retirement in 1984, and for his coverage of school, alumni and dental association events as a photographer, but some may not be aware of yet another significant role Dr. Carr fulfilled as School historian.

Of major import to the School's historical records is the Master's thesis Dr. Carr wrote in 1957 while he was studying at Butler University. Entitled "History of the Indiana Dental College," the manuscript chronicles events from 1879 to 1925, providing a valuable and often fascinating account of activities pertaining to the dental college prior to its affiliation with Indiana University.

Details abound in the pages of this document (available in the library), and it is a must-read for all School of Dentistry nostalgia buffs. A glimpse into Dr. Carr's thesis--and into our past--follows:

- . The privately owned Indiana Dental College was founded in 1879, the 19th dental school to be established in the country and the 13th still in existence at the time.
- . Original rooms housing the dental college were located at 147 East Market Street and owned by James A. Roosevelt, of New York, father of future president of the United States, Franklin D. Roosevelt. Rent was \$20.84 per month.
- . The school term lasted from October to March, and a full dental education consisted of two terms. In the first year six men made up the student population.
- . Students were charged \$5 for each lecture course, 50¢ for gold fillings up to two grains and 25¢ for each additional grain.
- . In the beginning, most of the faculty served without pay (all appointments were part time).
- . Three students graduated in the first Class of 1880.
- . "Lady" students were invited to attend the college in its second year and were assured that special facilities in physiology and anatomy classes would be afforded them.
- . In 1881 Dr. Phineas G.C. Hunt was the first to be named dean. (Prior to this the board of trustees looked after such administrative responsibilities.) Dr. Hunt was also first president of the Indiana State Board of Dental Examiners (those were the days when one person could serve in both capacities at the same time).
- . Within a couple of years, the College moved to Pennsylvania and Court Streets.
- . In 1883 a custodian was hired for \$35 per month, more than some faculty members were earning.

- . Shortly after the first electric street lights were installed in Indianapolis in 1886 (including one on the Circle that was placed on a pole 153 feet high), electrical appliances were listed among equipment at the College.
- . Exactly 100 years ago, the Indiana legislature passed a law requiring all dentists to register with the State Board of Dental Examiners (a law not strictly enforced at first).
- . In the mid-1880s the first full-time faculty position was created: Chairman of Clinical Dentistry. Dr. Ernest Reese filled the position at \$500 a year.
- . A note in the 1890-91 College Announcements says: "Both Pennsylvania and Court Streets having been recently paved with asphalt, the annoyance of vehicles clattering over bouldered streets has been entirely done away with."
- . It was suggested during a board of trustees meeting in 1891 that the College purchase caps and gowns to loan to the students so that no graduate need be ashamed of his clothes at commencement.
- . In 1891 faculty member Dr. J.N. Hurty was paid \$434 for presenting 72 lectures.
- . By 1892 requirements for graduation were still general enough so that some students graduated without having placed even one filling in a patient's mouth.
- . In 1894 the College moved again, this time to the southwest corner of Delaware and Ohio Streets.
- . The first fraternity, Xi Psi Phi, appeared in 1896.
- . A rival dental school cropped up in the city in 1897. The Central College of Dentistry survived until 1905.
- . The first woman lecturer was hired in 1908: Dr. Alice Harvie Duden, whose subject was oral prophylaxis.
- . In 1910 the College organized a successful football team, which gave way a few years later to a basketball team known as the "Dents."
- . Another move took place in 1914 to a building on North and Meridian Streets that formerly housed an automobile tire company.
- . The ever-mobile dental college relocated to Walnut and Pennsylvania in 1920, the last move before West Michigan Street.
- . In 1920 a popular student pastime--crap shooting--was prohibited during school hours.
- . The State of Indiana bought the Indiana Dental College for \$35,000 in 1925, and Indiana University assumed ownership.
