Direktor Rath berichtete, daß der Unterricht in

werde; Lieut. Scott, der ihn übernommen sollte,

war daran verhindert und es wurde kein Versuch

gemacht, Ersatz zu finden, weil die Klasse nur

zwei Männer enthält.

Wegen der Influenza – Epidemie ist die Schule zur

Zeit geschlossen, doch ist bisher nur ein Krankheits-

fall unter Seminaristinnen zu verzeichnen.

Die städtische Gesundheitsbehörde gestattete die Fort-

setzung des Unterrichts im Freien. Bei gutem

Wetter werden Volksturnen und andere Uebungen

in Willard Park durchgenommen.

Die folgenden Seminaristen verließen nach  
zweiwöchigem Besuch die Anstalt, um in Students'  
Training Camps einzutreten: Schmidt, Seelbach,  
Fischer. Ferner traten Frl. Carr und Frl. Ashbaugh  
aus. Frl. Goldie Howard wurde der Eintritt  
nachträglich gestattet. Die Klasse besteht jetzt aus  
54 Damen und zwei Männern.

Hierauf Vertagung.

Meeting on October 19, 1918.

Present: Frankling Vonnegut, Scherer, Rath, Pantzer, Stempfel, George Vonnegut, Lieber, and Westing.

Dean Rath reported that the military exercises classes will be suspended temporarily.

Lieut. Scott who was supposed to take over the classes was unable to do it after all and no effort was made to find a replacement because the class consist only of two men.

Due to the influenza epidemic, the Seminary is currently closed although, at this point, only one female student has been reported ill. The city healthcare authority allowed continuing the classes outdoors. Athletics and other exercises will be conducted in Willard Park by good weather.

The following students left the Seminary after two weeks' time so they can enter Students Training Camps: Schmidt, Seelbach and Fischer. In addition, Ms. Carr and Ms. Ashbaugh left the Seminary. Ms. Goldie Howard was accepted in the Seminary belatedly. Currently, the class consists of 54 women and 2 men.

The Athletic Committee was re-structured as follows: Chair, Emil Rath; Secretary: Hans Reuter; Treasurer: Ella Williams; Affiliates: G. H. Westing, Mildred Jost, Kate R. Steichmann and Geo. W. Lipps. The committee decided to try and organize competitions with the women's teams from other colleges.

Dean Rath read an invitation to a conference of college representatives of Indiana initiated by Indiana University President Bryan on October 21 in the Columbia Club. The topic is discussion of the colleges' participation in the United War Work campaign. Dr. Pantzer moved to have Rath represent the Seminary. Motion granted.

Wm. R. Chapman applied for a gymnastic teacher diploma. Based on communications about his behavior since leaving the Seminary, the Board of Trustees decided to notify Chapman that he cannot obtain a diploma and that the Board of Trustees considers this matter closed.
