## UNCLE SAM AND YOU

"The Draft, The Law and You" will be the subject of a panel discussion Wednesday sponsored by the Indianapolis Law School. The 7:30 p.m. program will be presented in Room 101 of the Lecture Hall Building at the new Downtown Campus.

All IUPUI students, faculty and staff and other interested persons are invited to attend the discussion based on the national theme -- "Channel Change through Law and Reason"-- adopted this year by the American Bar Association. There is no admission charge.

Panel members will be Professor Robert Allen Sedler of the University of Kentucky law faculty, Professor Edward F. Sherman of the I.U. (Bloomington) law faculty, Father Bernard Survil, chairman of the board of directors of the Indianapolis Area Draft-G.I. Center, and Colonel Wayne E. Rhodes, Indiana state director of Selective Service. Richard K. Levi, president of the Indianapolis Law School Student Bar Association, will moderate the discussion.

Professor Sedler has taught at Kentucky since 1966. Prior to that he was associate professor of law and assistant dean at Haile Selassie University, Addis Ababa, Ethiopia, and associate professor of law at St. Louis University. A director of the Kentucky affiliate of the American Civil Liberties Union, he is quite active in civil rights and draft litigation. He recently carried a successful appeal of a draft conviction to the Supreme Court of the United States in the case of Mulloy v. United States.

His presentation will be based on a recently completed article scheduled for fall publication in the University of Iowa Law Review, "The Procedural Defense in Selective Service Prosecutions - The View From With-out and With-in."

Before coming to I.U. in 1969, Professor Sherman was a teaching fellow at Harvard for two years, a captain in the U.S. Army Military Police Corps, and practiced law in Texas. He is a captain in the Judge Advocate General's Corps, U.S. Army Reserve, and has taught courses in military law at the Judge Advocate General's School and I.U. School of Law.

Professor Sherman has been a participating attorney, American Civil Liberties Union since 1967. He has been active in draft counseling at both Harvard and Indiana.

Father Survil, as a representative of the Social Action Committee of the Priests' Association of the Archdiocese of Indianapolis, serves on the Governing Board of the Draft - G.I. Center. Working with the Social Action Committee which has been implementing a general resolution of the Association "to cooperate with other interested groups in the establishing of a Draft Counseling Center," he has been meeting with various Roman Catholic parish organizations seeking financial support for the center.



Colonel Rhodes is a graduate of Purdue University. He was a high school coach, teacher, and administrator before being called to active duty in 1942. His service includes overseas assignments in the Middle East, North Africa, Sicily, and Europe. He was awarded the Bronze Star, Distinguished Unit Citation with two Oak Leaf Clusters and Seven Campaign Stars. He has served as state Selective Service director twice, from February 1, 1957 through June 1961 and again from March 1969 to the present.

Levi, a 1967 graduate of I.U. (Bloomington), currently is an evening division student at the Indianapolis Law School and expects to receive his doctor of jurisprudence degree in June.

## 21 ACHIEVE FULL PROFESSOR RANK

Twenty-one IUPUI faculty members have been promoted to the rank of full professor, Chancellor Maynard K. Hine announced recently.

In addition, 55 faculty members were promoted to the rank of associate professor and 28 were promoted to assistant professor. The promotions become effective July 1.

The new full professors at IUPUI include 12 at the School of Medicine, four at the School of Nursing, two at the Downtown Campus, two at the 38th Street Campus, and one at the Indianapolis Law School.

At the School of Medicine, they are Dr. William McD. Armstrong, Dr. Norman H. Bell, Dr. Harvey Feigenbaum, Dr. Joseph A. Fitzgerald, Dr. Julius J. Friedman, Dr. Donald A. Girod, Dr. Oscar M. Helmer, Dr. Thomas Horwitz, Dr. Ralph A. Jersild, Dr. Robert D. King, Dr. Thomas C. Lloyd Jr., and Dr. Joseph Zimmerman.

Those promoted from associate to full professor at the School of Nursing are Dr. Kathryn M. Bearss, Dr. Lucy C. Perry, Dr. Lauranne Sams, and Miss Jean E. Schweer; Dr. James R. East and Dr. Robert W. Greenleaf at the Downtown Campus and Dr. Monte E. Juillerat and Dr. Abraham M. Max at 38th Street. Dr. James E. Beaver at the Indianapolis Law School also will assume the rank of full professor on July 1.
