Minutes of the 9/1/06 meeting were distributed.

Conversation with Dean Sukhatme

Since the Town Hall meetings on the Academic Action Plan occurred the previous day and the following Monday, Dean Sukhatme made a few opening remarks about the Action Plan and asked for questions so that he could engage in a conversation with the APPC. (The following is a brief synopsis.)

Question--Does the current focus on attracting better students to enhance retention conflict with our historic mission to serve the community which can mean enrolling less well prepared students?

Response--Access is very important. The initial advising is a critical element in helping the student to make good decisions about course selection. If students need more than 1-2 semesters of remediation, the outcome will not be good and the student should be referred to Ivy Tech.

Remediation courses should be available in the summer to prepare the students for fall courses. An enhanced Bridge program will help the students gain necessary skills for success. Early monitoring of student performance within the first 2-3 weeks is important. If the student is not going to be successful, there should be ½ semester courses that will address the students' deficiencies. It is not beneficial for the student to try to retake the same course without remediation.

Question--Focusing on adult and returning students, how should we serve them, particularly those who are not well prepared?

Response--The ½ semester preparation courses may be advantageous in helping the adult and returning students. We want adult and returning students to be well served as our traditional aged students. We can look at degree completion initiatives at the outlying service centers so that students don't have to come downtown in the evenings. (It was noted that James Johnson is working on developing degree completion programs in an accelerated format and Dean Sukhatme suggested at this become an Action Item for the Academic Plan.)

General comments from the group—

- We will need to consider the policy issues in developing the concept of students switching courses within a semester.
- Students with deficiencies may not be able to attend a Bridge Program because they are working during the summer. We need to look at additional financial solutions including institutional need based aid.
- We need to address financial literacy to assist the students in making better decisions and address the cultural/generational basis for their decision making.
- We need to have a service focus in dealing with our students.

Announcements from the Chair

- October 22 = Fall Campus Day with both an Undergraduate and Graduate student recruitment focus
- Update on STAC's development of the Course Transfer Library and statewide articulation agreements for 12 degrees
 - 88 frequently taken courses organized by CIP code were identified for possible inclusion in the legislatively mandated Core Transfer Library.
 - A STAC subcommittee is reviewing the list to determine the courses that are taught at all of the public institutions and which can be agreed upon for transfer among all the institutions.
 - The goal is to establish a list of at least 70 courses.
 - The UFC policy which limits the transfer of courses from 2 year institutions as equivalent only at the 100 and 200 level is posing problems for some courses.

- Work is continuing on the development of articulation agreements in 12 program areas
 - Criminal Justice and Nursing are completed
 - Under review by departments
 - English and Communications
 - Mathematics
 - Life and Physical Sciences
 - Humanities
 - Social and Behavior Sciences
 - Foreign Languages
 - At various stages of discussion
 - Computer Information Science
 - This is a problematic area because of the different educational outcomes for the 2 year and 4 year degrees. Suggestions are being sought for a different degree area that would be consistent with the needs of Indiana and more amenable for transfer from 2 year institutions.
 - Manufacturing and Industrial Technology
 - Business
 - Education

Academic Affairs Committee Report *Betty Jones, Chair*

- Betty Jones was not able to attend.
- Rick Ward provided an update on the work of the Undergraduate Curriculum Committee.
 - Originally the outcome of the work on General Education was to have one curricula for all campuses. Currently the work is focused on developing a Gen Ed curriculum for each campus. The UCC has looked at the Core Transfer Library list and identified several courses that fulfill the Gen Ed requirements of all the IUPUI academic units.
 - The Gen Ed plan is to be presented to IFC in November and completed in February.
