## **FEATURE STORY**

#### Lilly Endowment Awards \$6.6 million to Support IU Public Policy Institute

The Indiana University Foundation has received a \$6.6 million grant from Lilly Endowment to support the work of the Indiana University Public Policy Institute (PPI). "This generous funding is a vote of confidence in the Institute's ability to continue its good work in the future, which Lilly Endowment has supported for 20 years," said John L. Krauss, director of PPI.

PPI is housed within the Indiana University School of Public and Environmental Affairs at Indiana University-Purdue University Indianapolis. PPI will use this grant to launch a fundraising campaign to sustain PPI for years to come, Krauss noted.

"Once again Lilly Endowment has demonstrated its strong support for Indiana University and the people of Indiana with this grant to the Public Policy Institute," Indiana University President Michael A. McRobbie said. "This latest example of the endowment's remarkable generosity will strengthen PPI's mission to carry out vital research on a range of community and public policy issues that affect the lives of Hoosiers every day."

"Lilly Endowment has supported our efforts since 1992, when the Endowment funded the newly formed Center for Urban Policy and the Environment (CUPE)," Krauss said. CUPE's research included government and community policy issues as well as criminal justice, public safety and environmental issues. The topics ranged from land use to teepage drivers

environmental issues. The topics ranged from land use to teenage drivers, economic development to gun violence, gaming to intergovernmental cooperation, and housing concerns to nonprofit organizations. As CUPE grew, a second center—the Center for Criminal Justice Research (CCJR)—was formed to focus on criminal justice and public safety research. The Public Policy Institute was created in 2008 to be the umbrella organization over both centers. CUPE, CCJR and PPI have long been recognized for their nonpartisan, non-ideological research.

"Lilly Endowment is pleased to support the efforts of PPI and its centers to provide solid research and analysis on important issues facing Indiana policymakers," said N. Clay Robbins, president of the Endowment. "Such information is critical to the deliberations of private and public sector leaders as they strive to improve the quality of life in Indiana communities."

PPI has collaborated with many university entities statewide, including the IU law schools in Indianapolis and Bloomington, the Center on Philanthropy, and other IU and Purdue schools. PPI also supports the Indiana Advisory Commission on Intergovernmental Relations. In 2007, PPI staffed the Indiana Commission on Local Government Reform, which issued the report, "Streamlining Local Government: we've got to stop governing like this," (the Kernan-Shepard report) which continues to inform efforts in the Indiana General Assembly.

"PPI is truly a multidisciplinary, applied research institute, and PPI's work is especially beneficial to our urban campus and our central Indiana neighbors," said IUPUI Chancellor Charles R. Bantz.

# Faculty Innovator's Guide to Technology Transfer offers Blueprint for Entrepreneurship, Commercialization

The Indiana Clinical and Translational Sciences Institute, <u>Indiana University</u> <u>Research and Technology Corp.</u> and IU School of Medicine have released a new guide to assist research faculty in navigating the complicated waters of technology transfer, intellectual disclosure and commercialization.

"The Faculty Innovator's Guide to Technology Transfer" was developed by Mervin Yoder, M.D., associate director for entrepreneurship at the Indiana CTSI and assistant dean for entrepreneurial research at the IU School of Medicine. The 20-plus page publication is one of several efforts that aim to turn up the dial on entrepreneurship at the three institutions that comprise the Indiana CTSI – IU, Purdue University and University of Notre Dame.

"When you join the faculty as a researcher, everyone knows you're expected to make discoveries, publish papers and earn grants," said Dr. Yoder, who also serves as director of the <u>Herman B Wells Center for Pediatrics Research</u> at the IU School of Medicine and founder of <u>EndGenitor</u>

Technologies, a biotech company in Indianapolis. "What nobody really talks to you about is technology transfer. Going forward, I want to make sure all new faculty receive this guide so they're aware of all the opportunities available to them to be successful."

With topics that range from a review of the technology transfer and patent IU School of Medicine processes to considerations for a start-up company, the "Faculty Innovator's Guide to Technology Transfer" serves as a straightforward "how to" for faculty who want to transform their ideas into a new company or other commercial opportunity. The guide will be distributed widely among faculty, as well as given to all new investigators when they join the university.

"The 'innovator's guide' provides to investigator at all levels a step-by-step introduction to many challenges associated with commercialization of novel discoveries, which is a key focus of the Indiana CTSI," said Anantha Shekhar, M.D., Ph.D., director of the Indiana CTSI and associate dean for translational research at the IU School of Medicine. "I congratulate Dr. Yoder; Marie Kerbeshian, Ph.D., [vice president for technology commercialization at IURTC]; and all of the people at IURTC on doing a masterful job."

As defined by the guide, technology commercialization refers to the formal licensing of technology to third parties under the guidance of professionals employed by universities, research foundations and businesses.

Other upcoming efforts to encourage the entrepreneurial spirit among faculty include a program being testpiloted at the Wells Center to submit all papers for review for potential intellectual disclosures by the IURTC prior to publication and to integrate innovation into the core curriculum by capitalizing upon opportunities presented by two master's programs in translational science and clinical research established over the past several years by the Indiana CTSI.

In addition, Dr. Yoder aims to meet personally with all new IU research faculty to talk about how thinking entrepreneurially can advance their career goals.

The gift, made by Tom and Peggy Ward of OmniSite, will create a Student Innovation Fund to help enterprising students actualize creative project ideas. "Our students' potential to accomplish great things is clear," said Dr. David Russomanno, Dean of the School of Engineering and Technology. "It is increasingly evident on a national and global scale that young people have big ideas—ideas that can very quickly develop into a powerful movement or life-altering technology. We're grateful to Tom and Peggy Ward for their continual investment in our students, and for helping them bring their ideas to life."The Student Innovation Fund will provide resources for senior design students and student organizations that have innovative, multidisciplinary and/or collaborative project ideas. The Fund will be used to purchase parts, supplies and equipment for these projects, with the eventual goal of raising additional funds to create a student innovation endowment as well.

## STUDENT SPOTLIGHT

#### **Undergraduate Student Blossoms in Scholarly Pursuits**

Lakeisha Cross, a senior majoring in Management at the Kelley School of Business, participates in both the Ronald E. McNair Postbaccalaureate Achievement Program and the Innovation-to-Enterprise Central Program. Both programs are administered through the <u>IUPUI Center for Research and Learning (CRL)</u>.

Lakeisha connected with CRL somewhat by accident, while searching IUPUI's research website. "I wanted to find a subject related to my career path so I could apply those techniques to my future," says Lakeisha, when asked what intriqued her about the possibility of doing research. "I also thought it would be great to be an author in which people could view my findings." After consulting with Dr. Kenneth Durgans, Assistant Chancellor for Diversity, Equity and Inclusion, she determined that by participating in the McNair and ITEC programs she could strengthen her research techniques, gain a better understanding of her chosen field of work, and prepare for graduate school and the work force.

Lakeisha's mentor is Dr. Barbara Flynn, Professor of Business Administration in the Kelley School of Business at IUPUI since 2005. "Dr. Flynn is the most amazing individual I have worked with," says Lakeisha. "I could not have asked for a better mentor. Dr. Flynn trusts me with the data that I collect and it feels great that someone in her position is comfortable with an undergraduate student handling an important piece of information. In addition, Dr. Flynn has inspired me in many ways and influenced my career goals."

Currently, Lakeisha is researching companies that have been involved in product recalls and how their recall strategy affects consumers' repurchase intentions. Data is gathered from IUPUI undergraduate business students and compared to undergraduate students in China. "Many companies have gone bankrupt because they were not effective in recalling a product. To prevent this, our research will help managers prepare and make effective decisions towards a firm's recall strategy."

She believes it is very important for undergraduate students to engage in research because "it helps you gain more knowledge in your field of study, and builds your reputation for becoming an expert in your field of study for the future."

Lakeisha and fellow CRL student Gabrielle Rayner recently presented at the Decision Sciences Institute 42nd Annual Meeting in Boston, Massachusetts. When asked what she took away from the conference, she said she was able to learn about the different fields in a supply chain, and her favorite session was about statistics in basketball. The conference also allowed her to network with people from all over the world, and with the help of her mentor and her expanding network she is on track to study abroad in Japan, where she will study language and fashion.

Professor Howard Giles will present on Thursday, March 22, 2012 at 5:00 PM in Scholars Hall University Place Hotel and Conference Center at 850 W. Michigan Street. The community, faculty, and students are invited to attend his presentation titled: "Crossing the Thin Blue Line: Translating Intergroup Theory into Social Action." Professor Giles is a Distinguished Professor at the University of California, Santa Barbara. He has a long history of publishing on intergroup and intergenerational communication issues and notably, he developed the "Accommodation Theory," applying the perspective to a number of everyday problems people face when they are from different cultures, have different group affiliations, or try to communicate across generations. His presentation turns to a particular group, law enforcement.

Professor Giles' selection as the IUPUI TRIP Inaugural Speaker is based on his keen ability to effectively illustrate how to translate research investigations to make evidenced-based changes in communicative behavior. #### AGENCY FOR HEALTHCARE RESEARCH AND QUALITY (AHRQ)

<u>Building the Science of Public Reporting (R21)</u>: This research initiative seeks to fill three major gaps in the public reporting evidence base in order to:

Improve the design and presentation of public reports to meet the needs of consumers, including subgroups such as AHRQ's priority populations and Medicare and Medicaid beneficiaries. Increase consumer use and the dissemination of public reports, including subgroups such as AHRQ's priority populations and Medicare and Medicaid beneficiaries. Improve the underlying data and methodology of public reports to make them more credible, meaningful, and useful. *Application deadline is March 28, 2012.* 

#### CENTERS FOR DISEASE CONTROL

Identifying Reasons for Racial/Ethnic Disparities with Completing the HPV Vaccine Series among Adolescent Females (UO1): The applicants must address in the application's research plan all of the following three research objectives: 1. Among parents of adolescents 11-18 years of age, assess factors contributing to HPV vaccination disparities, specifically assessing factors contributing to series non-completion or not initiating the series, and determining whether reasons differ in nature or in importance by racial/ethnic groups (whites, blacks and Hispanics) or by poverty level. Applicants are expected to provide a research plan that addresses the following elements: • Description of the geographic area(s) to be included in the study including population size, racial/ethnic diversity, income level distribution, and level of urbanicity. Applicants must be able to include in their evaluation: parents from at least one racial/ethnic minority group (i.e., black or Hispanic) in addition to white parents, parents of adolescents that receive vaccinations at public clinics in addition to parents of adolescents that receive vaccinations in private provider offices. *Application deadline is March 28, 2012.* 

#### **DEPARTMENT OF DEFENSE**

Broad Agency Announcement (BAA) for the Naval Medical Research and Development Center-Frederick (NAVMEDRSCHDEVCTR-Frederick): The focus is on innovative approaches in infectious disease research, non-communicable disease research, and combat casualty care research. White papers of no more than 5 pages may be submitted at any time. A response will be provided within 90 days. Anticipated funding is 100 projects and total funding of \$100M.

#### NATIONAL INSTITUTES OF HEALTH

Biodemography of Aging (R01, R03, R21): Biodemography, the integration of demographic and biological theory and methods, provides an innovative tool for understanding the impact of aging on health and longevity. This FOA encourage applications for research combining demographic and life-science approaches for expanding the current understanding of aging/senescence, frailty and mortality. Applications should include evolutionary and life history theories as a framework for investigating individual and population-level factors that underlie changes in lifespan and healthy life expectancy, including sex and population differentials in late-life frailty and mortality. Application deadline is March 13.

Biomechanisms of Peripheral Nerve Damage by Anti-Cancer Therapy (R01, R03): The focus is on basic biologic research on damage to the peripheral nervous system instigated by pharmacologic cancer treatments, known as chemotherapy-induced peripheral neuropathy (CIPN). Application deadline: <u>Standard dates</u> apply.

#### NATIONAL SCIENCE FOUNDATION

Division of Molecular and Cellular Biosciences (MCB): The Division of Molecular and Cellular Biosciences

(MCB) supports fundamental research and related activities designed to promote understanding of complex living systems at the molecular, subcellular, and cellular levels. The Division is soliciting proposals for hypothesis-driven and discovery research and related activities in four core clusters: Biomolecular dynamics, structure, and function; Cellular processes; Genetic mechanisms; Networks and regulation. *Application deadline is May 21, 2012.*

<u>Partnerships for International Research and Education (PIRE)</u>: The primary goal of PIRE is to support high quality projects in which advances in research and education could not occur without international collaboration. PIRE seeks to catalyze a higher level of international engagement in the U.S. science and engineering community. *Application deadline is May 15, 2012.*

#### **Limited Submission Funding Opportunities:**

Many federal agencies and foundations offer grants, awards and fellowships that limit the number of applications that can come from one institution or require special handling. In order to comply with agency and foundation guidelines and increase the chances of Indiana University (IU) succeeding in such limited submissions and special handling opportunities, IU policies and procedures are in place and are utilized by the Office of the Vice Chancellor for Research and other IU research offices to facilitate internal coordination and competitions.

Individuals interested in responding to limited submission opportunities must inform the Office of the Vice Chancellor for Research about their intent to apply to a given limited submission opportunity, such that they can be included in the internal review and selection process. Failure to do so may disqualify individuals from consideration for submission to the funding opportunity.
