Present: Stempfel, Rath, Pantzer and Scherer.

Dean Rath reported that Anthony Tate joined the Seminary two weeks after the begin of the course and that the Administrative Office allowed him to attend classes for now. Accepted.

In addition, he reported that Dr. Edwin Kime replaced Dr. Henry as teacher of Anatomy.

Dr. Henry wrote explaining that he resigned due to work overload.

The office of teacher education (State Teacher Training Board) informed of several changes in the legal policies. Among other things, an accredited institution for teacher education must have a yearly income of \$15,000 now.

Dr. Ziegler, Kindervater and Stecher sent their responses to Williams' report and agreed to the recommendations.

Students who have not finished Chemistry and Physics in high school will take both subjects via evening classes in the der Manual Training High School a pay a fee of \$1.00 for each subject.
