II. MSW Curriculum J. Daley

III. Old Business. R. Vernon

<u>Update on MSW Direct.</u> Awaiting final approval from IBHE in Feb or March. Opening date: Sept. 5, 2012. Over 140 potential applicants on inquiries list. If approved by March, we will advertise at BPD.

IV. New Business.

BSW Curriculum- A. Tamburro

BSW Committee voted to change the title for S305 from "Child Abuse and Neglect" to "Intro to Child Protection." *Motion passed by voice vote.*

<u>Classrooms.</u> G. Folaron—fewer classrooms available in ES for SW students. M.Patchner –ideally in a new building we would have 13 new classrooms and a continuing ed center. The university is currently doing a classroom space analysis at IUPUI and gathering information on future needs. M. Patchner serves on the Campus Resource Committee that is working with a national consultant to examine space needs. Offering more online courses doesn't necessarily mean less need for oncampus classrooms. J. Daley requested consideration of space needed for practice courses to do practice simulations. We lost the practice labs we renovated in the Union Bldg.

V. Good and Welfare. Dean Patchner

<u>Self-Study</u>- Dean Patchner acknowledged contributions of all the faculty to reaccreditation and self-study work this year. Self-study materials are available for all to view on the public drive. Dean Patchner offered a special acknowledgement of G. Majewski for all of her hard work and leadership in the process. Site visits will be in Sept, Oct or Nov depending on the Chancellor's availability.

Position Changes.

- G. Majewski is stepping down from Associate Dean as of June 30, 2012. M. Patchner plans to appoint an Interim Director and initiate a national search in September.
- S. Larimer has transitioned from MSW Student Services Coordinator to Lecturer. M. Patchner introduced M. Dale as the new MSW Student Services Coordinator.
- L. Lecklider is a new visiting faculty member replacing R. Richardson who took a research position in the community.

LeAndra Ross is replacing Jennifer Vines as the Financial Aid advisor. LeAndra will be available to students two mornings per week in ES 4112.

IUNW is reviewing candidates for a faculty position.

John Gallagher has accepted the faculty position at IUSB. An offer is out for a second faculty position.

Michelle Linnis will be the new field secretary at IUPUI.

Interviews will take place on 1/30/12 for the Admin Assistant for BSW/MSW Director at IUPUI.

A position description is being drafted for a technology person to augment services provided by S. Khamis.

B. Bennett and L. McGuire are no longer "Interim."

IPFW Coordinator Search is underway. Three candidates are under consideration.

There is an available position for a tenure track faculty member to lead and coordinate field education. K. Lay played this role in the fall. Directors still would like to see the half-time position filled. If interested, please contact G. Majewski.

<u>MSW Direct.</u> D. Patchner thanked everyone involved in MSW Direct—B. Vernon, K. Khaja, P. Ouellette, D. Lynch, and S. Khamis . The Board of Trustee approval came Dec. 19th. MSW Direct will be on IBHE agenda Feb 9 or March 10th.

<u>IUSE MSW Cohort.</u> First MSW cohort of 18 students started at IU- South East in Albany in January 2012. Nine of the 18 students are supported by the Child Welfare Training grant. This is part of our commitment to serve the state of Indiana. Judge Payne and DCS requested our help with offering MSW education in southeast Indiana to address workforce needs. We are planning for one three- year cohort.

<u>Update on new building</u>. We were working with the architect's office about a year ago. M. Patchner met with T.Warson, head of campus facilities. D. Kemp from campus facilities toured the space at IUPUI to assess our space needs. We need space for new MSW Direct staff. M. Patchner will meet with the Chancellor next week about our space needs. We may need to find another campus partner to work with us on new space.

<u>Budget-</u> no news from the university yet on next year's budget. We are on schedule with our budget projections—no deficit.

<u>Lecturer Criteria:</u> P&T Committee has been directed to come up with promotion criteria for Lecturers to be promoted to Senior Lecturers. We learned this week that IUPUI is challenging the university decision to have the lecturers' positions be "up and out." IUPUI administration is still going to encourage Lecturers to go up for Senior Lecturer, so we will continue to develop our criteria. The up and out aspect is pending.
