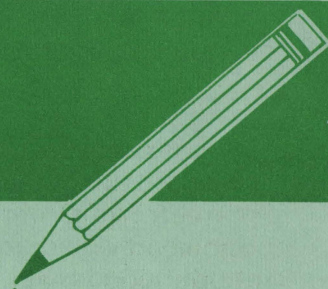

Professor James P. White of the Indianapolis Law School has been appointed consultant on legal education to the American Bar Association and will supervise accreditation of law schools by the ABA. White will continue to hold his faculty appointment and continue all his IUPUI activities and responsibilities. His ABA duties also will include periodic review of standards of those law schools already accredited. He also will consult with the ABA board of governors and the section on legal education and admissions to the bar on matters involving legal education. Professor White is chairman of the law school administration section of the Association of American Law Schools and director of its promotion and tenure study. He is chairman of the I.U. constitution committee, the IUPUI goals and objectives committee and the Indianapolis Bar Association law school liaison committee. He is director of external affairs and urban legal studies for the Indianapolis Law School.

Mary A. Lacy, director and assistant professor in the Medical Records Program, was installed as president of the American Medical Record Association during the organization's recent 45th annual meeting in Boston. The association is a non-profit, national organization of more than 12,000 professional medical record practitioners who work closely with physicians, hospital administrators, medical researchers and public health officials to improve health care delivery and establish high standards.

Donald R. Dignam, assistant hospital director/finance, has been named as one of five members to the national Task Force Committee on Hospital Accounting Principles and Practices of the 10,000-member Hospital Financial Management Association.

Dr. Henry M. Swenson, professor of periodontics in the School of Dentistry, is the new president of the American Academy of Periodontology. He was installed during the group's annual meeting recently in San Antonio, Texas. A former examiner for the American Board of Periodontology, Dr. Swenson also has served as secretary-treasurer of the board and of the 3,000-member academy. At the same meeting, Dr. Timothy J. O'Leary, chairman of periodontics, was elected vice-president of the academy and re-elected to the board of examiners.

Elton T. Ridley, associate professor of hospital administration and director of Medical Center Planning, has been elected vice-president of Indiana Health Careers, Inc.

Arthur Mirsky, chairman and associate professor of geology, has accepted an invitation to become a member of the Solid Waste Task Force of the Indiana Senate Committee on the Environment and Ecology. One objective of the task force is to consider alternatives to the problem of solid waste disposal in terms that could lead to legislative action by the Indiana General Assembly.

During the annual Society of Nuclear Medicine meeting at Miami, David Miller, the assistant chief technologist in nuclear medicine, was awarded the top prize for the best scientific paper presented by a technologist. The title of the paper was "An Improved System for Administration of Xenon-133 in Pulmonary Ventilation Scintiphotography." Associated with this award was a \$500 cash prize. Dr. Hee-Myung Park received a bronze award for his display called "Radionuclide Angiocardiology: A Diagnostic Aid in the Detection of Superior Vena Cava Anomalies and Left to Right Cardiac Shunts." Jerry Porter, chief technologist in the nuclear medicine division, received a bronze award for his display, "The Anger Camera Used as a Body Counter for Thyroid Evaluation."

The 1973 Lord-Chaim Award of the First District Dental Society of New York has been awarded to Dr. Myron J. Kasle, associate professor and chairman of dental radiology in the School of Dentistry. The annual award is presented to the writer of a meritorious essay dealing with research in basic or clinical services.
