**Agenda Item III: Updates/Remarks from the Chancellor**

Nasser Paydar, Chancellor

Paydar reported on the following:

- Rodrick Perry has been appointed athletic director and will begin on January 1, 2016. Perry comes from Wright State University with over 20 years of experience.
- Executive Search Updates:
  - Vice Chancellor and Dean at IUPUC: The search committee has been appointed. The IFC provided names for the committee.
  - Executive Vice Chancellor/Chief Academic Officer: The search process has started, and the committee has met for the first time. The IFC provided names for the committee.
- Support of Talks/Discussions on Campus: Departments bring in speakers for talks/discussions but do not always support the speaker's view. Paydar brought the following statement to the council. He believes it is good to be open to all ideas whether we are for or against it and to engage students in the discussions.

**A Place for All Voices at IUPUI**

IUPUI is committed to provide forums for the free expression and exchange of ideas, including those we may not condone. Even when we vehemently disagree, we should strive

to do so with mutual respect and civility. Open dialogue is central to academic freedom and our educational mission.

While the university provides a forum for the free discussion of ideas, it abhors all forms of racism, bigotry and discrimination, including anti-Semitism.

- November 17, 2015, is the installation of the chancellor. The State of the Campus address will also be given at this function. All are invited. 2 p.m. in CE 450.

#### **Agenda Item IV: Updates / Remarks from the IFC President**

Marianne Wokeck, IUPUI Faculty President

Wokeck reported on the following:

- Open Discussion of Opposing Beliefs: The Faculty Affairs Committee is working on a statement that underscores academic freedom and freedom of expression.
- Report from the University Faculty Council (UFC) (Tuesday, October 27, 2015):
  - Student Code of Conduct Compliance: Because of laws passed, sometimes our policies and language needs to be changed to reflect the laws. The code will be changed accordingly.
  - The report from the presiding officer of the UFC was very brief. She hopes the meeting in February is more substantive in that regard.
  - The UFC Executive Committee asked for a report from Human Resources for the reason, and hopefully the correction, of why IU does not have 10-month salaries paid out over 12 months. Joan Hagen, associate vice president and university controller, explained the way the university handles that kind of request. The expediency of the work on the request is based on how much time it will take, how much it will cost, etc. There are many requests to be considered. Until it can be addressed, the university will provide a tool for faculty to figure out how much money they will need to put aside to allow for pay in June and July. Wokeck was disappointed in that what the UFC asked for will have to be handled by the faculty themselves. She stated that it has been over 20 years that she has been asking the question of why the university does not allow payment in this manner, and she hopes to have that solved before she retires. She will be asking the IFC later if they used the tool and if it was effective.
  - The most frequent question she gets is regarding the status and value of tenure in the School of Medicine. She wants to be able to give answers in the future that are beneficial as she is not able to answer well at this time. The IFC-EC will look into this further.
  - IU Online: The university will have the opportunity to create and brand a degree programs. The question occurs – what is the prerogative of the faculty to address curriculum in online programs? We know this is in our purview of responsibilities but we do not have a body or group that handles this across the system. We need to find a way to discuss this and a way for faculty to handle this across the system. The ICHE sets a framework from which we need to work which is curriculum based. The IFC-EC will address this issue.
  - Another question she receives is regarding the role of the Office of Equal Opportunity. The lines are not always easily drawn and is something we need to discuss. She said it is a good time to do that as the OEO is under administrative review.
  - She thanked those who attended the meeting, but noted there are deans in the academic units who are not attending as they used to. She asked schools to talk with deans to encourage attendance to take part in the discussion of faculty issues that are important and engage all faculty on campus.

### **Agenda Item V: [Information Item] The Mentoring Exchange**

Steve Mannheimer, Associate Dean for Faculty Affairs, School of Informatics and Computing

Mannheimer gave the following information from a handout:

- The IUPUI Faculty Mentoring Exchange is a simple-to-use website that matches faculty looking for mentors (mentees) with faculty offering to be mentors. The Exchange facilitates this connection by offering mentees a list of likely mentors. After that, it is up to the mentees and mentors to work things out. The whole process is completely voluntary.
- The Exchange is open to any member of the IUPUI faculty. To explore the Exchange, go to <https://comet.soic.iupui.edu/mentor/> and use your university login to enter the website.
- You will be asked to create a personal profile, which is a checklist that describes your academic identity, experience and collegial interests. You can provide as much or as little information as you choose. The more information you provide, the better the chances you will be matched with someone with corresponding interests. Both mentees and mentors fill out the checklist, and can be listed as either a mentee or mentor or both.
- Once you create your profile, the Exchange recognizes you as a set of categorical qualities, to be matched with the qualities of a potential mentee or mentor. The matching process is automatic and straightforward.
- When a potential mentee uses the Exchange to find mentoring and innovative research, your profile appears in the list of potential mentors. It is up to the mentee to make the first contact through regular email or by phone.
- After establishing the human-to-human communication, the mentee and mentor can decide if this is a good match and if they want to continue, and what they expect from this mentoring relationship.
- You can use the Exchange as often as you like to find one or 100 mentors – for research, teaching, and/or civic engagement. You can update your profile whenever you choose. For mentees, every adjustment to your search checklist will produce a different list of potential mentors. For mentors, every adjustment to your profile may change how often your name appears in different searches.
- The Exchange is sponsored by the IUPUI Office of Academic Affairs and the Office of the Senior Associate Vice Chancellor for Academic Affairs Melissa Lavitt. We consider the Exchange to be a living, evolving platform. Its primary purpose is to help faculty achieve their professional goals. To do that, the Exchange must be responsive to faculty needs and preferences.

- We are the only, as far as he can tell, large campus with this kind of tool.

#### Questions:

- Stockdale asked if it is possible to find certain groups/types of people for mentoring. For example, can you search for women, women/men by social identity, interest, etc.? Mannheimer said that suggestion has been made; however, the tool will not do it at this time.
- Gavrin said the privacy notice link on the website does not work and there should be a privacy notice. The university has a privacy policy that tells you what kind of data is being stored, etc. Mannheimer said data is not being stored to a long-term database, but data about yourself is being stored.
- Murtadha said finding a mentor with social identity is hard to do. It is often a challenge to find the same kinds of social identities you have also paying attention to interests in research, teaching, and service. She hopes this gets worked on soon.
- Windsor said his mentees want to go to dental schools. It was noted the tool is for faculty, not students.
- Schneider asked about storage and access; whose idea is this? Mannheimer said it grew out of a conversation with Lavitt, and he had then further discussed it with the Mentor Academy. It is a very

low level tool that helps you find a mentor/mentee. The Mentoring Academy comes out of the Office of Academic Affairs. He said there are schools that have mentoring processes and the Exchange should take that into account.

- Are there any results? Is anyone using it? Any success stories? Mannheimer said no data has been collected at this time. The idea was not to feel that the site is being watched, but to provide comments at this time. The tracking will come once the Exchange is further revised.

**Agenda Item VI: [Action Item] Determination of “N”**

Marianne Wokeck

Circular 2015-09 (appended to minutes): Chart showing council representation depending on “N”

Wokeck reviewed the handout appended to the minutes and discussed the following:

- “N” determines the number of unit representatives and at-large representatives allowed on the Faculty Council.
- “N” has changed from two years ago because two schools have had zero faculty since dissolution and the School of Medicine faculty count has changed.
- The recommendation from the Executive Committee is to appoint N as 50-51 which makes the number of representatives 38 and provides one more representative than from the previous N. This would be in effect for the next two years.

The motion came out of the Executive Committee; therefore, it did not need to be seconded. A vote was taken and “N” was passed as 50-51.

**Agenda Item VII: Call for IFC or UFC Standing Committee Reports**

Budgetary Affairs Committee (BAC): L. Jack Windsor, committee chair, reported on the following:

- Congratulated Camy Broeker for her interim position as vice chancellor for finance and administration.
- The committee will be working on RCM proposal, banded tuition, and assessment drivers.
- Cluster conversations are moving to the fall instead of the spring due to the change in budgeting practice. The conversations are used by the Budgetary Affairs Committee and Campus Planning Committee to meet with the deans.
- Parking revenue: how are we doing with managing parking ourselves?

## **Agenda Item XI: Report from the IUPUI Staff Council**

Jim Klenner, President

Klenner reported on the following:

- At the last meeting, Camy Broeker and Juleta Toliver, the new interim AVC for Human Resources.
- Following the model of the IFC, the Staff Council has opened time on the agenda for questions. Questions need to be submitted in advance. New Business can be submitted in advance by members as well.
- Klenner wants to begin the process to form a University Staff Council.
- The Faculty and Staff Relations Committee, from both the IFC and SC, has met and will begin work.
- The Staff Affairs Committee is working with the campus to find a way to do away with the taxing of the fee benefit for graduate students. Currently, the \$5,200 graduate fee benefit is taxed unlike the undergraduate tuition benefit.
- The Staff Council hears complaints from staff across the campus. Recently, the council sent out postcards to our constituents from each unit representative to reach out and introduce ourselves. One complaint was received about the usage of the cards in that it cost too much. Another employee felt the council was not doing enough to help to change the parking situation. Klenner responded to both complaints saying that the postcards did not cost that much and the response to them was really good. He also said the council was doing all it could to help with the parking situation and works very closely with Parking Services.

Paydar said the search for the executive director of HR has been suspended as the campus looks at the way we do HR-related work. He has asked Juleta Toliver to look and study this.

With no further business appearing, a motion was made and seconded to adjourn. The motion passed and the meeting was adjourned.

- Campus Policy on Limits in Withdrawal: Policy to be voted on by AAFC, EC, and IFC fall 2013. (*Oct. 2013: The AAC agreed that the policy was too restrictive. They agreed that students should not be allowed to enroll and withdraw (or fail) a given course numerous times. Perhaps an alternative solution is to block registration for such students, initiated at the unit level. The registrar will investigate creating lists of students who enroll repeatedly in the same course. These lists could be provided to the appropriate unit for action (registration block), if the units choose to do so. Annual Report 2014: The proposed policy was put on hold pending further fact-finding and deliberation.*)
- Grade Forgiveness Policy (*Annual Report 2014: Carried over from 2012-2013. Should this assignment be eliminated?*)
- Investigate what, if any, "University Sanctioned Events" should be included in the Registrar's list of Course Policies (*Annual Report 2014: Committee added this assignment for the 2014-15 AY.*)
- IUPUI Policy on International Teaching Assistants
- Potential Policy on Credit Hour Overlap Between Minor to Major or Major to Second Major (Porter email of 5-14-14) (*Reported at February 3, 2015, IFC Meeting: The committee concludes that the academic units should have such policies and is generating a draft.*)
- Evaluation of IUPUI Withdrawal Deadlines

- For 2015-16: Decide whether or not common questions should be adopted for course evaluations at IUPUI. Determine how common questions should be handled within core schools at IUPUI.

- Verbatim Minutes: Review proposal to exclude notation of taking verbatim minutes if a recording is being made during council meetings. (*Committee discussed this item; will suggest wording.*)
- Nominations Committee: Review and change bylaws so that the Nominations Committee is made up of faculty governance leaders of the schools. (*Update 7-10-14 and 6-10-15: keep on agenda.*)
- Review and rewrite the charge to the Constitution and Bylaws Committee. (*Update 7-10-14 and 6-10-15: keep on agenda.*)
- Recognition of Honors College (*Update 7-10-14 and 6-10-15: Recognition was discussion, but until the school submits a constitution and bylaws for review, no action is taken. Keep on agenda until C&B submitted by Honors College.*)
- FGAP Bylaws revision (problem raised by Handbook Committee/Faculty Affairs Committee in 2013-2014). (*Update 7-10-14 and 6-10-15: keep on agenda.*)
- Undergraduate Curriculum Advisory Committee: (*Update 2-25-14: With the Strategic Plan, this committee is under review by the Academic Affairs Committee and Faculty Affairs Committee as they determine whether the IFC should endorse an Undergraduate Curriculum Committee. The Constitution and Bylaws Committee will be asked to make a motion to remove the UCAC from the IFC Bylaws should the IFC endorse the new committee. The committee has been endorsed, so a motion is needed.*)
- Limit the amount of time a Board of Review can be heard before time runs out once it has been assigned by the IFC-EC. (Motion made by IFC-EC on March 27, 2014.) (*Update 7-10-14 and 6-10-15: keep on agenda.*)
- Metropolitan Affairs Committee: The committee has been inactive for several years and no member appointed. Does it still need to be a committee of the IFC?
- Add the usage of Senior Academy faculty when considering composition of Boards of Review (Assigned per IFC-EC at 5-21-15 meeting).
- Look at coordinating with IUB the University Policies and how they interact with each other. (Also assigned to Faculty Guide Committee.)
