Mark Miles is President and Chief Executive Officer of the Central Indiana Corporate Partnership, Inc. ("CICP"), a regional alliance of corporate CEOs and university presidents focused on long-term growth and economic development throughout the Central Indiana region. CICP advocates policy direction and engages in collaborative efforts to address issues facing the region. CICP encourages region-wide planning and goal setting in both the public and private sectors that recognize the interdependence of the entire area. The organization also develops objective data and analyses that lead to an informed consensus about activities that help Central Indiana businesses to become more globally competitive.
