





George K. Stookey Appointed Acting Dean of Dentistry

Dr. H. William Gilmore resigned from the deanship of the Indiana University School of Dentistry on March 1, 1996, nearly 11 years after he was appointed to the position.

The IUPUI administration has appointed IU faculty member Dr. George K. Stookey to serve as acting dean until a new dean is named. A search and screen committee headed by Dr. Angela B. McBride, dean of the IU School of Nursing, has been recruiting candidates for the deanship since January.

At a special gathering of the IUSD faculty, staff, and students called by IUPUI Chancellor Gerald L. Bepko on March 1, Dr. McBride reported that the search is progressing well and that several outstanding candidates have submitted applications for the position. A new dean is expected to be appointed as early as July 1.

Dr. Stookey, who joined the IU School of Dentistry faculty in 1964, has been the director of the school's Oral Health Research Institute since 1981 and the associate dean for research since 1987. He holds three degrees from IU—a B.A. in chemistry ('57) and M.S.D. and Ph.D. degrees in preventive dentistry ('62 and '71, respectively).

As a professor of preventive and community dentistry, Dr. Stookey has served as a consultant for both the U.S. Food and Drug Administration and the American Dental Association. He also has


been a member of the Special Grants Review Committee of the National Institute of Dental Research.

Under his leadership, the external support for research at the IU School of Dentistry has doubled. His personal contributions to the research program have helped IU gain international prominence for its work in such areas as fluoridation, the early detection of dental caries, and other preventive measures in dentistry.

Dr. Stookey was the first recipient of the IUSD Alumni Association's Distinguished Faculty Award, established in 1986, and the 1994 recipient of the Indiana Dental Association's highest honor, the Maynard K. Hine Award.

Introduced at Chancellor Bepko's special dental school meeting, Dr. Stookey indicated that he will work closely with the faculty and staff to maintain the school's traditions and facilitate scholarly activities during the interim period until a new dean is named.

Dr. Gilmore, who became dean of dentistry on July 1, 1985, and who has devoted nearly four decades of service to the school,

plans to return to faculty activities in the summer and will retire from the faculty when eligible in September 1997. Upon announcing his resignation, Dr. Gilmore issued the following statement:

"It has been a privilege to be an employee of Indiana University over the last 40 years. As a strong supporter of the University and the School of Dentistry, I have

been rewarded personally and professionally while serving in many different capacities. Unfortunately, and to my great dismay, my present assignment as dean has now become associated with factors which are harmful to me personally and to the faculty and students at the School of Den-

tristry. I, therefore, am resigning from my official administrative responsibilities as dean of the IU School of Dentistry, effective March 1, 1996, and will, instead, resume my full-time faculty position.

"I leave the position of dean with sadness and, at the same time, pride in the accomplishments that have been implemented at the School of Dentistry over the past decade while I served as dean. We have developed a plan for the future of dental education that will position the IU School of Dentistry among the leading dental schools of the 21st century. It has become apparent to me that issues directed at me personally are detracting from our progress in implementing the plan. My commitment to the success of the School of Dentistry is more important to me than the deanship. I believe the school's future is best served by allowing someone else to provide the leadership until a new dean is named.

I look forward to continuing to support the University and higher education in Indiana, with particular devotion to the profession of dentistry. In my new role, I also look forward to enjoying a more private existence while contributing in a variety of ways to the health and growth of the School of Dentistry and the University."

To put together this annual event for grads of the dental school, IU Alumni Association Director Stefan Davis (Indianapo-


Anderson Dentist Is New Alumni President

ALUMNI AWARDS

JOHN A. RAHE (DDS'63) AURORA DISTINGUISHED ALUMNUS

Dr. Rahe's far-reaching professional achievements bring much pride to his alma mater.

A former president of the Indiana Dental Association, Dr. Rahe currently is trustee of the 7th District (Indiana and Ohio) of the American Dental Association. He previously was an IDA delegate and alternate delegate to the ADA for 14 years. Dr. Rahe has served since 1992 on the board of trustees of the ADA, pursuing a wide variety of special assignments for several ADA councils and committees. In 1989 he chaired the ADA's Committee on State Government Affairs.

Long active in IU's alumni affairs, Dr. Rahe joined the IUSD Alumni Association board in 1987 and was elected president in 1992. In the 1960s Dr. Rahe organized the IU Alumni Club of Dearborn County, serving as its second president.


A general dentist in Aurora, Dr. Rahe presided over the Southeastern Indiana Dental Society from 1969 to 1971. He served on the IDA's Endowment Committee for the IU dental school for 11 years.

Dr. Rahe is a fellow of the American College of Dentists and the International College of Dentists, and holds membership in the Pierre Fauchard Academy and Academy of Operative Dentistry. A long record of civic leadership includes his having organized and served as the first president of Aurora Community Housing, Inc., a not-for-profit group that built Aurora's first housing project for senior citizens. He was first president of the Aurora City Board of Parks and

Recreation, and a four-term president of Aurora's Chamber of Commerce. He is also a past president and chair of the Dearborn County Chamber of Commerce.

REMARKS: I would like to thank the officers and directors of the IUSD Alumni Association for giving me this award. Also I wish to thank the wonderful people in dentistry and in the Alumni Association with whom I have worked for so many years. They have made the years and the association with them a great reward and the award even more meaningful for me.

When my mother learned of this award her reaction was the same as mine: What did you do to deserve such a high honor? After some

RICHARD D. ELLSWORTH (DDS'73) LAFAYETTE DISTINGUISHED SERVICE AWARD

Dr. Ellsworth's outstanding record of service to Indiana University is a testament to his strong commitment to both the Alumni Association and the School of Dentistry.

A life member of the association, Dr. Ellsworth was appointed to the IUSDAA board of directors

in 1985. He was elected to a one-year term as president of the organization in 1990 and represented the dental school on the IUAA's Executive Council from 1991 to 1993.

Since 1993 Dr. Ellsworth has devoted much energy and time as chair of the dental school's Development Committee, a group that was formed that year to assist the school with a variety of fundraising efforts. Under Dr. Ellsworth's leadership the committee created the Dean's Associates program, which recognizes donors who contribute at least \$1,000 annually to the school.

When not involved with IU projects, Dr. Ellsworth turns his attention to a number of community and church activities in Lafayette, where he has practiced since graduating from IUSD. He has served on the Home Hospital Staff for 22 years and has been active on the board of the First Christian Church since 1986.

Dr. Ellsworth is a former trustee of the Indiana Dental Association and former president of West Central Dental Society. He holds fellowship in the International College of Dentists.

Again, I would like to thank each person responsible for this award.


MIKE HALLORAN INDIANAPOLIS CERTIFICATE OF APPRECIATION




1945

The group was honored by the alumni during a reception that preceded Friday night's annual banquet.





JAMES A. COTTONE RECEIVES DISTINGUISHED ALUMNUS AWARD

When Dr. James Cottone was in Indianapolis last September to present a continuing education course at Indiana University, he was belatedly presented with an IUSD Alumni Association award he had been selected for a year earlier.

In 1994 Dr. Cottone, professor and director, Division of Oral Diagnosis/Oral Medicine at The University of Texas Health Science Center at San Antonio, was named a Distinguished Alumnus of IUSD. A prior engagement that year prevented Dr. Cottone from participating in the Fall Dental Alumni Conference, where the alumni honors are traditionally bestowed, so the presentation was delayed until his most recent visit to Indiana.

Dr. Cottone, a native of Syracuse, N.Y., received his education at the University of Pennsylvania (BA'68), Tufts University (DMD'72), and Indiana University (MS'77 in oral diagnosis/oral medicine). He practiced dentistry both in the Navy and in Syracuse.

Dr. Cottone's current appointment at The University of Texas also includes the directorship of the Center for Research, Education and Policy Development in Infectious Disease Control in Dentistry. He is internationally recognized for his work in viral hepatitis, AIDS, and infection control as they relate to the dental profession. Dr. Cottone has presented more than 500 programs on these topics. He received an Assistant Secretary for Health Award from the U.S. Department of Health and Human Services in 1989 for his

contributions to the care and treatment of people with AIDS and HIV infection.

Dr. Cottone's other area of interest is forensic dentistry. He participated in the identification of Lee Harvey Oswald (1981) and the victims of the Pam Am Flight 759 crash (New Orleans, 1982) and the Delta Flight 191 crash (Dallas-Fort Worth Airport, 1985). He is a past president of the American Society of Forensic Odontology and was a member of the Examining Committee of the American Board of Forensic Odontology.

Dr. Cottone has written several textbooks and monographs, and more than 100 scientific papers and abstracts. In 1995 he and two colleagues produced the 2nd edition of *Practical Infection Control in Dentistry*.

He holds fellowships in the American College of Dentistry, the Academy of General Dentistry, the American Academy of Forensic Sciences, and the Academy of Dentistry International. He is a diplomate of the American Board of Forensic Odontology and the American Board of Oral Medicine. Dr. Cottone is a past chair of the Board of Directors of the Office of Sterilization and Asepsis Procedures (OSAP) Research Foundation and is a retired Captain in the U.S. Naval Reserve Dental Corps.

Dr. James Cottone received his 1994 Distinguished Alumnus Award during a visit back to Indianapolis in 1995 to present a continuing education course, "Infection Control and OSHA Requirements for Dentistry."

Partners in the Pursuit of Excellence

Open the door to any clinic, any lab, any lecture hall at the Indiana University School of Dentistry and you will likely find evidence of the Indiana Dental Association's generosity.

Results of this generosity often reveal themselves tangibly, as in the form of research equipment, clinical instruments, and computer systems.

They also show up in more subtle displays, as in the form of training programs, scholarships, and faculty recruitment efforts.

In whatever form, the financial assistance is critically important to the dental school's ongoing pledge to excel in teaching, research, and service, and to uphold the ideals of the parent university.

In 1979 the IDA, under the direction of then IDA President W. Kelley Carr (DDS'55, MSD'61), vowed to establish an endowment program for the pursuit of excellence at IUSD. The IDA leadership was particularly interested in contributing to the school's efforts to acquire, retain, and nurture an outstanding roster

of faculty. By 1980 the organization had created its Endowment Committee and an endowment fund, which became known as the Pursuit of Excellence Endowment Program. These efforts set in motion a fundraising campaign for dental education in Indiana that has not only grown but flourished over the past 16 years.

Funding Nuts and Bolts— or an Entire Laboratory

Sometimes assistance from the IDA comes in small packages. Two winters ago, for example, a modest \$171.99 from the Pursuit of Excellence fund helped the school install a breaker switch for a microradiographic instrument that the Oral Health Research Institute needed for its work related to the early detection of dental caries. Since then, the Institute has moved swiftly forward in its study of early caries detection. In May of this year, Dr. George Stookey, acting dean of dentistry and the Institute's director, will host on behalf of IUSD a global community of experts in early caries detection. Twenty-two researchers from six nations, including four IU faculty members, will share their work in

this important field with participants of the 1st Annual Indiana Conference, to be held on the IUPUI campus.

The IDA also lends a welcome hand when the dental school's needs are sizable, such as in 1994 when the newly established Department of Oral Biology required a variety of laboratory instruments and devices. More than \$53,000 from the Pursuit fund was applied toward these expenses. In turn, this demonstration of the dental school's commitment to develop a team of oral biology researchers helped lead to a grant of \$476,500 from the IUPUI Research Investment Fund to support the cost of renovations and additional instrumentation required for this new program.

In 1996, the IDA hopes to realize its most ambitious project yet—the creation of an Indiana Dental Association Chair in Restorative Dentistry.

The IDA trustees have endorsed this recommendation of the Endowment Committee, chaired by former IDA President Lloyd Phillips (DDS'54).

A minimum of \$1 million is required to endow a chair in the IU system, and the Pursuit of Excellence fund is drawing near

to that goal. As Dr. Phillips and Dr. H. William Gilmore, then IU dean of dentistry, conveyed in a letter to IDA members last December, prudent investments and a strong base of donors have helped the fund grow to its current level of about \$915,000.

The IDA Endowment Committee is hopeful that donations made this spring will push the fund "over the top," making it possible for the search for an endowed chair to be announced at the IDA's annual session in May.

"The endowed chair project has given strength to the bond that already exists between the IDA and the dental school," said Dr. Gilmore. "Only one other state dental association in the nation has chosen to support its dental school with the special gift of an endowed chair. We've seen the Pursuit fund swell to nearly a million dollars over the years—outstanding proof of the IDA's special commitment to this school and its graduates."

Endowing a "Chair": Notes on Nomenclature

Some of you may be asking, Just what does an endowed chair *do*? Is it the same as an endowed professorship? Will the endowed chair teach, conduct research, or

run a department?

While teaching and conducting research are expected to play enormous roles in the career of the IU dental school's endowed chair, he or she will not "chair," or administer, a department.

The terminology can be confusing since the words "chair" and "professor" are routinely used in teachers' academic titles. To the Indiana University Foundation, however, the phrase "endowed chair" is a philanthropic rather than academic term. It denotes one of several gift opportunities in the IU system that are used to perpetuate the name of a person or group by associating that name with a project of enduring value. One may choose, for example, to create an "endowed professorship" for the sum of about \$500,000. Endowing a chair is one of the highest philanthropic honors that can be awarded, and it requires one of the highest levels of giving at about a million dollars.

Last year IDA President Charles Hassel (DDS'67) appointed a committee led by Immediate Past President James Frey (DDS'62) to determine the area of dentistry that would benefit most from this special addition to the faculty.

The committee decided during its October 1995 meeting to focus its attention on the dental school's restorative dentistry program. The Indiana Dental Association Chair would be used to pay tribute to the success of IU's restorative program, including a salute to its past contributors, and would serve as a symbol of a renewed commitment by the IDA to support the faculty's efforts to expand oral health services for the citizens of Indiana.

"Dental professionals in Indiana have always had an appreciation of clinical dentistry and the types of research that help practitioners expedite patient care," said Dr. Gilmore. "The committee that will be charged with the responsibility of recruiting the endowed chair will be focusing its search on dentists who have superior clinical and teaching skills as well as an outstanding background in research related to dental materials commonly used in general practices. It will be important to find a gifted person—a unique individual—who can work closely with IU's restorative team as well as other teaching and research groups throughout the school. We hope that the search, once it gets under way, will be brief. But it must be a thorough, worldwide search."

Dr. George Willis, who heads IU's Department of Restorative Dentistry, was delighted to learn that the group wanted to place this special faculty member in the restorative area.

"I'm very honored that our department was chosen by the IDA," says Dr. Willis. "It is very difficult financially to create new faculty positions in this era of tightening budgets—especially a world-class position such as the one the IDA has in mind. The whole department is very excited about the prospect of having this person join us. We want to work

with the IDA to find the best person possible for the position, someone worthy of carrying the IDA name in his or her title."

In anticipation of the fund reaching its goal this spring, a committee is being composed of IU teachers and IDA members to initiate a global search for the endowed chair. Dr. Willis will oversee the search and screen committee. "We are finalizing the list of committee members now," he says. "That list will be published, and we will welcome input from the IDA membership. Obviously, we will be looking for an extraordinary restorative dentist, and someone who can augment our departmental research and clinical programs."

In 1981, a year after the Pursuit of Excellence Endowment Program was launched, Dr. Ralph McDonald, then IU's dean of dentistry, announced with pride and gratitude in his *Alumni Bulletin* column that 13 persons had joined this unique IDA/IUSD campaign for excellence. Today a couple of hundred dental professionals are participating, and everyone who has contributed since the program's inception has helped to guide it toward its unprecedented success in the history of giving at IUSD.

While the creation of the endowed chair will undoubtedly reflect the Pursuit of Excellence program's finest hour, it will by no means signal the program's last hurrah. Once the endowed chair has been created with the Pursuit monies the chair will become self-supporting, leaving the Pursuit fund free to begin building once again toward new goals shared by the IDA and the IU dental school. And there promises to be many innovative projects on the dental school's horizon that will require the support of its partners in the IDA. A perennially valuable component of the dental school's

fundraising program, the Pursuit of Excellence Endowment Program has never been more important to the dental school that it is right now.

In the 16 years that the IDA/IUSD Pursuit of Excellence Endowment Program has thrived, gifts have helped breathe life into old programs and been invaluable in the creation of new ones. While the individual instances in which the Pursuit fund has helped shape the school are too numerous to list here, we offer a few examples of how these donations have become part of the rich educational fabric at IUSD.

□ In 1981 the Pursuit fund recognized the excellence of two IU faculty members by honoring them at a Dean's Council banquet in Bloomington, where they each were presented a \$1,000 award.

Chris Miller, PhD, Excellence in Research Award. "It made me feel proud to be associated with the dentists in the state of Indiana," Dr. Miller recalls of that September evening 15 years ago. He received the award after nine years on the IUSD faculty. "I've always enjoyed, and will continue to enjoy, interacting with the

dental community, through both my teaching and research efforts."

Today Dr. Miller is a professor of oral microbiology at the School of Dentistry and a professor of microbiology and immunology at the School of Medicine. He is a nationally respected authority on infection control in dentistry, serving as a spokesperson for the American Dental Association and as a consultant to the Centers for Disease Control and Prevention as well as the ADA's Council on Scientific Affairs. Dr. Miller writes a monthly column on infection control procedures for *RDH*, a national journal for dental hygienists, and has co-written a textbook titled *Infection Control and Management of Hazardous Materials for the Dental Team*. He maintains the dental school's Sterilization Monitoring Service for dental practitioners throughout Indiana and in other states, and co-edits the service's newsletter.

Abdel Kafrawy, BDS, Excellence in Teaching Award. "I will never forget that evening," says Dr. Kafrawy, who earned an MSD degree in oral diagnosis/oral medicine at IU in 1962 and joined IU as a research assistant in 1969. "The award came as a very nice surprise, and it meant a lot to me. To this day I remain honored as well as grateful to everyone in the IDA who made the award possible."

Today Dr. Kafrawy is a professor of dental diagnostic sciences. He possesses one of the most brilliant minds in oral histology, and has been a key figure in the education of the majority of postdoctoral students who have passed through IU's advanced education programs. He has written or co-written 125 articles and chapters published in a wide

variety of scientific journals and texts (mirroring the wide variety of student researchers he has taught during his career). Dr. Kafrawy has served on hundreds of graduate committees during his IU tenure and has turned a highly trained eye to the evaluation of histologic work required in many student and faculty projects. Dr. Kafrawy has read hundreds of thousands of histologic slides since coming to IU; they are on file in black boxes that cover an entire wall of the histology laboratory. His lecture courses—which any grad student will tell you are among the most comprehensive they have experienced—include *Advanced Oral Histology and Embryology* and *Histophysiology and Pathology of the Periodontium*.

□ In November 1985 the Pursuit of Excellence fund sent two IU faculty members—Timothy O'Leary, a periodontist, and Roland Dykema, a prosthodontist—and Diana Yates, a periodontic dental assistant, to Sweden for training in the

Branemark implant system. Dr. O'Leary is now deceased and Dr. Dykema has retired, but Diana Yates continues to draw upon the valuable knowledge she acquired in Sweden more than a decade ago in her career at the school today. In 1994, Diana celebrated her twentieth anniversary with IUSD. "The Branemark implants continue to serve as our primary implant system in both the periodontic and prosthodontic graduate programs," says Dr. E. Brady Hancock, chair of periodontics and allied dental programs. "About 75 percent of the implants we place are Branemark."

□ And, speaking of Dr. Hancock, the Pursuit fund was instrumental in the recruiting process back in 1987 when the school was combing the nation for a talented person to fill the chair of the periodontics department, a position that Dr. Timothy O'Leary had retired from. A retired Captain in the U.S. Navy Dental Corps, a diplomate of the American Board of Periodontology, and an alumnus of IU (MSD'74), Dr. Hancock was chosen to follow in his former teacher's footsteps, and he has been an outstanding

addition to the IU faculty. Dr. Hancock is widely recognized in his field and is serving until 1999 as a director of the American Board of Periodontology. He is a consultant in periodontics to the ADA's Council on Dental Education.


□ About \$38,000 of Pursuit funds was channeled into the dental school's aging dental illustrations facility in 1990 and 1991, bringing the facility up to speed technologically. The newly installed computer system made it possible for the facility to offer more—and faster—services. No one was more ecstatic about this infusion of technology than Alana Barra, supervisor of dental illustrations. "The new system enabled us to produce higher quality computer-generated slides with enhanced graphics capabilities," she explains. "Another dramatic benefit was the expedience it gave us in terms of layout and design of numerous types of artwork and other printed materials. Many tedious hours of free-hand artwork design and creation were eliminated by the new system. The turn-around time for most slide requests was reduced by 75 percent. After we started using the computers we began to receive a lot of positive feedback from faculty who were lecturing at professional conferences—members of their audiences were remarking to them about the excellent quality of their slide presentations. Since our slides travel with the faculty all over the world, they represent in a visual sense the quality of the institution itself. We're proud of the work we can do with these computers, and we are deeply grateful to the IDA members for their generous contributions to our department."

laboratories for the school's new Department of Oral Biology, chaired by Dr. Marilyn Lantz. The biggest ticket item—a high-speed centrifuge costing \$28,374—is also one of the most essential instruments for research performed at the cellular and molecular level. Looking a lot like a household washing machine, the centrifuge has a spin cycle of 20,000 revolutions per minute. "Think of it as a machine that separates the 'milk from the cream' in research," says Dr. Lech Switalski, a new IU associate professor and one of several oral biology faculty and staff members who keep the centrifuge humming in its corner spot in Room 284. "The centrifuge is fundamental to research in molecular biology, biochemistry, and microbiology. We study bacteria in our labs, so we use the centrifuge to separate the bacteria from the cultures they are grown in. The centrifuge is one of many instruments that help us study root surface caries and periodontal disease." The oral biology department's research is funded in part with grants from the National Institute of Dental Research. ¶

Establishing a Link with Lille

The dental school is set to play a significant role in the new collaborative relationship between Indiana University and France's Université de Lille II.

They are separated by some 4,000 miles, but Indiana University and the University of Lille II have sealed an agreement that will allow the two institutions to work closely with one another for the mutual benefit of their students and faculty.

In a ceremony held March 26, 1995, on the Indiana University-Purdue University Indianapolis campus, an official Agreement of Friendship and Cooperation was signed by Dr. Jean Leonardelli, president of the University of Lille II, Lille, France, and Gerald Bepko, IU's vice president for

long-range planning and chancellor of IUPUI.

The agreement pledges a commitment from both universities to engage in activities that promote "mutual understanding and academic, cultural, and personnel exchange."

The University of Lille II is one of four universities (and about two dozen schools of higher education) situated in this northern French city, located near the Belgium border. About one hundred thousand students and researchers inhabit the city of Lille, which has a population of 1.1 million. Lille is the largest university complex outside Paris and the second largest health center in France.

The university is composed of three campuses, with Lille II comprising the professional schools of law, medicine, and dentistry.



Dr. Leonardelli's delegation included six members of Lille's faculty, with representatives from all three schools. In 1993, a private delegation of Indiana physicians and dentists visited Lille, followed by an official visit by Dr. H. William Gilmore, then IU's dean of dentistry, and Dr. W. Eugene Roberts, chair of IU's Department of Oral Facial Development.

"IU's dental school has enjoyed an unofficial working relationship with Lille university for several years," Dr. Gilmore said last spring. "We are therefore very pleased to be a participant in the two universities' official friendship agreement."

The idea to pursue a collaborative agreement originated primarily with two persons: IU's Dr. Eugene Roberts—who had been appointed a permanent visiting professor at the Lille medical school in 1986, when he was on the faculty at the University of the Pacific in San Francisco—and Manuel Chanavaz, DDS, MD, a colleague of Dr. Roberts at Lille.

(Dr. Roberts joined the IU faculty in 1988 and continues to maintain his position at Lille.)

Both teachers share research interests in such areas as implantology. In 1990, Dr. Chanavaz, who heads Lille's Department of Oral and Maxillo-facial Implant Surgery, was

appointed a consultant on the orthodontic faculty at IU, where he periodically lectures to graduate students and presents continuing education programs to Indiana physicians and dentists on such subjects as orthognathic surgery, dental implant procedures, and craniofacial anatomy.

"Other cities might choose football teams to forge their identity," says French publication Grands Reportages, "but here in the North of France, the people build belfries that potential aggressors can see from afar. Or giants, which they bring out and parade on carnival days."

Dr. Chanavaz helped IU's dental faculty develop its advanced anatomy curriculum.

Over the years Dr. Roberts has pursued a number of teaching obligations at Lille, where he annually presents a lecture series on bone physiology. In June 1995, he completed a six-month faculty sabbatical there.

"My time at Lille was both professionally and personally rewarding," says Dr. Roberts. "Lille has an excellent medical center with a rich resource of patients and faculty. It was also personally gratifying to experience the French culture from 'the inside'—a unique benefit of the sabbatical."

The IU dental school is now participating in friendship agreements with 17 institutions located in Australia, Brazil, China, England, France, Germany, Hungary, Japan, Mexico, Singapore, South Korea, and Thailand. ■

Latest Developments in the Development Office

In the past few months the IUSD Office of Development has undergone several important personnel changes.

After serving for three years as director of development, Barry F. Smith resigned from his position at IU in order to proceed with plans to move to Roanoke, Va., where, ironically, his ties to the IU dental school will remain strong.

A native of Bloomington, Ind., Mr. Smith announced late last summer that he would be leaving IU in order to marry a recently departed IUSD student—Dr. Penny Lampros, who became an alumna after collecting her Master of Science in Dentistry degree in orthodontics last July (see Postdoc Profiles on page 40). Penny, by the way, is the daughter of another IU alum: Dr. Leo Lampros, who preceded Penny in IU's ortho program by 31 years. Penny has joined her father in his Roanoke practice. As she and Barry plan their May '96 wedding, all of their many friends and colleagues at IUSD wish for them a lifetime of prosperity and happiness.

On January 2, Mr. Smith began a new job as director of development for the College of Architecture and Urban Studies at Virginia Tech (Virginia Polytechnic Institute and State University), in Blacksburg, Va. He is also overseeing the development efforts of the university's Center for European Studies in Switzerland.

Also last fall the dental school bid farewell to Joyce Stafford, the development office's longtime secretary. Mrs. Stafford, who worked with Mr. Smith and also his predecessor, Mr. Danny Dean, has moved to Carrollton, Texas, where she is still involved with development work, this time for a church group that raises funds to send missionaries overseas.

Taking the reins of the dental school's development program is B.J. Isaacson, who is currently serving as the program's on-site manager. Her efforts complement those of Gail Plater, a director with the Indiana University Foundation who has been serving as a consultant to the school's development program.

Ms. Isaacson recently moved to Indianapolis from St. Louis, where she has a long history of service with not-for-profit organizations. From 1986 to 1994 she was executive director of Reproductive Health Services, a crisis intervention, counseling, and ambulatory surgical center with a budget of more than \$3 million. The center's 90 staff members and volunteers serve 16,000 women annually.

Last year Ms. Isaacson was named director of Client and Volunteer Services for the St. Louis Effort For AIDS (EFA), which is funded by the United Way and involves the efforts of more than 400 volunteers. Her responsibilities included the recruitment, management, and training of these volunteers as well as program development.

An experienced fundraiser, Ms. Isaacson raised more than \$1 million from grants, private foundations, and direct mail campaigns between 1989 and 1994.

Ms. Isaacson is a licensed clinical social worker with degrees from Stephen's College, Columbia, Mo. (BA'72) and Washington University (MA'82). She is a founding member of five service organizations in St. Louis and Washington, D.C., including Adoption Associates, which finds homes for minority infants.

Ms. Isaacson is busy settling into the dental school environment and hopes to meet as many of the school's donors as possible in the months ahead. "I am most struck by the wonderful example

of benevolence I see in the dental school's faculty, staff, students, and alumni," Ms. Isaacson said after her first few weeks on the job.

"I'm also very humbled by what is happening with the IDA's generous plans to endow a chair at IU," she says. "It gives me the desire to do even more in my own position at the school. I'm very proud to be a part of the dental school's fundraising efforts."



earned his bachelor's degree in biology in 1975. Dr. Radovich has dental offices in Munster and East Chicago.




a few weeks our two shipping containers delivered our household goods and more than 200 boxes of supplies and other large equipment for the clinics. The first month was a very busy one but by the end of August we felt settled in and had accomplished many tasks.

"The eye clinic was deluged with people needing exams.... The dental clinic has been very busy too. We are proud to have a clinic where the standard of care and the level of infection control are as high as that of any found in an American dental office. This was made possible by donations of \$40,000 worth of dental supplies and equipment by dental suppliers, manufacturers, and professionals. Over the summer we saw community people for a minimal fee. Now that school has started, care will be provided only to the mission's 1,400 school kids except for Wednesday, which will be community day. The school receives free care. We are also setting in place a strong prevention program that will include brushing and fluoride rinsing in the classroom.

"Three-quarters of the school children have been screened at two schools and are being seen in priority order. We still need to perform screenings at two remote schools. We are fortunate to have an orthodontist from Florida who flies in to offer his service every six weeks. Many of the children will receive orthodontic care from him.

"Our regular staff consists of myself, a Haitian dentist, three assistants, one receptionist, and a hygienist in training. We have two operatories but the clinic is built to accommodate four. Our units are old and are having more and more problems. We are looking into obtaining two more donated units. This would allow us to run a more complete program as well as to work around breakdowns. As you may have read in the Nov. 6, 1995 *ADA News* (Dental Clinics Abroad Seek Volunteers and Donated Equipment, p. 23) we are also recruiting dentists of all specialties to come and work with us on short-term mission trips."

Dr. Raber says that the items they are in greatest need of are a slow-speed motor with nose cone and latch contra angles, an electrosurgery unit, an ultrasonic bath, delivery units, and a variety of lab equipment. 



Family Matters

Katherine Carr-Medley's road to higher education was more like an obstacle course. But determination helped her stick to the path, which led to a once-in-a-lifetime surprise from the Soroptimists.

My column for the *Alumni Bulletin* is usually reserved for stories about IU's dental hygiene graduates. But this time I'd like to introduce you to a current dental hygiene student: Katherine Carr-Medley, a member of the second-year class from Linton, Ind.

As IU's dental hygiene classes have increased in size, so has the diversity in the backgrounds of our students. Like many of our older students, Kathy brought to her dental hygiene education a unique collection of life experiences that bear little resemblance to the experiences of students who embark on their studies immediately after high school.

Kathy quit high school at age 16 to marry. A decade later, she had five beautiful children—and a deeply troubled marriage.

Early in her married life Kathy struggled to make improvements. She took jobs pumping gas, washing cars, cleaning dog kennels—anything that would help a large household that suffered from periods when there was no other income to count on. She also managed to obtain her GED, earning a near-perfect score. But when she attempted to seek a certificate as a nursing assistant,

she was unable to complete the course because of family obligations. Even worse, she was forced to default on a student loan—an event that was to have consequences later on.

Taking stock of her life at age 26, Kathy tried again to gain some control over it. She vowed that by the age of 30, she would establish a better life for herself and her kids.

During a trip to a dentist's office, she was told of a family counselor who could help her learn to deal with her problems. Deciding to seek counseling and follow through with it changed Kathy's life. To this day she is grateful to the members of the staff in that dental office for steering her in a wise direction. "They treated me as more than a dental patient," Kathy remembers. "They saw me as an entire person who had other needs."

In June of 1992, Kathy separated from her husband, moving out of the house with her children. She hoped to re-enroll in school, but the black mark on her record from the defaulted loan made any attempt at securing another school loan futile.

Time passed. By August of 1993 Kathy was divorced, but she had managed to scrape enough money together to enroll in a semester of

classes at Indiana State University. She had made up her mind to become a dental hygienist.

"I had always been frightened of the dentist's office," admits Kathy, who was a patient at the dental school during the years she was growing up in Indianapolis. "My father lost his teeth at an early age, and I remember one of my dental students warning me that if I didn't take better care of my teeth I too would lose them early. I met other dental professionals along the way who spoke of the important role teeth play in our overall health. I decided I didn't want to lose my teeth. And gradually I began to feel that I wanted a career in which I could share with others the importance of maintaining good oral health."

But there were to be more bumps in the road for Kathy as she pursued her educational goal. Her family was once again plunged into chaos when, just three days into her first semester at ISU where she was taking prerequisites for dental hygiene, her ex-husband suddenly died. Kathy faced the reality that it was now totally up to her to fend for the family.

Repeatedly turned down for financial aid, Kathy saw a bleak future unfolding. With no where else to turn, she sought help from the dental profession itself.

Looking for financial assistance, Kathy wound up receiving something she ultimately found more important to her survival: a reminder that her faith in God would help her help herself. The first dentist she approached in her community counseled her—they discussed religion and the importance of having faith in difficult times. And they prayed.

A few days after these meetings, things began to fall into place for Kathy. Encouraged to apply for financial aid once again, she did. This time, it came through! Kathy was cognizant of the fact that another monumental change had occurred in her life that was connected to the guidance she received from a dental professional.

Kathy did very well in her studies at ISU, making the dean's list and getting accepted into Alpha Lambda Delta, a national honor society for freshmen. She also earned \$5 an hour in the Department of Life Sciences as a teaching assistant, a job usually reserved for graduate students.

After applying to IU's dental hygiene program, Kathy was accepted for fall semester 1994 on the Indianapolis campus. De-

lighted to have accomplished a goal she had worked so hard for, Kathy geared up for the challenges ahead.

For one, there was the commute: almost 1,000 miles per week back and forth daily from Linton. Still, commuting seemed the most logical choice because at home she

had the support of her mother and others for the care of her children, ranging from 5 to 11 years old back then. Baby sitters helped out in "shifts." Kathy developed incredible organizational skills to keep everybody on track. Financially, life remained as rough as ever.

It was during Kathy's first semester at IU that she saw a notice about a scholarship program funded by Soroptimist International of the Americas, a service organization for executive and professional women. Called TAP awards (Training Awards Program), the aid is targeted toward mature women who must enter or return to the job market, and who need additional skills, training, and education to upgrade their employment status.

Kathy quickly applied, submitting an essay that described her circumstances and explained her desire to create a better life for herself and her children. She was selected as the local winner in February 1995, receiving a prize of \$500. For Kathy, it was a windfall! Five hundred dollars would go a long way to help her with her financial burdens.

What Kathy did not realize was that, as the local winner, her application was automatically placed in the running for a regional contest.

Later that spring, Kathy received some extraordinary news: She had captured the TAP regional award—this time, a prize of \$3,000. "That was more than some of my yearly incomes in the past," Kathy remarks. "I was thrilled." The regional contest included a trip to Detroit, where the check was presented. Kathy not only received more money than she had ever hoped for, she also took her first ride in an airplane.

After the excitement died down, Kathy re-immersed herself in her life and studies and soon forgot that there was one final TAP award competition, a prize given at the international level. Only one person would be selected from competitors in more than 20 countries and territories.

The startling news came in a phone call to Kathy's home in June 1995. "Are you sitting down?" asked Cherryl Liddle, president of The Soroptimist Foundations.

"I still feel shook-up," Kathy says as she recalls being told she was the TAP award's international recipient. The \$10,000 prize was presented to her during ceremonies held in Philadelphia.

Looking back, Kathy says she doesn't know how she would have made it to where she is today without the award money. It relieved much of the pressure she was under to take care of her family while working toward a career. Sometimes, she still can't believe what happened to her is real.

Now finishing the final semester of classes for her associate's degree, life is definitely looking brighter. She's enjoying the time she spends with her patients in the dental hygiene clinic. "I repeat to them the same advice that the dental student gave me when I was a teenager," she says.

There's been another change, this one related to affairs of the heart: A few months ago Kathy married Tim Medley, of Carlisle. The couple has refurbished an old home near Carlisle to make room for their merging families, including Kathy's brood and her husband's 3-year-old daughter.

The Soroptimists have helped to keep Kathy on the road—quite literally. For Kathy's long commute, which is 223 miles each day now that she has moved, gas costs \$75 a week. She has worn out three cars in two years (although she reminds us that each of those vehicles had logged 150,000 miles before she ever started driving it). Few mysteries lurk beneath the hoods of Kathy's automobiles; she's adept at changing oil, spark plugs, distributors, and alternators, and has learned to take care of just about anything else that needs attention.

With a household complicated by varied personal schedules, Kathy is determined to reserve Saturdays for family time. She is

very proud of her children and is instilling in them the importance of a good education, although she believes they already have a pretty good head start in understanding this, given the dramatic changes their own lives have taken.

If you're already at the bottom, then where can you go but up? You need to ask yourself if you still want to be making a minimum wage by the time you are 30. That was the question that inspired me to get started."

Being able to spend more time closer to home is one "pearl" that Kathy is looking forward to after she completes school. The children are active in basketball, cheerleading, and choir, and all but the youngest play baseball. Kathy expects to be spending more time in the grandstands cheering them on next season.

And when IUPUI's commencement ceremonies come around in May, Kathy will have a huge cheering section of her own. She believes that her family and other supporters all deserve honors. "I'm not sure that I could have or *would have* gotten this education without their help and influence," she says.


Kathy's career plan is two-pronged: She wants to practice full time for the next few years, and when her children are grown she'd like to earn a master's degree and then find a dental hygiene teaching position at a university. When asked if she has any advice for young people who may feel they are facing insurmountable problems and are on the verge of throwing in the towel in terms of acquiring an education, Kathy says: "I learned that the world isn't going to stop for me—I have to be the one to make the move. You should think about where you will be if you don't try.

When Kathy decided she wanted to go to school several years ago, she pursued her goal with absolutely no idea of how she would actually achieve it. "I decided to worry about the big things and let the little ones work themselves out," she says.

Resolve, conviction, and faith. These are the kinds of feelings that help people learn to help themselves, and Katherine Carr-Medley possesses them in abundance. ■




