## National FFA Organization Selects Site for 2006-2012 Conventions

The National FFA Board of Directors and National FFA Officers recently chose Indianapolis as the site for the 2006-2012 national FFA conventions. The location of the FFA Alumni national convention for those years will likewise be affected by the decision. The National FFA Alumni Association has traditionally held its conventions in conjunction with the national FFA convention. The unanimous decision, made in a meeting April 5, followed a recommendation from the board's convention site selection committee.

The site evaluation process included representatives of teachers, past national FFA officers, and state agricultural education leaders. A "scorecard" used to rank the competing cities contained evaluation criteria and priorities determined by teachers, students, and state FFA leaders. It reflected the projected needs for

capacity, lodging, transportation, facilities, security, location, and expense. While no one city involved in the bidding process scored "best" in every category, the committee gathered information and made several site visits to the four finalist cities to inspect facilities and discuss issues with local representatives.

The FFA Alumni and FFA will hold the next four national conventions at the current site in Louisville, Kentucky, including the upcoming 75th anniversary FFA and 30th anniversary FFA Alumni conventions this coming October. The selection committee considered both Louisville and Indianapolis as the top two cities and ideal sites to host the national FFA convention from 2006-2012. However, the committee determined Indianapolis represented the most balanced and advantageous approach to providing for the needs of students and teachers in the years under consideration.

## Council and FFA Seek New Alumni Executive Director

The National FFA Alumni Association and National FFA Organization are conducting a joint search for a new Alumni executive director, who will share responsibilities between both organizations. The new director will spend 70 percent of his or her time managing the day-to-day operations and developing membership of the National FFA Alumni Association. The director will be responsible for planning and coordinating national Alumni meetings, conventions, and major activities.

The remainder of the joint position's duties will focus on volunteerism: recruiting, retaining, and recognizing Alumni/volunteers as a critical resource for local program success.



As coordinator for the organizations' volunteerism efforts, the new Alumni director will develop and implement programs, materials, and workshops that mobilize and assist local teachers in the management of volunteers. Organizational leaders hope that this outreach will provide agricultural educators with volunteer management tools and training through pre- and in-service programs.

Interviews for this position are currently being conducted. *New Visions* will highlight the new director in a future issue.

## Alumnus' Efforts Improve State Fair for FFA and 4-H

Leo Tsimbinos nearly jumped out of his seat when the final vote on the state budget bill was counted in the Wyoming House of Representatives in early March.

Tsimbinos, a Cheyenne resident and National FFA Alumni life member, left the 2001 National FFA Alumni Convention inspired to do something for Wyoming youth. About three months later, an opportunity presented itself. He lobbied long and hard for an amendment to the appropriations bill authorizing \$67,600 for four new swamp coolers and 952 mattresses in dormitories for FFA and 4-H exhibitors at the Wyoming State Fair.

When the House voted 44-16 for the bill, about an hour after the Senate approved it 18-12, Tsimbinos' goal was a major step closer to reality.

"Justice has been done," said Tsimbinos as a testament to the power of one person. He deflected credit for his efforts, which included testifying before the Joint Appropriations Committee and lobbying senators and representatives to resist an amendment in the House to erase the state fair improvements. During his testimony to the committee, Tsimbinos stressed the economic impact created by FFA and 4-H students as a reason for maintaining the authorization.

"The credit should go to the kids who work so hard," he said. "The kids told me, 'The mattresses stink. We can't sleep [in the dormitories]. It's so hot.'"

## Grant Enriches Aquaculture Curriculum and Community

Instructor Doug Mayfield of Grayville, Illinois, is grateful that his local affiliate submitted an FFA Alumni Chapter Grant Program application. A \$1,000 grant was instrumental in alleviating the financial burden of purchasing new aquaculture equipment.

Since fish farming is a growing industry in the region, Alumni members and Mayfield decided it would be beneficial to invest in a school aquaculture system. The system includes a 300-gallon tank, a biofilter, and circulation pump for raising 25 fish at one time. The biofilter uses a bacterial culture to neutralize fish waste.

“With the recent construction of a fish processing plant in nearby Pinckneyville,” Mayfield explains, “it was important that our program keep up-to-date and students learn basic aquaculture practices.”

The aquaculture system will be used to teach students enrolled in the both the Agricultural Science and the Biological Sciences Applications in Agriculture courses. Students will study water quality, feed effi-

ciency, fish growth rates, and general fish farming management techniques.

Mayfield says the new system will eventually benefit every student in the district. “We annually conduct joint efforts with

grade school and junior high teachers and students through our agriculture in the classroom program,” Mayfield says. “During that presentation, we will highlight the aquaculture system and show them why it is important to learn about aquaculture.”

District administrators and community leaders have reacted positively to the new

aquaculture program. Besides enriching the curriculum, the aquaculture equipment will provide students who want to remain in the local community with an advantage in securing local employment. “The skills and knowledge of aquaculture practices will enable students to generate more income for local employers who hire them,” Mayfield adds.

For now the aquaculture system has peaked the interest and curiosity of students and staff. Mayfield often enters the local agriscience classroom to find people gathered around the tank and mesmerized by the swimming fish. Questions on how the system works lets him know that he’s got students and the community hooked.

# Working Effectively with Your Local Agriculture Instructor

The purpose of your local FFA Alumni affiliate is to serve as an advocate for agricultural education.

Whether you find yourself in a community that has had the same teacher for many years or that has had several teachers in recent years, your role as Alumni members is to support the students and the program.

Teaching agricultural education is a challenging job. Teachers work individually with students on their supervised agricultural experience (SAE) programs, career goals, and training for various career development events offered through the FFA. Teachers also take students to leadership activities, thereby encouraging them to become better community leaders and volunteers.

Most of our teachers teach five to seven different classes a day. This is not the case with math, English or history teachers who might only prepare for two different classes per day.

You should know what your local agriculture teacher expects from the program. You can ask how you can assist in meeting those expectations. By traveling in the same direction as the local teacher, you can make reaching the goal so much easier for everyone.

The ideal agriculture program should function as follows:

- The agricultural education advisory committee provides the vision for the program.
- Your agriculture teacher(s) direct(s) the program.
- The local FFA Alumni and other volunteers support efforts to achieve the vision.

## Nominations Sought for Council Member-At-Large Vacancies
