### Law School



The Program in International Human Rights Law presented a special event on Friday, December 3, 2010, in the Conour Atrium in celebration of Human Rights Day. The theme was "Human Rights Defenders: Voices from the Community" and featured "The Invisible Frontier" art exhibit created by IUPUI's Democracy Plaza Project. The IUPUI Office of International Affairs and IUPUI Democracy Plaza, co-hosted the event, along with *Professor George Edwards*, director of the Program in International Human Rights Law. Professor Edwards moderated the event that commemorated the 1948 adoption and proclamation by the UN General Assembly of the Universal Declaration of Human Rights. Other speakers included: *Ian McIntosh*, IUPUI director of International Partnerships, who gave the allegory of the starfish to demonstrate the power of individuals to achieve change; *Isaias Guerrero*, hunger striker of the Latino/Youth Collective, who spoke about the struggle of migrant youth in the U.S. for the passage of the Development Relief and Education for Alien Minors (DREAM) Act; he was one of more than 31 other youths across Indiana who went on a hunger strike to press for the passage of the act; and *Dr. Marquita Walker* of the IUPUI Labor Studies Program who discussed domestic legislation affecting workers' rights. Law student organizations serving as co-sponsors included: The International Human Rights Law Society, Equal Justice Works, and Master of Laws Association. Community organization sponsors included: The Center for Victim and Human Rights, and Human Rights Works.

On December 6-7, 2010, at the American Bar Association's Washington Healthcare Summit in the nation's capital, IU School of Law-Indianapolis Professor David Orentlicher and Priscilla D. Keith, Director of Research and Projects for the law school's Hall Center for Law and Health, participated in a panel discussion on "Health Care Reform Litigation: Its Impact and Response to State Challenges." The Summit session focused on H.R. 3590 Patient Protection and Affordable Act, signed into law by President Obama on March 23, 2010. Shortly thereafter, 13 states filed a complaint challenging the constitutionality of the new law, indicating that the health care reform bill violates the Ninth and Tenth Amendments and is, therefore, unconstitutional. It also argued that the bill violates the Commerce Clause and, as a result, Congress cannot require every person to purchase health insurance from a private company or face a penalty if they do not purchase the requisite insurance. The panel discussed the current status of health care reform litigation and its impact and response to state challenges. They also addressed the impact of state's nullification statutes and the ability of the states to carry out current federal programs.

The law school once again hosted colleagues from Brazil for a second visit to the "Program in U.S. Law" conducted by Professor Lloyd T. "Tom" Wilson. From August 30 – September 3, colleagues from the Faculdades Espirito Santenses law school in Vitória, Espírito Santo, Brazil participated in the program, which, at their request, provided emphasis on the U.S. Constitution. The program included four half-days of classes at the law school, law-related field trips to the Indiana State Senate and Indiana Supreme Court, and also the offices of Baker & Daniels. A cultural tour was also a part of the program and included a Brazil-U.S. Student Forum at Wabash College, as well as the Colts v. Bengals game at Lucas Oil Stadium. The third annual Program in U.S. Law for the Brazilian law school will be conducted in early September 2011.

*Professor Robert Pape*, an expert in international security, is a Professor of Political Science at the University of Chicago. His recent book, *Cutting the Fuse*, published in October, 2010, offers a wealth of new knowledge about the origins of suicide terrorism and strategies to stop it. Professor Pape, along with his co-author, *James K. Feldman*, and the Chicago Project on Security and Terrorism, examine every suicide terrorist attack worldwide from 1980 to 2009 – nearly 2,200 in all. Professor Pape's commentary on international security policy has appeared in *The New York Times*, *Washington Post*, *New Republic*, *Boston Globe*, *Los Angeles Times*, and *Bulletin of Atomic Scientists*, as well as on *Nightline*, *ABC News*, *CBS News*, *CNN*, *Fox News*, and *National Public Radio*.

*Judith Kaye* received her B.A. from Barnard College in 1958 and her LL.B. from New York University School of Law in 1962, graduating *cum laude*. Following law school, she entered private commercial practice at Sullivan & Cromwell in NYC, 1962-1964. From 1965 to 1969, she was part-time assistant to Dean Russell Niles of NYU School of Law. In 1969, she joined Olwine, Connelly, Chase, O'Donnell & Weyher as a Litigation Associate on a part-time basis while raising her three children, and then was later named a Partner. In 1983, she was appointed by Governor Mario M. Cuomo to the high Court of the State of New York, the Court of Appeals, becoming the first woman to occupy that post. In 1993, Governor Cuomo appointed her Chief Judge of the State of New York, the first woman to occupy that post. As the only New York Chief Judge ever to complete a full 14-year term, she was re-appointed in 2007 to a term that ended December 31, 2008, due to the state's mandatory retirement provisions. Today, she is Of Counsel to the firm of Skadden, Arps, Alte, Meagher & Flom LLP in New York City. As Chief Judge, she led numerous projects to make the New York court system more efficient and responsive to the needs of all residents.



## Faculty, Students & Staff in the Spotlight !



**Jonathan Bashi**, LL.M. student and Fulbright Scholar from the Democratic Republic of Congo, was invited to the UN to give a panel presentation before the end of last semester. He was selected from many African students to represent African youth for a special ceremony that consisted of 1 panel of only 4 Africans. Jonathan has also been offered an Internship at the UN in New York, which will begin on January 17<sup>th</sup>. He will work with the UN Department of Peacekeeping Operations.

**Alexander Berger & John Tao**, J.D. students, are the recipients of a \$500 grant from the IUPUI Lesbian, Gay, Bisexual and Transgendered (LGBT) Faculty Staff Council for their project, "Greater Indianapolis LGBT Legal Needs." The grant will be applied to a two-pronged analysis of the legal community in Indianapolis and the surrounding areas to first determine what unique legal resources are available to the LGBT community and, secondly, determine what the legal needs are of the Indianapolis LGBT community. The ultimate goal of this project is to identify and describe any gaps that may exist, either real or perceived, between the legal needs of the LGBT community and the available legal services. This will be achieved through surveys and interviews of both practicing attorneys and through potential LGBT clients. The grant research will be done as part of the students' membership in the IU School of Law-Indianapolis's chapter of Equal Justice Works, a student organization dedicated to public interest.

**Professor Shawn Boyne** delivered a presentation on October 27, 2010, entitled "Law in Action: Training Law Students using a Counter-Terrorism Simulation" at the Max Planck Institute for Foreign and International Criminal Law in Freiburg, Germany. The presentation highlighted the Counter-Terrorism Simulation held at our law school last fall in which students from the law school and SPEA responded in role to a series of simulated terrorist attacks. She also discussed the importance of using cutting edge teaching methods to teach decision-making skills, the lessons learned from the simulation, and how she hopes to incorporate that new knowledge into future simulation exercises. Max Planck Institute completing work on a book project entitled, *The Many Faces of Prosecutorial Decision-Making: The German Way of Justice*.

**Professor Karen Bravo** traveled to Prague, the Czech Republic, to participate in a conference on bullying November 8–10, 2010. She was joined by an international group of attendees from many other countries in examining the nature, role and impact of bullying in various spheres of human endeavor. Professor Bravo presented her current research on human trafficking, *Legal Constructions of Personhood and Their Nexus with the Traffic in Human Beings*, at the Second Global Conference on Bullying and the Abuse of Power: *From the Playground to International Relations*.

**Professor Eric Dannenmaier** was asked to participate in the Richard G. Lugar Symposium for Tomorrow's Leaders at the University of Indianapolis on Dec. 11<sup>th</sup>. (Principals from every high school in Indiana selected two junior students to attend this Symposium.) He addressed the group and answered questions on the topics of food and energy security. Professor Dannenmaier researches water and energy security topics, and delivered a paper on water security in Marrakesh, Morocco, at a NATO sponsored scientific workshop last spring. He is currently finishing work on a co-authored paper addressing "Energy Security as a National Security Challenge."

**Professor George Edwards** was invited to present at London's Royal Society of International Affairs – Chatham House, which is the U.K. sister organization of the prestigious U.S. Council on Foreign Relations (CFR). Professor Edwards spoke as part of the Transatlantic Dialogue on International Law co-sponsored by Chatham House and the Atlantic Council. His presentation was titled "Efficacy of International Law in Protecting Human Rights: Hong Kong, the U.S., the U.K., and Transnational Legal Education." Professor Edwards was one of two dozen participants invited to join the dialogue, with other participants being officials of the U.S. government (Department of State), UK government (Foreign Office), and the European Union, along with representatives of academia and civil society from the U.S., the U.K., and continental Europe. The panel on which Professor Edwards spoke was chaired by William T. Taft, IV...

(former U.S. Deputy Secretary of Defense and Legal Advisor to the Department of State). The Atlantic Council, based in Washington, D.C., co-sponsored the Dialogue, which took place Nov. 10–11, 2010.

Professor Edwards also presented a keynote speech on Nov. 8, 2010, to over 350 members of the National Association of Foreign Student Advisors (NAFSA). His speech was entitled “Ambassadors for International Education: How We Promote Peace, Security, Human Rights & Fundamental Freedoms.” Other more recent presentations included: Accra, Ghana at the U.S. Embassy-Ghana, Dec. 9<sup>th</sup>; Monrovia, Liberia at the University of Liberia, sponsored by the U.S. Embassy-Liberia, Dec. 10<sup>th</sup>; Brussels, Belgium, (visit to U.S. – Belgium & Luxembourg Fulbright Commission), Dec. 13<sup>th</sup>.

**Ryan Funk**, J.D. student, was invited to participate in the UN International Labor Organization Conference in Santiago, Chile, in December.

**Professor Emeritus Henry C. Karlson** passed away on Monday, October 25, 2010, after a battle with cancer. He taught criminal law at our law school for over 30 years, and was a frequent commentator for local media outlets. He joined our law school in 1977 and retired in 2008, although he continued to teach on a part-time basis. Professor Karlson served for eight years in the U.S. Army where he was appointed a Trial Judge as a member of the U.S. Army Trial Judiciary and served as a Trial Judge in Vietnam. Before joining the faculty at IU, he taught at the University of Illinois, College of Law. Over the years, he taught not only criminal law but evidence, trial practice, and a seminar dealing with child abuse. He was a noted expert on child abuse and not only co-authored a book on the subject, but wrote articles that appeared in journals, reviews and other publications. He received his A.B., J.D. and LL.M. degrees from the University of Illinois.

**Priscilla D. Keith**, '93, has joined the law school's Hall Center for Law and Health where she serves as Director of Research and Projects, as well as adjunct professor. She earned her J.D. from IU School of Law-Indianapolis, her M.S. in Anatomy from Atlanta University, and her B.S. from Spelman College. She served as the General Counsel of Health & Hospital Corporation of Marion County, including Wishard...

Health Services, the Marion County Health Department and Environmental Services, as well as Assistant Counsel to Governor O'Bannon, and Executive Assistant to the Dept. of Insurance, State Board of Accounts, Utilities and Telecommunications and the Women's Commission. She was also Chief Counsel of the Advisory Section under Attorneys General Jeff Modisett and Karen Freeman-Wilson. **Professor Maria Pabón López** has been appointed to the Editorial Advisory Committee of the National Conference of Bar Examiners. The Editorial Advisory Committee reviews and comments on articles for publication in *The Bar Examiner*, which is published quarterly, and is the only national publication related to bar admissions. Professor López has been the secretary of the Board of Law Examiners since 2008. She is a graduate of Princeton University and the University of Pennsylvania Law School. The 10-member Board of Law Examiners is responsible for ensuring that individuals admitted to practice law have met the requirements specified in the Admission and Discipline Rules of the Indiana Supreme Court. This includes the duty of writing and grading the essay portion of the examination given to applicants seeking admission to the Indiana Bar.

**Johnny Pryor** has joined the law school administration as the Assistant Dean for Student Affairs. Dean Pryor received his J.D. from IU Mauer School of Law in Bloomington and his B.A., *cum laude*, in English and Political Science from Wittenberg University. After law school, he served as an Assistant Clark County Prosecutor in Springfield, Ohio and, during this time,

**Professor Carlton Waterhouse** participated in the White House Forum on Environmental Justice on December 15, 2010. This event brought together environmental justice community leaders, state, local and tribal government officials, Cabinet members, and other senior Federal officials to discuss creating a healthy and sustainable environment for all Americans. Professor Waterhouse is nationally recognized for his work on environmental justice and is known internationally for his research and writing on reparations for historic injustices and state human rights violations. His views have been published in the *Wall Street Journal* online, and his articles have appeared in prestigious law journals including: the *Pennsylvania Journal of International Law*, the *Fordham Environmental Law Review*, and the *Rutgers Law Review*.

Professor Waterhouse also traveled to South Africa in December to present his current research on *Rights and Reparations: Remediating the Past without Wrecking the Future* to the law faculty of the University of Cape Town on December 9, 2010. While in Cape Town, Professor Waterhouse also participated in the Conference on Law, Culture, Constitutionalism, and Governance being held jointly with the University of Cape Town and the University of Stellenbosch December 10–11. He presented his research as part of a conference panel on Law and the “Post-Racial/Ethnic State.” He also conducted research and met with South African government officials and business leaders regarding the government's efforts to rectify economic harms caused by apartheid.

## EMERGENCY PREPAREDNESS INFORMATION

Indiana University has created a web page to provide resources for you about emergency preparedness; information will be updated as needed. From the IU homepage, <http://www.indiana.edu/>, go to: About IUPUI, Site Index, Emergency Preparedness. **In the event of a building emergency for:**

**FIRE:** Alarms will sound and evacuation is mandatory. Use closest stairway for exits. **DO NOT USE ELEVATORS.** Once outside, move to a safe place; if possible, to the parking lot west of the law school. Remain outside until the “all clear” is given.

**TORNADO WATCH:** The “campus siren” will sound but evacuation is NOT required.

**TORNADO WARNING:** Three blasts of an air horn in the Atrium will indicate **evacuation is necessary.** Evacuate **immediately** to the parking garage and use only the NW and SOUTH stairwells which have direct garage access. Remain in garage until an “all clear” is given.


## SAFETY AT IUPUI

Please call the IUPUI Public Safety Dispatch Center at **274-7911** whenever you see anything that makes you feel uneasy or if you have discovered a crime. This number is a direct line and may be used to report ANY emergency, problem, or concern.

### Campus Police Escorts

Police escorts are available to students and employees 24 hours a day. Please call **274-SAFE or 274-7233** **between 6:00 p.m. and 2:00 a.m.** if you are concerned about your personal safety.

Emergency phones are available in parking garages and in outside areas on campus. The outside campus phones are identified by yellow boxes and a distinctive blue light above them. Emergency phones are also found in the hallways of some campus buildings. These provide free access for people on campus to request any type of assistance. All emergency phones are identified by the word **EMERGENCY** and connect to the IUPUI Safety Dispatch Center (911).



## IUPUI Shuttle Service It's a FREE ride!

The IUPUI shuttle system operates Monday through Friday all year round, except during university recognized holidays. Their 3 shuttle routes: the Campus Route, North Campus Route, and HITS Express, are complimentary of Parking & Transportation Services and are available to anyone in the university community. IUPUI has improved the Jags Express shuttle routes to meet your campus transportation needs. Additional parking is available just minutes from campus along Indiana Avenue and on 16<sup>th</sup> St. at Bush Stadium. The Jags Express lots offer convenient parking and easy transportation to campus. Buses leave every 10 minutes between the hours of 6:00 a.m. and 10:00 p.m., Monday – Friday.

## *Bike Theft Prevention Tips*

The increasing popularity of biking as a sport and as a means of transportation has made bicycles an easy target for thieves. Theft prevention tips include:

1. Lock your bike to a bike rack **ONLY** and avoid locking items that can be easily cut, broken, or removed. **(Bike racks are located in the law school underground garage for extra security.)**
2. Locking your bike on rails, trees, signs, etc., can be a hazard to campus safety, campus property, and your personal property. Bikes found to be a hazard will be removed by campus officials.
3. Bikes not locked to anything may be removed by thieves. Buy a good lock and use it. Cable bike locks that secure both frame and front and rear wheels to a bike rack are best.

NOTE: For personal safety, always wear a helmet every time you ride!
