IUPUI's Mission

Indiana University-Purdue University Indianapolis (IUPUI), a partnership between Indiana and Purdue Universities, is Indiana's urban research and academic health sciences campus...IUPUI promotes the educational, cultural, and economic development...through innovative collaborations, external partnerships and a strong commitment to diversity



- ❖ IUPUI's mission documents are clear and articulate publicly the organization's commitments



Mission Statement

- located on *About IUPUI*
 - IUPUC
 - Schools
 - Departments
- remains consistent, with changes in implementation strategies but not principal themes
 - Doubling Goals introduced in 2003
 - Academic Plan for Implementing IUPUI's Mission developed in 2007



- ❖ IUPUI in its mission documents recognizes the diversity of learners, other constituencies, and the greater society it serves



Cross-Cutting Themes in Mission Documents

- *a commitment to ensuring diversity*
- *attract and support a better prepared and more diverse student population*
- *committed to the personal and professional development of a diverse campus community*
- *committed to building a strong, welcoming campus community for all*

❖ Understanding of and support for the mission pervade IUPUI



Schools, Offices, Divisions, Departments have mission statements congruent with the campus mission

Deans and Vice Chancellors submit progress and planning reports based upon school and campus goals and did a 10 year retrospective in 2011

Organizing framework for Academic Program Reviews



- ❖ IUPUI's governance and administrative structures promote effective leadership and support collaborative processes



Established by the Boards of Trustees of Indiana University and Purdue University

- Board of Trustees
- Boards of Advisors for both IUPUI and IUPUC
- President of Indiana University appoints chancellor
- IUPUI and University Faculty Councils
- Staff Council
- Student Government
