

## CHANCELLOR MAYNARD K. HINE REMARKS ON THE UNIVERSITY PRESIDENCY:

"Dr. John W. Ryan comes to the presidency of Indiana University with skills and experience especially important in this period of growth and transition for the University.

"A former chancellor of the University of Massachusetts at Boston, he moves to the presidency of the University from the office of vice-president and chancellor for regional campuses. From these positions of responsibility Dr. Ryan has established himself as a leader in the development of university systems.

"We believe this development is the primary present business of the University. The re-organization of the University, the accelerating growth of the regional campuses throughout our state, the organization and development of IUPUI as Indiana's fifth primary state campus all require the leadership, the wisdom and vision, and the experience which we have found in Dr. Ryan.

"We are no longer a University with a single main campus and a system of extension or subsidiary campuses. But neither have we yet become an Indiana University system of fully developed campuses in all the regions of our state.

"The organization to achieve this purpose now exists. I believe the support for the achievement of this Indiana University system is strong among our faculty, students, alumni, citizens, and their legislators.

"These are crucial and difficult times for us. But they are also good times with the challenge of renewing the University to serve the new needs of a new society. We congratulate the man who will lead us in this challenge, President John W. Ryan."

## LEGISLATIVE REPORTS VII

### Senate -- New Bills:

SB 222 (Fanning, McDaniel) -- Requires denial or revocation of state scholarships for students convicted of use of illegal force during a demonstration in which they take part. Assigned to Education Committee.

SB 242 (Bainbridge) -- Permits counties to establish cumulative building funds for medical centers; mandates it for Lake County. Assigned to County & Township Business Committee.

SB 270 (Konrady, Swisher, McComb) -- Requires State Board of Health to make plans for the establishment of a special facility for diagnosis and treatment of the multiple handicapped; to be known as the Multiple Handicapped Special Facility Act of 1971; appropriates \$50,000. Assigned to Public Health Committee.

SB 319 (Hayes, Harrison) -- Authorizes Indiana-licensed physicians to render birth control services and information to minors under certain conditions. Assigned to Organization of Courts Committee.

SB 332 (Lundquist) -- Exempts whole blood, blood plasma, blood products and derivatives, and human tissue from taxation. Assigned to Public Health Committee.

SB 340 (Gubbins) -- Repeals 1905 law prohibiting contraceptive device advertising. Assigned to Public Policy Committee.

House -- New Bills:

HB 1292 -- (Crowe) -- Amends Indiana Scholarship Act to provide educational grants to college students on the basis of financial need; raises maximum scholarship award to \$1,200 a year. Assigned to Education Committee.

HB 1356 -- (Allen, Murakowski) -- Authorizes any hospital in counties with over 100,000 population to conduct a pilot program to provide emergency medical care by using mobile intensive care, paramedics and nurses; allows paramedics to perform certain services; free doctors and nurses of civil liability for instructing a paramedic at the scene of an emergency. Assigned to Public Health & Environmental Affairs Committee.

HB 1400 -- (Jones) -- Places the educational telecommunications system under the jurisdiction of a Board of Regents rather than the state universities. Assigned to Education Committee.

HB 1430 -- (Lamkin, F. Bauer) -- Creates a state-wide medical education system in cooperation with hospitals and educational institutions throughout the state. Assigned to Public Health and Environmental Affairs Committee.

HB 1434 -- (O'Connor, Deckard) -- Establishes autonomous University of Southern Indiana using appropriations, real estate, and other properties owned or held by Indiana State University in Vanderburgh County. Assigned to Education Committee.

Betty Crocker and her coupon fans may play an important role in saving the lives of many Hoosiers.

The A.B.C. (A Better Community) Club of Brandywine Township in Hancock County is saving their General Mills coupons in an effort to accumulate 600,000 which is the amount needed to purchase an artificial kidney machine.

Mrs. Julia Low, chairman of the project, said coupon collection, a monumental project for a group of eight people, is rapidly progressing. More than 50,000 coupons had been counted as of Friday, January 22, and some 25,000 have been received since then.

The coupons will purchase a dialysis machine to donate to the Medical Center, which administers the nation's largest and most successful dialysis and kidney transplant program in cooperation with the Indianapolis Veterans Administration Hospital.

Mrs. Low says the club hopes to complete the project by April 1.

Coupons will be collected in the News Bureau at 104 Fesler Hall and then sent to the club, or anyone interested in donating coupons can send them to Mrs. Richard Low at Route #1, Greenfield, or Mrs. Joanie Bowen at Route #1, Fountaintown.

A temporary, limited intercampus courier service has been established to handle mail between IUPUI campuses, according to a memorandum circulated to the faculty by John D. Williams, purchasing and general services manager for the 38th Street Campus. University mail addressed to any of the IUPUI campuses now may be sent through campus mail postage free. Interoffice or plain envelopes may be used.

"It is important to note that intercampus mail is under study at this time," the memo continues. "A committee has been appointed to make a study and proposal for complete intercampus mail service. The temporary service will be ended on or about June 20, 1971. It may end earlier if a definite intercampus system is developed to take its place. We cannot guarantee fast service with the system for some IUPUI locations."

The IUPUI Housing Office for Medical Center Housing Accommodations and Off-Campus Listings, which has been located in the Warthin Apartment Building since April 1, 1958, will transfer to offices on the 3rd floor of the Single Student Dorm effective this Thursday. The move will be completed this Friday afternoon.

Phil D. McQuillen, associate director of housing, reports that he and Mrs. Evelyn Badgett who is in charge of the Off-Campus Information Listings will share the expanded office quarters in the Dorm now occupied by Clarence Long, residence halls manager.

The new telephone number for the Housing Office will be 264-7452 for business relating to Married Apartment Accommodations for the Union Building, the Warthin Apartment Building and Winona Village as well as Off-Campus information pertaining to accommodations for single and married individuals.

The telephone number for Long's Office for business relating directly to Ball Residence, the Single Student Dorm and Winona Village Dormitory Buildings will continue to be 264-7200.

Warthin Apartment Building residents will continue to call 264-7354 for assistance with problems relating to keys, laundry room, mail, repairs, and janitorial services. In view of the fact Warthin will now have limited office hours, residents of the building should call 264-7452 if they receive no answer at 264-7354.

A modest amount of money has been made available to IUPUI to support studies in environmental problems. The subject matter encompasses research and educational activities in the humanities and the physical and social sciences-in other words, all the IUPUI disciplines. It has been recommended that a substantial portion of these institutional funds be used to support pilot projects related to defining, exploring, and alleviating problems of the metropolitan environment. Pilot projects, it is hoped, will ultimately lead to well-financed individual or institutional projects and programs.

It is unlikely that more than \$4,000 could be awarded for any single project. However, multidisciplinary approaches may qualify for increased funding. No request will be considered too small.

The application should be addressed to Dean Doris Merritt, Office of Sponsored Programs, Chancellor's Office, by April 1, 1971. It should include:

Name of the Project Director and his qualifications,  
A title for the project,  
A description of the goal sought: What is the problem and hypothesis?,  
The method designed to carry out the project,  
The significance to be expected from the results (negative or positive),  
A budget.

Awards will be made by May 1, 1971, for a one-year period. Please call Doris Merritt at 8287 if you have any questions concerning this notice.
