

NOTED ISRAELI TO SPEAK

Elad Peled, director general of Israel's Ministry of Education and Culture, will speak Monday (March 20) at 4 p.m. in the Union Building. Peled has a degree in economics and social science from Hebrew University in Jerusalem and is also a graduate of France's top military college. He served as deputy chief of staff under General Rabin during the Six-Day War and commanded the division that led the attack on the Golan Heights and defeated the Syrian Army. Peled is deeply concerned with the educational development of Jews and Arabs.

He will be the guest of the Indianapolis Chapter of the American Professors for Peace in the Middle East and all interested persons are invited to attend.

IUMC AUTHORS

A major new text, Maxillofacial Prosthetics -- Multidisciplinary Practice, has been written by Dr. Varoujan A. Chalian, chairman of maxillofacial prosthetics in the School of Dentistry, Dr. S. Miles Standish, chairman of the dental school's division of clinical oral pathology, and Dr. Joe B. Drane, head of maxillofacial prosthetic services at the University of Texas Dental Branch and the M.D. Anderson Hospital and Tumor Institute.

The book is being published by Williams & Wilkins Co. as the first comprehensive text on maxillofacial prosthetics.

Sonia-Sanchez, called by many the "female LeRoi Jones," will present the opening program Monday, March 20. She is perhaps the leading black poetess and writer in America today. Tuesday's program will be headed by William H. Wiggins Jr., a teaching associate and folklore doctoral candidate at I.U. Other appearances will be made by The Black Arts Theater of Indianapolis, Wednesday; Dana Chandler Jr., black artist, Thursday; Dr. Charles G. Hurst Jr., president of Malcolm X College, Friday; Earl Anthony, black author, Saturday. All programs begin at 8 p.m., except Thursday's which starts at 7 p.m.

The Lecture Hall Building will be the scene Saturday (March 25) at 10 a.m. for workshops in education, community life, politics, Black Student Union, "black student on white campus" and campus coalitions.

Sunday's program (March 26) at the Walker Theater will include "Shrine of the Black Madonna" with Mwaimu Aminifu at 11 a.m., Chicago Drums Unlimited at 2 p.m. and "Tribute to a Black Woman--Part II" at 6 p.m.

DICTUM NOTES

Chancellor Hine wishes to call to the attention of the faculty two editorials that appear in the February issue of Dictum, a periodical published by students at the Indianapolis Law School. Excerpts from the editorials:

"Law School is not, and should never be compared to undergraduate school, yet many of us persist in acting as though it were. Each of us has shown that we are pretty special, otherwise we would not be here. Shouldn't we mix some of that special ability with a little common sense and begin acting as future business and community leaders?"

"The administration of this school worked long and hard to acquire a new building and you show no appreciation. NO PRIDE! The lounge looks like a bus station on Friday night...Even worse is the snack area downstairs...Ours is a profession that prides itself on protecting and safeguarding the rights of others...You may not agree with us, but play the part anyway and humor us. The effect may be contagious. Pride is one disease no one should mind catching."

Chancellor Hine comments: "It is important to keep reminding ourselves that we do have responsible students in all of our divisions, and they deserve even more attention than some of our 'dissidents.'"

ATTENTION RESEARCHERS

The following is a message from Dr. Jerome H. Jaffe of the President's Special Action Office for Drug Abuse:

"The Special Action Office for Drug Abuse Prevention is concerned about the difficulties that some scientists seem to be having in obtaining Schedule I substances for research purposes. For this reason, a task force has been convened to examine the current regulatory procedures for obtaining these substances and, where appropriate, to recommend changes in these procedures.

The task force is composed of members of the Special Action Office, the Office of Drug Abuse Law Enforcement, the National Institute of Mental Health, the Food and Drug Administration, and the Bureau of Narcotics and Dangerous Drugs.

"I would appreciate any effort you can make to communicate to your members our interest in this matter. They should channel comments about specific problems they are having in obtaining Schedule I substances to the Task Force for Research, c/o Special Action Office for Drug Abuse Prevention, 726 Jackson Place, N.W., Washington, D.C. 20506. Such reports, coming directly from concerned scientists, will be helpful to the members of the task force as they assess the existing procedures and determine what action, if any, is needed to correct them.

"We solicit the advice of, and information from, members of the medical and scientific communities on this problem. Working together, we can help to create a situation in which the obvious need for regulating controlled substances can be met without suppressing individual scientific creativity."
