

~~X~~ DR. GLENN W. IRWIN JR. APPOINTED CHANCELLOR OF IUPUI

Dr. Glenn W. Irwin, Jr., dean of the Indiana University School of Medicine, today was named Chancellor of Indiana University-Purdue University at Indianapolis.

Dr. Irwin succeeds Dr. Maynard K. Hine, who took over as chief administrative officer in 1969 when Indiana University and Purdue academic programs in the state's capital were merged into a unique joint campus.

The Indiana University Board of Trustees also named Dr. Edward C. Moore, Indiana University associate dean for academic affairs, to the new post of executive vice-chancellor at Indianapolis.

President John W. Ryan said that Dr. Hine will continue in an active role for IUPUI by helping to co-ordinate financial support of the campus through gifts, grants and bequests to the Indiana University Foundation. He retains the title of professor of periodontics.

PRESIDENT RYAN PRAISES CHANCELLORS HINE AND IRWIN

"Dr. Hine has given this campus excellent leadership," Dr. Ryan said. "His vision and his energy have carried development of IUPUI forward in great strides these past five years. Today IUPUI is one of the most unique and viable urban campuses in America.

"As we make this change in chancellors, Dr. Hine joins me in wholehearted tribute to the faculty, staff, and administration of both Indiana University and Purdue, whose unstinting co-operation brought this about.

"Dr. Irwin is especially well experienced to carry on the long-range goals of the Indianapolis campus. His challenge is not only to continue the development of the undergraduate and professional programs, but also to expand graduate studies selectively in the arts, sciences, and technologies.

"Of particular assistance to Chancellor Irwin in this respect will be Dr. Moore's experience of six years as the dean of graduate studies in the humanities and sciences in another state university. Like Chancellor Irwin, he also has had extensive experience as a classroom teacher."

Chancellor Hine said of Dr. Irwin: "This is an excellent choice of an excellent man. As dean of medicine, Dr. Irwin demonstrated his talents and abilities as he led the School of Medicine through a period of innovation and growth unique in the history of medical education.

"I am equally impressed with the selection of Dr. Moore as executive vice-chancellor.

"I look back on the first years of IUPUI with some pride and some feeling of accomplishment. I look ahead now to the next years with great confidence and hope for our campus."

President Arthur G. Hansen of Purdue said, "I am most pleased with the Indiana University decision to appoint Dr. Irwin as chancellor of the IUPUI campus.

"I pledge to him Purdue University's full co-operation as the two universities continue to work in close harmony in carrying out their educational responsibilities to the citizens of the Indianapolis region.

"I have every expectation that my personal association with the new chancellor will be as warm and friendly as it was with the former chancellor, Dr. Maynard K. Hine. Chancellor Hine will certainly be remembered for the excellent foundation that he built, which now serves as the base for future developments by Chancellor Irwin."

A native of Roachdale, Indiana, Dr. Irwin received the B.S. degree from Indiana University in 1942 and the M.D. degree in 1944. He served as an intern at Methodist Hospital before Army service, and later was a resident at the Indiana University Medical Center.

In 1950 he joined the faculty as an instructor in medicine, reaching the rank of professor in 1961. He was acting chairman of the department of medicine in 1956-57. He became dean of the School of Medicine in 1965.

Known as an outstanding educator during his tenure as dean of the School of Medicine, Chancellor Irwin was instrumental in the development and implementation of the Indiana Statewide Program for Medical Education. This program has developed Centers for Medical Education at seven new locations throughout the state in co-operation with other institutions of higher education. The universities include Purdue, Ball State, Indiana State, Notre Dame, and Evansville.

Under his leadership the postgraduate and continuing education programs of the school have been greatly expanded. This has been accomplished primarily through the development of affiliation arrangements with community hospitals throughout the state for medical student, intern and residency education.

He was primarily responsible for the development of the metabolic and endocrine clinic system at the Medical Center. He also has directed research in the field of steroid pharmacology and research training in the field of drug and therapy evaluation.

A fellow and member of numerous professional societies, he is past Governor for Indiana of the American College of Physicians.

He has served in leadership capacities in such other organizations as the Council of Deans of the Association of American Medical Colleges, the American Cancer Society, the United Cerebral Palsy of Indiana, the Marion County Medical Society, the Governor's Commission on Medical Education, and as Chairman of the Medical Education Board of Indiana.

He and Mrs. Irwin are the parents of a son and two daughters.

DR. MOORE HIGHLY QUALIFIED

Dr. Moore was chancellor of the Massachusetts Board of Higher Education for two years before coming to Indiana University. From 1968 to 1970 he was vice-president for graduate studies and research at the State University of New York at Binghamton.

For six years prior to that he was dean of the graduate school and co-ordinator of research at the University of Massachusetts at Amherst. Earlier he was chairman of philosophy at the University of Idaho, and taught at the University of Iowa.

He holds the B.A. degree in English (1938) from Western Michigan University, and three degrees, M.A. in educational administration (1946), M.A. in philosophy (1947), and Ph.D. in philosophy (1950) from the University of Michigan.

He is the author of three books and co-author of a fourth, as well as a frequent contributor to professional journals.

He has served as a member of the executive committee, Division of Graduate Work, Association of State Universities and Land Grant Colleges.

With an enrollment of more than 17,000, the IUPUI campus today includes the following major divisions: School of Medicine, Dentistry, Nursing, Liberal Arts, Engineering and Technology, Science, Social Service, and Physical Education, Indianapolis Law School, Herron School of Art, the University Hospitals, the Divisions of Business Education and Education, the Krannert Institute of Cardiology, and the Regenstrief Institute, operated in co-operation with the Marion County General Hospital.
