The ADA Health Policy Institute produces a rich collection of economic reports for the practicing community. In November 2014, they released this report which found:

- * Cost and low perceived need are the top reasons why adults indicate they do not intend to visit a dentist in the next 12 months. This is true among adults of all ages and income levels.
- *Other important reasons for not visiting a dentist include lack of time, difficulty traveling to a dentist, anxiety, and difficulty finding a dentist that accepts Medicaid.
- *The prominence of "no need" as a reason for forgoing dental care may be driven by improvements in oral health, changes in oral health literacy, or a significant shift in the value proposition of dental care. Further research is needed in this area

• Compliance 2015: IUSD and the Health Sciences Plan

Given the changing health care environment, IUSD is ramping up attention to Compliance in 2015. In mid-December 2014, the Health Science Schools at IUPUI all endorsed a new comprehensive plan to strengthen the oversight for each academic program. The health sciences are a highly regulated industry with increased oversight and enforcement including access to and use of health information, patient care, billing practices and research. The recent Indiana Walgreen's court decision unfavorable to employers regarding actions of their employees should have all dental offices reviewing their training and policies regarding compliance. The Plan applies to all Health Science community members, which include faculty, staff, and trainees (collectively "employees"), as well as students, of the health science schools. The Health Science schools (Schools) are currently comprised of the Schools of Dentistry, Health and Rehabilitation Sciences, Medicine, Nursing, Optometry, Public Health (Bloomington and Indianapolis) and Social Work.

Another change to enhance compliance is the enrollment of all faculty as Medicaid providers while serving as supervising dentists at IUSD. Forms will be sent out soon to all full and part time faculty to make enrollment an easy process. This status has no financial impact on a dentist who also has an extramural private practice as all IUSD authorized Medicaid procedures are billed under the IUSD Medicaid provider account number. As I mentioned on Tuesday at the Faculty Orientation, in the words of Bob Dylan—"the times are a changing" and we need to bring IUSD into better compliance.

Dental Building Project Update

Last month, I shared with you the news that we spent much of calendar year 2014 consulting with the Smith Group JJR, the architectural planning group for IU working on: the Inter-Professional Education (IPE) project, master space planning needs for IU dentistry and options for IUSD on the former Wishard campus. For various reasons, it is not feasible to pursue the Wishard property option. Therefore, we now return to the original plan of expanding our existing structure for new clinical facilities and then renovating the remaining dental buildings. For 2015, we are taking on a new renovation project on the fourth floor of

IUSD to renovate the lobby area, restrooms, dental hygiene clinic, and graduate operative clinics at the south end of the building. This will bring the remaining patient lobby area into a contemporary standard. In addition, this provides the opportunity to showcase what the new clinical facilities can look like when the new addition is constructed. The timeline calls for planning and design during spring 2015 with construction/renovation during summer 2015. We plan a grand opening September 2015 (hopefully). The entire project is being funded by the dental school from capital funds. No cash or pledges contributed for the new clinic facility will be used for this project as they are reserved for the new clinical facilities.

As part of our ongoing transition with clinical space, we have been granted access back into the Regenstrief dental clinical area while the University considers financing and building use for the former Wishard now IU-Regenstrief building. In addition to having space for the pre-doctoral oral surgery clinic, IUSD is now operating an emergency clinic for patients of record and will be opening an Honors clinic for D4 students who are well advanced in their clinical progress. This is a temporary re-opening as long-term plans call for much of Regenstrief to be renovated into Inter-Professional Education (IPE) space which is dependent on state funding.
