Promotion and Tenure Committee report:

Robert Barrows reported on the plans for updating Promotion and Tenure Guidelines, which Dean Upton had asked the committee to undertake. It has been approximately ten years since guidelines had been updated; Barrows introduced the process and the background thereof. Two documents have been posted on the SLA website. Members for read these documents and offer feedback to Dean Upton. Dean Upton urged looking over the documents carefully over the summer as there are some significant changes; the documents will be brought to FA later in Fall 2015. Barrows thanked Andre De Tienne and especially Merle Illg for the work on this issue.

> SLA Honors Program: Eric Saak reported on the SLA Honors Program, noting the highlights of its first year running. They had a good year this, with a number of learning activities. Plans were announced for developing the program further, giving it more structure. A Steering Committee has been formed, and a detailed proposal for the restructuring will be brought to the FA in the Fall.
