# ARTICULATION AGREEMENT for CRIMINAL JUSTICE

between

Indiana University School of Public and Environmental Affairs and
Ivy Tech Community College

#### **Statement of Intent**

The purpose of this articulation agreement is to provide a mechanism whereby individuals graduating with the degree of Associate of Science (A.S.) in Criminal Justice are eligible to complete the requirements for the B.S. degree in Criminal Justice (B.S.C.J.) at Indiana University's School of Public and Environmental Affairs (SPEA). Such eligibility is subject to the conditions detailed below and in attachments to this agreement.

#### Principles Upon Which Articulation is Based

- 1. The articulation initiatives are consistent with the Commission for Higher Education's State Policy on Associate Degree Programs Offered at Public Institutions in Indiana.
- 2. Relationships between Ivy Tech and Indiana University's School of Public and Environmental Affairs faculty and administration have been and will continue to be in a spirit of cooperation that provides the basis for all articulation initiatives.
- 3. Graduates of the Ivy Tech A.S. degree program in Criminal Justice who are accepted into the IU School of Public and Environmental Affairs Criminal Justice program and who successfully meet the course work, retention and graduation requirements for a B.S. degree in Criminal Justice will be awarded the degree of Bachelor of Science in Criminal Justice from Indiana University.
- 4. All students of Ivy Tech applying for admission to IU's School of Public and Environmental Affairs program in Criminal Justice must meet the transfer and retention standards of the School of Public and Environmental Affairs.
- 5. Recognizing that changes in curricula and course content are inevitable, each institution agrees to consult with the other institution concerning all curriculum changes affecting this agreement. The purpose of this consultation is to ensure that both institutions possess the information necessary to understand how the proposed curricular changes may affect this articulation agreement.

# **Specifics of Articulated Programs**

#### 1. Associate of Science degree

- a. Ivy Tech will offer an Associate of Science (A.S.) degree in Criminal Justice according to the curriculum outline in Exhibit 1.
- b. The A.S. degree is designed as a transfer degree for students wishing to complete a baccalaureate degree at IU-SPEA following completion of the A.S. degree, and the degree consists entirely of course work transferable to IU.

# 2. Curriculum and Program Articulation

- a. Courses that are offered in the A.S. degree program are equivalent to specific courses at Indiana University. Because there are variations in the courses offered on different IU campuses, there is some variation in IU-SPEA Bachelor of Science in Criminal Justice (B.S.C.J.) degree requirements across IU campuses. A specific articulation crosswalk has been prepared that specifies the correspondence between courses offered in the Ivy Tech A.S. degree and courses required in the IU-SPEA B.S.C.J. degree program. The articulation crosswalk for the IU-SPEA B.S.C.J. degree on the Indianapolis campus can be found in Exhibit 2.
- b. The A.S. degree program contains coursework that is transferable to IU and that satisfies general education requirements for the B.S.C.J. degree. The specifics can be found in Exhibit 2.
- c. The A.S. degree program contains course work that is equivalent to courses required as part of the core requirements of the B.S.C.J. degree program in the SPEA. The specifics can be found in Exhibit 2.

# 3. Course Transfer and Grandfathering

- a. Ivy Tech students who do not complete the A.S. degree and who seek to transfer course credit that has been earned after the implementation of this agreement will have their transfer request evaluated on a course-by-course basis consistent with the prescribed policies and practices of Indiana University's School of Public and Environmental Affairs and consistent with the course equivalencies in Exhibit 2.
- b. Students that have taken course work at Ivy Tech before the implementation of this agreement, but during or after the fall semester of 2001, may be allowed to transfer those courses into the B.S. program at IU assuming those courses were previously articulated general education courses or courses that are now articulated as part of this agreement.

c. Individuals who began an A.A.S. degree in Criminal Justice after August 2001 may be given the opportunity to either transfer to the A.S. program or, if the A.A.S. has been awarded, to take additional course work to earn an A.S. degree. Evaluation of Criminal Justice courses taken outside this agreement is subject to a case-by-case and course-by-course basis. However, only the six Criminal Justice courses listed in this articulation agreement are transferable to the IU-SPEA B.S.C.J. degree program. Other Criminal Justice courses taken at Ivy Tech Community College will not count toward the IU-SPEA B.S.C.J. degree.

# 4. B.S. in Criminal Justice

Individuals who graduate from Ivy Tech Community College with the A.S. in Criminal Justice and who are accepted into the IU School of Public and Environmental Affairs Criminal Justice program will enter as junior-year students. These graduates will take a minimum of 60 additional credit hours at Indiana University and earn the BS in Criminal Justice. <sup>1</sup>

# 5. Means of Course Transfer

All students transferring course credit from Ivy Tech to IU's School of Public and Environmental Affairs, whether following completion of the A.S. degree or for individual courses, will do so via official transcripts.

# 6. Program Review

- a) The IU School of Public and Environmental Affairs reserves the right to review periodically the Ivy Tech A.S. program in Criminal Justice or any of its courses.
- b) The IU School of Public and Environmental Affairs will work with the faculty and administration of Ivy Tech to strengthen or implement changes in the A.S. program in Criminal Justice.
- c) A review of the articulation agreement will commence after the second full year of implementation and every three years hence. This review will be a joint effort by Ivy Tech and IU-SPEA.

<sup>&</sup>lt;sup>1</sup> To assure a smooth transition between the Ivy Tech A.S.C.J. and the SPEA B.S.C.J., students are strongly encouraged to meet with a SPEA advisor as soon as possible after they have begun their work toward the A.S.C.J. degree.

# EFFECTIVE DATE, AMENDMENT, AND TERMINATION

Terms of this Articulation Agreement will be effective beginning Fall Semester 2010.

Each institution will inform the other, through its chief academic officer, of any institutional plans or changes that have impact upon the points of this Articulation prior to implementing those plans or changes. Every effort will be made to assure that proposed amendments do not threaten the viability of this articulation agreement.

Written notice of intention to terminate or withdraw from this Articulation Agreement will be submitted by the Chief Executive Officer of either institution not less than one calendar year prior to the proposed date of termination/withdrawal.

This articulation will be in force when conditions of the agreement have been met.
