# NASSP to List 1979 National FFA Convention as Approved

The 1979 National Future Farmers of America Convention will be listed as approved in the Advisory List of National Contests and Activities for the coming year, according to Douglas W. Hunt, Executive Director of the National Association of Secondary School Principals, publishers of the list.

The decision followed the submission of a proposal for future Convention dates to the NASSP's National Contests and Activities Committee by the National FFA Organization.

Hunt said the Committee's reason for not including the FFA Convention in 1978 was because of the "out of school" time spent by a great number of both teachers and students who have attended the Convention. With the FFA's assurance that the program would go to an annual Thursday, Friday, Saturday schedule in 1981, the Committee chose to once again add the Convention to its Advisory List.

"It illustrates once again that the FFA is committed to working with school administrators and educators at all levels, whether it be local, state or national," Coleman Harris, National FFA Executive Secretary, said of the approval and the cooperation exhibited by the NASSP and the FFA. Harris also stated that the National FFA Organization plans to maintain and strengthen further the educational value of all the activities at the National FFA Convention.

While all entries in the NASSP's Advisory List are reviewed and subjected to change on a yearly basis, Hunt indicated that he thought the National FFA Convention would likely be included in the future, with the new revised schedule.

"We can see no reason why it would not be listed in the coming years provided the high level and quality of educational content is maintained and FFA's assurances of going to the new proposed dates are carried out," Hunt said. The 1979 edition of the NASSP's Advisory List will be mailed to every school system in the country this summer.

A special thanks to the many FFA Alumni members who contacted the Principals'Association in support of the FFA being listed on its list of educational activities.

### National FFA Advisor H. N. Hunsicker Retires

H. N. Hunsicker, Head of Agriculture Education of the Office of Education and National FFA Advisor, retired on May 18, 1979. Mr. Hunsicker was employed at the U. S. Office of Education in 1952 after serving as West Virginia State Supervisor of Agriculture Education and State FFA Advisor. He had served as Head of Vocational Agriculture since 1965. Mr. Hunsicker has been one of the strong promoters of the FFA Alumni and was instrumental in its founding. He was awarded the Outstanding Achievement Alumni Award in 1977.

#### **Rawls Named National FFA Advisor**

Byron F. Rawls, Chief of the Southern Branch, Division of State Vocational Program Operations in the U. S. Office of Education and a member of the National FFA Board of Directors since 1967, has been named to assume the head position of Agriculture Education. Mr. Rawls, prior to his employment with the U. S. Office of Education, served as FFA Executive Secretary in Alabama.

#### **Did You Know?**

As the FFA Alumni becomes more aware of the needs of a strong voice for vocational agriculture-FFA, we feel the need to present important facts to you.

1. FFA membership for 1978-79 was 494,394 compared to 507,108 in 1977-78. The secondary (high school) vocational agriculture enrollment for 1978-79 was 715,272 compared to 720,509 in 1977-78. Note that only 69 percent of the students are receiving the educational values of the leadership laboratory offered by the FFA.

2. Vocational agriculture programs for Young Farmers and other adults are conducted in approximately fifty percent of the states. There has been a gradual decline in adult education in agriculture in recent years.

3. Currently your U. S. Congress members are young in terms of years in office. The Senate is composed of fifty-six percent of its members with less than six years in office. The House of Representatives' Committee on Education and Labor is composed of thirty-three percent of its members with less than six years in office. This emphasizes the need for constant input in support of vocational agriculture education.

4. The next Federal legislation on vocational education will start at the subcommittee level in 1980. Your interest in vocational agriculture-FFA should be expressed to your Congressional representative at every opportunity.

#### The FFA and You

The FFA and You, an excellent reference book on the FFA, includes a chapter on the FFA Alumni in its recently published third edition. The Alumni chapter highlights the importance of the Alumni to the FFA, the history of the Alumni Association, eligibility and benefits to Alumni members, information on affiliate chartering and developing a program of activities, and much more. 
