TIBS Treasurer's Report November 14, 2007

All of the news this year is good. Membership is up, we have recovered from the negative balance from last year, and conference expenses are expected to be much lower this year. Details for all categories are provided below.

Membership

As of September 30th, TIBS had 108 members. We have decreased 12 members from our 2006 level of 120 members. For 2008, 25 members have submitted their dues.

Revenue

Our members pay \$10, which means that for 2007 we had \$1,080 in revenue. Please note that these data reflect balances on September 30th. We may still add a few more members in 2007.

Expenses

ARNOVA charges 10% for administrative fees (\$120 in 2006; \$108 in 2007).

In 2006 our conference related expenses were much, much lower than in 2005. In 2005 we were charged for the room, microphones, and refreshments totaling \$1,122.19. However, in 2006 TIBs was only charged \$279.19 for conference refreshments. This year we will be charged \$15 for each person attending the business meeting. We anticipate expenses of approximately \$225.

Balance

Currently we have \$2,298.57 balance in our account. After conference expenses, we should have approximately \$2,073.
