LEGISLATIVE REPORTS V

LEGISLATIVE ACTION -- NEW BILLS

House:

- HB 1277 - (Richardson, Campbell) -- Would prohibit denial, revocation, or suspension of occupational or professional licenses because applicant or holder has been convicted of misdemeanor or felony. Assigned to Public Policy committee.
- HB 1280 - (Lapar) -- Would provide for collective bargaining by public employees; would define unfair labor practices; would establish an Indiana Public Employment Relations Board. Assigned to Public Policy committee.

New Bills -- Senate:

- SB 210 - (Bosma, Ullrich) -- Would provide for licensure of speech pathologists and audiologists and establish a state board of examiners for speech pathology and audiology. Assigned to Public Health committee.
- SB 222 - (Shawley) -- Would provide that certain state employees would periodically receive pay in lieu of accumulated sick days. Assigned to Benevolent & Penal Institutions committee.

I.U. SYSTEM CLOSED FOR PRESIDENT JOHNSON'S FUNERAL

The Indiana University system was closed for business Thursday for the funeral of former President Lyndon B. Johnson.

All employees who were released on Thursday received a paid day of absence; employees who remained on duty Thursday to perform essential services will receive a compensating paid day of absence.

Chancellor Maynard K. Hine has appointed Elton T. Ridley, associate professor of hospital administration, as a special consultant to his office for long-range planning for the Medical Center. SCHOOL OF MEDICINE APPOINTMENTS

Dr. Glenn W. Irwin Jr., dean of the school of medicine, announces that Duane Gaither, associate director of fiscal affairs in the School of Medicine, will assume the duties and responsibilities of the Office of Sponsored Programs for the School of Medicine. Dr. Jack W. Lukemeyer, former assistant dean for sponsored programs, has recently been appointed associate dean for allied health sciences in the School of Medicine.

Gaither joined the administrative staff of the School of Medicine in February 1967 as an administrative assistant in the Department of Medicine, managing several large research grants. He joined the staff of the Dean's Office in November 1969 and has been involved in the management and administration of the fiscal affairs of the School of Medicine. In his new assignment, Gaither will be handling all the administration of the research grant programs in the School of Medicine, and will assist the faculty and the departments in the administration of their accounting, reporting, and processing of grant applications.

Dr. Lukemeyer, who has been acting director for the Division of Allied Health Sciences since last May, was confirmed as associate dean for the division by the I.U. board of trustees at the December meeting. Dr. Lukemeyer holds the academic rank of associate professor of pediatrics in the School of Medicine and is the author of numerous scientific publications.

MA BELL AND YOU

Indiana Bell has a pending rate increase before the Indiana Public Service Commission. If the rate increase is approved, it should take effect this July or August.

For budget planning, each CENTREX telephone number should be increased \$2 each month. The monthly charge for extensions probably will not be changed.

Service connection charges probably will increase, too -- to install a six-button phone, from \$25 to \$28; to move a six-button phone, from \$20 to \$23. These figures are tentative estimates.

SUMMARY: I.U. BOARD OF TRUSTEES JAN. 20 MEETING

--Set the site for the next two meetings as Kokomo, February 24, and Indianapolis, March 24.

--Named J. Gus Liebenow as Vice-President and Dean for Academic Affairs, dropping the word "Acting" from his title of the past year.

--Confirmed the appointment of Lee Corso as head football coach on a five-year contract.

--Approved the use of Assembly Hall as the site for the 1973 State High School Basketball Tournament next March 17.

--Named Ben Dutton of Indianapolis, former Alumni Association president, and Judge Jesse Eschbach, of Warsaw, former trustee, to the Board of Visitors of the Bloomington Law School.

--Heard Fred Logan of Bloomington Student Government propose that the University adopt a three-point policy concerning budget request:

1. Make public whether it will lobby for its original request or that of the Higher Education Commission;
2. If opting for the HEC recommendation, clarifying that this does not merely assume an increase in fees;
3. Immediately place students on committees which consider budgetary matters.

--Approved changes in the Student Conduct Code:

1. Require a disciplined student to notify the Dean of Students only when an appeal is requested and not when the determination and penalty are accepted;
2. Eliminate Chief Justice of Student Supreme Court as candidate for student representative on the Review Board (In practice none has held such representation in past three years.)
3. Amend the language on section concerning identification cards to read:". .A student shall show his identification card to an I.U. official or employee upon request. Prior to showing the card, the student, if he asks, shall be entitled to be told the reason for the request and the employee's or official's name and position, and be shown the employee's or official's University identification card. If student, employee or official do not then have an identification card (on their person) other means of identification may be employed."
4. Added the underlined word to the statement on Human Rights: "With respect to the use of its services and facilities, the policy of I.U. is to offer these services and facilities to students and the general public without regard to race, religion, sex, or national origin."

--Subject to the approval of the State's Attorney General, agreed to enter into a contract with InPIRG (Bloomington) on a one-year experimental basis to permit voluntary check-off for contribution by students to InPIRG at fee-paying time. The contract is to be considered at the Kokomo meeting. Limitations include reimbursement by InPIRG for collection costs, agreement that InPIRG will stay out of issues rising from decisions of faculty or administration, agreement that InPIRG will not sue the university, and agreement by InPIRG that it will spend all funds collected locally and will not combine its funds with those collected from any other school.

--Increased the rates for the six-weeks Children's Camp at Camp Brosius, Wis., from \$350 to \$400.

--Postponed until the next meeting a discussion of proposed changes in Residence Hall regulations (Bloomington).
